**A BILL FOR AN ACT**

101      **CONCERNING TRANSFERS OF MONEY FROM THE GENERAL FUND TO**  
102              **IMPLEMENT THE STATE WATER PLAN, AND, IN CONNECTION**  
103              **THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

The bill allocates \$20 million from the general fund to the Colorado water conservation board (CWCB) to be spent to implement the state water plan as follows:

- \$15 million, which is transferred to the water plan implementation cash fund for expenditures and grants

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly  
3 hereby:

4 (a) Finds that:

5 (I) Investment in Colorado's water resources is critical to our  
6 economy and quality of life;

7 (II) These investments are needed now to ensure Colorado's water  
8 systems can be resilient to impacts of fire, drought, climate change, and  
9 population growth;

10 (b) Determines that:

11 (I) Colorado's water plan provides a vision for ensuring water  
12 supply and demand are met now and into the future while maintaining  
13 Colorado values of vibrant communities, productive agriculture, and  
14 world-class natural resources;

15 (II) The implementation of Colorado's water plan requires funding  
16 projects that address challenges across the state, but our investments in  
17 water infrastructure, natural and manmade, consistently lag behind our  
18 needs; and

19 (c) Declares this act's one-time stimulative infusion of money  
20 seeks to jumpstart the grant funding for diverse and multi-beneficial  
21 projects for communities, rivers, and economies in all parts of Colorado.

22 **SECTION 2.** In Colorado Revised Statutes, 37-60-123.3, **amend**  
23 (1) as follows:

1           **37-60-123.3. Water plan implementation cash fund - created**  
2   **- repeal.** (1) (a) There is hereby created in the state treasury the water  
3 plan implementation cash fund, referred to in this section as the "fund".  
4 The fund consists of sports betting revenues transferred from the sports  
5 betting fund in accordance with section 44-30-1509 and any other money  
6 that the general assembly may appropriate or transfer to the fund. The  
7 state treasurer shall credit all interest and income derived from the deposit  
8 and investment of money in the fund to the fund.

9           (b) (I) THE STATE TREASURER SHALL TRANSFER FIFTEEN MILLION  
10 DOLLARS FROM THE GENERAL FUND TO THE FUND. THE BOARD MAY USE UP  
11 TO FIVE PERCENT OF THE MONEY TRANSFERRED BY THIS SUBSECTION  
12 (1)(b)(I) TO ADMINISTER GRANTS MADE PURSUANT TO SUBSECTION (2)(a)  
13 OF THIS SECTION. BY JULY 1, 2023, THE BOARD SHALL AWARD PURSUANT  
14 TO SUBSECTION (2) OF THIS SECTION ALL OF THE MONEY TRANSFERRED BY  
15 THIS SUBSECTION (1)(b).

16           (II) THIS SUBSECTION (1)(b) IS REPEALED, EFFECTIVE SEPTEMBER  
17 1, 2025.

18           **SECTION 3.** In Colorado Revised Statutes, 39-29-109, **add**  
19 (2)(c)(V) as follows:

20           **39-29-109. Severance tax trust fund - created - administration**  
21 **- distribution of money - legislative declaration - repeal.** (2) State  
22 severance tax receipts must be credited to the severance tax trust fund as  
23 provided in section 39-29-108. All income derived from the deposit and  
24 investment of the money in the fund must be credited to the fund. At the  
25 end of any fiscal year, all unexpended and unencumbered money in the  
26 fund remains in the fund and must not be credited or transferred to the  
27 general fund or any other fund. All money in the fund is subject to

1 appropriation by the general assembly for the following purposes:

2 (c) **The water supply reserve fund.** (V) (A) THE STATE  
3 TREASURER SHALL TRANSFER FIVE MILLION DOLLARS FROM THE GENERAL  
4 FUND TO THE FUND. BY JULY 1, 2023, THE BOARD SHALL AWARD  
5 PURSUANT TO SUBSECTION (2)(c)(I) OF THIS SECTION ALL OF THE MONEY  
6 TRANSFERRED BY THIS SUBSECTION (2)(c)(V).

7 (B) THIS SUBSECTION (2)(c)(V) IS REPEALED, EFFECTIVE  
8 SEPTEMBER 1, 2025.

9 **SECTION 4. Appropriation.** (1) For the 2020-21 state fiscal  
10 year, \$15,000,000 is appropriated to the department of natural resources  
11 for use by the Colorado water conservation board. This appropriation is  
12 from the water plan implementation cash fund created in section  
13 37-60-123.3 (1), C.R.S. To implement this act, the Colorado water  
14 conservation board may use this appropriation for the purpose specified  
15 in section 37-60-123.3 (1)(b)(I), C.R.S.

16 (2) The money appropriated in subsection (1) of this section  
17 remains available for the designated purposes until it is fully expended.

18 **SECTION 5. Safety clause.** The general assembly hereby finds,  
19 determines, and declares that this act is necessary for the immediate  
20 preservation of the public peace, health, or safety.
