A BILL FOR AN ACT

101 **CONCERNING AN APPROPRIATION TO THE DEPARTMENT OF HIGHER**
102 **EDUCATION FOR THE COLORADO OPPORTUNITY SCHOLARSHIP**
103 **INITIATIVE'S DISPLACED WORKERS GRANT.**

Bill Summary

The bill appropriates money to the department of higher education for the Colorado opportunity scholarship initiative's displaced workers grant.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly
3 finds that:

4 (a) In 2020, the Colorado opportunity scholarship initiative
5 responded to needs caused by the COVID-19 pandemic by creating the
6 displaced workers grant;

7 (b) The displaced workers grant supports Coloradans displaced by
8 the COVID-19 pandemic who have completed a portion of their higher
9 education but have not earned or completed a credential, or who have the
10 need to reskill or upskill due to loss of employment; and

11 (c) Increased investment in the displaced workers grant is
12 estimated to serve at least three thousand displaced Colorado workers and
13 will provide these workers with the skills, supports, and credentials
14 necessary to secure good jobs; help sustain a resilient state economy; and
15 help institutions of higher education scale high-demand and highly
16 impacted programs.

17 (2) Therefore, the general assembly declares its commitment to
18 responding to the COVID-19 pandemic by continuing its support of the
19 Colorado opportunity scholarship initiative and furthering its purpose to
20 support students who are committed to academic achievement and
21 successful placement in the workforce.

22 **SECTION 2. Appropriation.** For the 2020-21 state fiscal year,
23 \$15,000,000 is appropriated to the department of higher education for use
24 by the Colorado opportunity scholarship initiative advisory board. This
25 appropriation is from the general fund. The Colorado opportunity
26 scholarship initiative advisory board may use this appropriation for the
27 Colorado opportunity scholarship initiative's displaced workers grant.

1 Any money appropriated in this section not expended prior to July 1,
2 2021, is further appropriated to the Colorado opportunity scholarship
3 initiative advisory board for the 2021-22 state fiscal year for the same
4 purpose.

5 **SECTION 3. Safety clause.** The general assembly hereby finds,
6 determines, and declares that this act is necessary for the immediate
7 preservation of the public peace, health, or safety.
