**A BILL FOR AN ACT**

101    **CONCERNING BACKCOUNTRY SEARCH AND RESCUE SERVICES IN**  
102        **COLORADO, AND, IN CONNECTION THEREWITH, MAKING AN**  
103        **APPROPRIATION.**

**Bill Summary**

The bill defines "backcountry search and rescue" as the utilization, training, and support of responders, with their specialized equipment, to locate, provide assistance to, and remove to safety individuals who are lost, injured, stranded, or entrapped, generally in remote areas of the state. natural resources must conduct a study and develop recommendations on the issues related to backcountry search and rescue, including coordination among the local, state, and nonprofit organizations involved in backcountry search and rescue, the adequacy of resources and benefits available to volunteers who provide backcountry search and rescue services, the funding needs for equipment and reimbursement, and the needs for volunteer training and public education. The division must also conduct outreach and training related to the physical and psychological support needs of backcountry search and rescue volunteers, which may include working with consultants, providing programs, or creating a grant program for local governments or nonprofit organizations providing backcountry search and rescue. The bill makes conforming amendments related to the definition of "backcountry search and rescue".

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly  
3 hereby finds and declares that:

4 (a) Backcountry search and rescue in Colorado originated in the  
5 1940s and has a strong heritage, saving the lives of thousands of  
6 Coloradans and visitors who engage in outdoor recreation in the state;

7 (b) Volunteer first responders, who are members of nonprofit  
8 backcountry search and rescue teams, risk their physical and  
9 psychological health when utilizing their specialized skills and local  
10 knowledge of Colorado's unique, diverse, and sometimes dangerous  
11 backcountry areas to render aid to anyone in need;

12 (c) Backcountry search and rescue is a vital service ensuring the  
13 safety of Colorado residents and visitors and is best accomplished with  
14 the cooperation and coordination of local backcountry search and rescue  
15 teams, county sheriffs, the Colorado National Guard, other local partners,  
16 and state, local, and federal government agencies;

17 (d) While limited state funding is currently generated from  
18 hunters, anglers, motorized boaters, off-highway vehicle users, and

1 snowmobilers to reimburse political subdivisions and volunteer teams for  
2 the costs incurred in conducting backcountry search and rescue  
3 operations, local governments and volunteer teams, especially those in  
4 rural areas, are experiencing more rescues and rising costs because of  
5 increasing backcountry use; and

6 (e) Maintaining strong backcountry search and rescue capabilities  
7 across the state is vital to the outdoor recreation industry, which is a  
8 major economic driver for the state and local economies.

9 **SECTION 2.** In Colorado Revised Statutes, 33-1-102, **add** (1.3)  
10 as follows:

11 **33-1-102. Definitions.** As used in this title 33, unless the context  
12 otherwise requires:

13 (1.3) "BACKCOUNTRY SEARCH AND RESCUE" MEANS THE  
14 UTILIZATION, TRAINING, AND SUPPORT OF RESPONDERS, WITH THEIR  
15 SPECIALIZED EQUIPMENT, COORDINATED BY A SHERIFF TO PROVIDE THE  
16 SERVICES DESCRIBED IN THIS SUBSECTION (1.3) DURING EMERGENCIES OR  
17 DISASTERS IN FORESTS, DESERTS, MOUNTAINS, CANYONS, CAVES, WATERS,  
18 PARKS, PLAINS, AND, AT TIMES, IN MORE POPULATED AREAS. RESPONDERS  
19 INCLUDE MEMBERS OF VOLUNTEER TEAMS THAT WORK ALONGSIDE FIRE,  
20 LAW ENFORCEMENT, EMERGENCY MEDICAL PERSONNEL, THE COLORADO  
21 NATIONAL GUARD, AND OTHER GOVERNMENT EMPLOYEES IN DISASTERS  
22 OR EMERGENCIES. "BACKCOUNTRY SEARCH AND RESCUE" IS A SUBSET OF  
23 SEARCH AND RESCUE AS DEFINED IN SECTION 24-33.5-703 (8) AND  
24 INCLUDES:

25 (a) LOCATING LOST OR INJURED INDIVIDUALS IN REMOTE AREAS;

26 (b) ACCESSING INDIVIDUALS WHO ARE INJURED, STUCK,  
27 STRANDED, OR ENTRAPPED;

- 1 (c) RECOVERING THE BODIES OF DECEASED INDIVIDUALS AT THE  
2 DIRECTION OF A CORONER;
- 3 (d) ASSESSING AND MITIGATING HAZARDOUS TERRAIN OR  
4 CONDITIONS;
- 5 (e) PROVIDING EMERGENCY ON-SCENE MEDICAL AND  
6 PSYCHOLOGICAL CARE;
- 7 (f) EVACUATING OR TRANSPORTING INJURED, STUCK, STRANDED,  
8 OR ENTRAPPED INDIVIDUALS TO A ROADWAY OR AIR AMBULANCE;
- 9 (g) PROVIDING PUBLIC OUTDOOR SAFETY EDUCATION;
- 10 (h) PROVIDING FOR THE PHYSICAL AND PSYCHOLOGICAL  
11 WELL-BEING OF FIRST RESPONDERS INVOLVED IN BACKCOUNTRY SEARCH  
12 AND RESCUE;
- 13 (i) TRAINING INDIVIDUALS AND TEAMS TO PROVIDE BACKCOUNTRY  
14 SEARCH AND RESCUE SERVICES; AND
- 15 (j) OTHER RELATED SERVICES PERFORMED AT THE WILL OF A  
16 SHERIFF.

17 **SECTION 3.** In Colorado Revised Statutes, **add** 33-10-116 as  
18 follows:

19 **33-10-116. Backcountry search and rescue - study - training**  
20 **and physical and psychological support pilot program.** (1) (a) THE  
21 DIVISION SHALL CONDUCT A STUDY AND DEVELOP RECOMMENDATIONS ON  
22 HOW TO ADDRESS THE CHALLENGES ASSOCIATED WITH BACKCOUNTRY  
23 SEARCH AND RESCUE IN THE STATE. AT A MINIMUM, THE STUDY MUST  
24 ADDRESS:

25 (I) HOW TO IMPROVE AND DEVELOP A SUSTAINABLE STRUCTURE  
26 FOR COORDINATION AMONG THE STATE OF COLORADO, COUNTY SHERIFFS  
27 AND LOCAL LAW ENFORCEMENT AGENCIES, PUBLIC OR NONPROFIT

1 ORGANIZATIONS THAT PROVIDE BACKCOUNTRY SEARCH AND RESCUE  
2 SERVICES, AND FEDERAL AGENCIES;

3 (II) THE AVAILABILITY AND ADEQUACY OF WORKERS  
4 COMPENSATION OR OTHER BENEFITS FOR INDIVIDUALS WHO ARE INJURED  
5 IN THE COURSE OF PROVIDING BACKCOUNTRY SEARCH AND RESCUE  
6 SERVICES, INCLUDING AS VOLUNTEERS;

7 (III) THE AVAILABILITY AND ADEQUACY OF RETIREMENT BENEFITS  
8 FOR INDIVIDUALS WHO PROVIDE BACKCOUNTRY SEARCH AND RESCUE  
9 SERVICES, INCLUDING AS VOLUNTEERS;

10 (IV) COMPENSATION AND REIMBURSEMENT OF EXPENSES FOR  
11 VOLUNTEERS WHO PROVIDE BACKCOUNTRY SEARCH AND RESCUE  
12 SERVICES;

13 (V) THE AVAILABILITY OF NECESSARY EQUIPMENT AND THE NEED  
14 FOR FUNDING TO OBTAIN, MAINTAIN, AND REPLACE EQUIPMENT AND  
15 OPERATE BACKCOUNTRY SEARCH AND RESCUE TEAMS;

16 (VI) THE PHYSICAL AND PSYCHOLOGICAL IMPACTS OF PROVIDING  
17 BACKCOUNTRY SEARCH AND RESCUE AND THE AVAILABILITY AND  
18 ADEQUACY OF PHYSICAL AND PSYCHOLOGICAL SUPPORT AND RESOURCES  
19 FOR INDIVIDUALS WHO PROVIDE BACKCOUNTRY SEARCH AND RESCUE  
20 SERVICES, INCLUDING AS VOLUNTEERS;

21 (VII) ISSUES RELATED TO GOVERNMENTAL IMMUNITY FOR  
22 VOLUNTEERS WHO PROVIDE BACKCOUNTRY SEARCH AND RESCUE  
23 SERVICES;

24 (VIII) TRAINING NEEDS FOR VOLUNTEERS INVOLVED IN  
25 BACKCOUNTRY SEARCH AND RESCUE; AND

26 (IX) THE NEED FOR PUBLIC OUTDOOR SAFETY EDUCATION.

27 (b) IN CONDUCTING THE STUDY REQUIRED BY THIS SUBSECTION (1),

1 THE DIVISION SHALL CONSULT WITH AFFECTED STAKEHOLDERS, INCLUDING  
2 COUNTY SHERIFFS, PUBLIC AND NONPROFIT BACKCOUNTRY SEARCH AND  
3 RESCUE ORGANIZATIONS, THE DEPARTMENT OF PUBLIC SAFETY, THE  
4 DEPARTMENT OF LOCAL AFFAIRS, THE COLORADO AVALANCHE  
5 INFORMATION CENTER, LOCAL GOVERNMENTS, AND OTHER ENTITIES  
6 AFFECTED BY OR INVOLVED WITH BACKCOUNTRY SEARCH AND RESCUE.

7 (c) THE DEPARTMENT SHALL REPORT ON THE DIVISION'S FINDINGS  
8 AS PART OF THE DEPARTMENT'S "STATE MEASUREMENT FOR  
9 ACCOUNTABLE, RESPONSIVE, AND TRANSPARENT (SMART)  
10 GOVERNMENT ACT" HEARING REQUIRED BY SECTION 2-7-203 IN JANUARY  
11 2022 TO THE RURAL AFFAIRS AND AGRICULTURE COMMITTEE OF THE  
12 HOUSE OF REPRESENTATIVES AND THE AGRICULTURE AND NATURAL  
13 RESOURCES COMMITTEE OF THE SENATE, OR THEIR SUCCESSOR  
14 COMMITTEES.

15 (2) THE DIVISION SHALL CONDUCT OUTREACH AND TRAINING  
16 ACROSS THE STATE ON PHYSICAL AND PSYCHOLOGICAL STRESS INJURIES  
17 AND IMPACTS FACED BY BACKCOUNTRY SEARCH AND RESCUE  
18 VOLUNTEERS. THE OUTREACH AND TRAINING MAY INCLUDE WORKING  
19 WITH A QUALIFIED CONSULTANT TO ASSESS THE PHYSICAL AND  
20 PSYCHOLOGICAL NEEDS OF VOLUNTEERS AND PROVIDE TRAINING ON  
21 RECOGNIZING AND ADDRESSING THOSE NEEDS, DEVELOPING A GRANT  
22 PROGRAM FOR LOCAL GOVERNMENT AGENCIES OR BACKCOUNTRY SEARCH  
23 AND RESCUE ORGANIZATIONS TO PROVIDE PHYSICAL AND PSYCHOLOGICAL  
24 SUPPORT AND TRAINING TO VOLUNTEERS, OR DEVELOPING OTHER  
25 OUTREACH, TRAINING, AND SERVICES FOR BACKCOUNTRY SEARCH AND  
26 RESCUE VOLUNTEERS ACROSS THE STATE.

27 **SECTION 4.** In Colorado Revised Statutes, **amend 33-1-112.5**

1 as follows:

2 **33-1-112.5. Backcountry search and rescue fund.** (1) There is  
3 hereby created in the state treasury a BACKCOUNTRY search and rescue  
4 fund. Such fund is established to assist any agency or political subdivision  
5 of the state of Colorado for costs incurred in BACKCOUNTRY search and  
6 rescue activities involving persons holding hunting or fishing licenses;  
7 vessel, snowmobile, or off-highway vehicle registrations; or a Colorado  
8 outdoor recreation BACKCOUNTRY search and rescue card. Reimbursable  
9 costs are limited to actual operational expenses. Reimbursable costs shall  
10 not include salaries paid to persons permanently employed by the agency  
11 or political subdivision.

12 (2) (a) A surcharge of twenty-five cents shall be assessed on each  
13 license listed in section 33-4-102 (1) and (1.4) that is sold by the division  
14 or one of its license agents pursuant to section 33-4-101. Receipts and  
15 interest from the surcharge shall be deposited in the BACKCOUNTRY  
16 search and rescue fund created in subsection (1) of this section.

17 (b) A surcharge of twenty-five cents shall be assessed on each  
18 vessel, each snowmobile, and each off-highway vehicle registration that  
19 is sold by the division or one of its agents pursuant to section 33-13-103,  
20 33-14-102, or 33-14.5-102. Receipts and interest from the surcharge shall  
21 be deposited in the BACKCOUNTRY search and rescue fund created in  
22 subsection (1) of this section. To coincide with annual registration  
23 renewal schedules, the surcharge shall be assessed on an annual basis  
24 beginning on October 1, 1992, for snowmobile registrations, January 1,  
25 1993, for vessel registrations, and April 1, 1993, for off-highway vehicle  
26 registrations.

27 (c) (I) The general assembly hereby creates the Colorado outdoor

1 recreation BACKCOUNTRY search and rescue card program. The  
2 department of local affairs shall make a Colorado outdoor recreation  
3 BACKCOUNTRY search and rescue card available to the public in  
4 accordance with this ~~paragraph (c)~~ SUBSECTION (2)(c) to backpackers,  
5 hikers, mountain and trail bikers, cross country skiers, and other persons  
6 who use the Colorado ~~back country~~ BACKCOUNTRY for recreation. The  
7 department of local affairs shall establish procedures for the licensing of  
8 vendors who sell the outdoor recreation BACKCOUNTRY search and rescue  
9 card, the printing of such cards, and the distribution of such cards to  
10 vendors for sale to the public.

11 (II) The Colorado outdoor recreation BACKCOUNTRY search and  
12 rescue card shall cost three dollars and shall be valid for one year from  
13 the date of purchase. The department shall charge vendors two dollars for  
14 each Colorado outdoor recreation BACKCOUNTRY search and rescue card,  
15 which shall be transmitted to the state treasurer, who shall credit the  
16 amount to the BACKCOUNTRY search and rescue fund created in  
17 subsection (1) of this section. The remaining one dollar shall be retained  
18 by the vendor as the vendor's fee.

19 (III) The department may issue a multi-year Colorado outdoor  
20 recreation BACKCOUNTRY search and rescue card that shall be valid for a  
21 period not to exceed five years. Such multi-year card may be offered at  
22 a reduced rate to vendors with a reduced vendor fee to reflect  
23 administrative cost savings and other considerations.

24 (IV) The general assembly finds and declares that the Colorado  
25 outdoor recreation BACKCOUNTRY search and rescue card program is a  
26 new program. The department of local affairs is therefore authorized to  
27 contract, pursuant to section 24-50-504 (2)(b), ~~C.R.S.~~, with a person,



1 corporation, or entity for any elements of the administration of the  
2 program created by this ~~paragraph (c)~~ SUBSECTION (2)(c).

3 (3) All agencies and political subdivisions of the state shall have  
4 the right to make a claim on the BACKCOUNTRY search and rescue fund  
5 for reimbursement of costs incurred in the performance of BACKCOUNTRY  
6 search and rescue activities involving those persons specified in  
7 subsection (1) of this section. Such claims shall be submitted to the  
8 department of local affairs for immediate consideration. Any  
9 reimbursement claims which have been certified by the sheriff of the  
10 county in which the BACKCOUNTRY search and rescue activity occurred  
11 shall be eligible for payment by the department of local affairs. The  
12 department of local affairs shall establish rules for the procedure through  
13 which claims shall be submitted and for payment of such claims.

14 (4) The BACKCOUNTRY search and rescue fund created in  
15 subsection (1) of this section shall be the sole source of funds for the  
16 reimbursement of costs incurred under this section in BACKCOUNTRY  
17 search and rescue activities involving those persons specified in  
18 subsection (1) of this section. The wildlife cash fund established in  
19 section 33-1-112 and the parks and outdoor recreation cash fund  
20 established in section 33-10-111 shall not be used for reimbursement of  
21 costs as provided in this section.

22 (5) The ~~moneys~~ MONEY in the BACKCOUNTRY search and rescue  
23 fund created in subsection (1) of this section shall be subject to annual  
24 appropriation by the general assembly for the direct and indirect costs of  
25 the administration of this section.

26 (6) At the close of any fiscal year, all of the ~~moneys~~ MONEY  
27 remaining in the BACKCOUNTRY search and rescue fund and appropriated

1 for BACKCOUNTRY search and rescue expenses, after all approved claims  
2 and administrative costs have been paid, shall be divided among those  
3 counties that have applied to the department of local affairs for year-end  
4 grants or reimbursements from the BACKCOUNTRY search and rescue  
5 fund. The department of local affairs shall divide such ~~moneys~~ MONEY  
6 among the counties, first making payment for uncompensated  
7 BACKCOUNTRY searches and rescues of parents, siblings, spouses,  
8 children, or grandchildren of persons holding hunting or fishing licenses,  
9 vessel, snowmobile, or off-highway vehicle registrations, or the owner of  
10 a Colorado outdoor recreation BACKCOUNTRY search and rescue card and  
11 second making payment for BACKCOUNTRY search and rescue-related  
12 training and equipment, and for any other uncompensated ~~searches~~  
13 BACKCOUNTRY SEARCH AND RESCUE INCIDENTS. The department of local  
14 affairs shall establish operating procedures for applying for year-end  
15 grants or reimbursements from the ~~moneys~~ MONEY remaining in the  
16 BACKCOUNTRY search and rescue fund.

17 ~~(7) and (8) (Deleted by amendment, L. 2001, p. 599, § 1, effective~~  
18 ~~July 1, 2001.)~~

19 **SECTION 5.** In Colorado Revised Statutes, 33-4-117, **amend** (1)  
20 and (4) as follows:

21 **33-4-117. Youth and young adult licenses - terminally ill**  
22 **hunters - special restrictions and privileges - rules.** (1) A person under  
23 eighteen years of age may obtain a youth small game hunting license,  
24 issued pursuant to section 33-4-102 (1.4)(x), upon showing a hunter  
25 education certificate as required by section 33-6-107 (8). The fee for the  
26 license, as established in section 33-4-102 (1.4)(x), includes the  
27 BACKCOUNTRY search and rescue fund surcharge imposed under section

1 33-1-112.5 (2)(a).

2 (4) Youth big game licenses, entitling the holder to hunt deer, elk,  
3 or pronghorn, may be purchased by persons who are at least twelve years  
4 of age but under eighteen years of age for the fees specified in section  
5 33-4-102 (1.4)(w). Said fees include the BACKCOUNTRY search and rescue  
6 fund surcharge imposed under section 33-1-112.5 (2)(a). Persons under  
7 sixteen years of age hunting deer, elk, or pronghorn must be accompanied  
8 by a person eighteen years of age or older as required by section 33-6-107  
9 (4).

10 **SECTION 6.** In Colorado Revised Statutes, **amend** 33-10-115 as  
11 follows:

12 **33-10-115. Use of parks and recreational areas by nonprofit**  
13 **backcountry search and rescue organizations - definitions - rules.**

14 (1) This section shall be known and may be cited as the "Colorado  
15 BACKCOUNTRY Search and Rescue State Parks Usage Act".

16 (2) As used in this section:

17 (a) "BACKCOUNTRY SEARCH AND RESCUE ACTIVITIES" MEANS  
18 OFFICIAL DRILLS, EXERCISES, LIVE INCIDENTS, OR OTHER SUCH ACTIVITIES  
19 THAT PROVIDE INSTRUCTION TO BACKCOUNTRY SEARCH AND RESCUE  
20 PERSONNEL, AND THAT ARE CONDUCTED AT ANY TIME OF THE DAY,  
21 INCLUDING, WITHOUT LIMITATION, OVERNIGHT OR OVER SEVERAL DAYS  
22 AND NIGHTS.

23 ~~(a)~~ (b) "Park, recreation area, or facility" means:

24 (I) A state park;

25 (II) A state recreation area; or

26 (III) A state-owned facility that is open to the public and related  
27 to or adjoining a state park or a state recreation area.

1           ~~(b)~~ (c) "Public or nonprofit BACKCOUNTRY search and rescue  
2 organization" means a not-for-profit entity that performs BACKCOUNTRY  
3 search and rescue, disaster relief, or national defense missions in  
4 Colorado. The term includes, without limitation, the Colorado civil air  
5 patrol, governmental search and rescue organizations, and the Colorado  
6 search and rescue ~~board~~ ASSOCIATION.

7           ~~(c) "Training activities" means official drills, exercises, live~~  
8 ~~missions, or other such activities that provide instruction to search and~~  
9 ~~rescue personnel, that are conducted at any time of the day, including,~~  
10 ~~without limitation, overnight or over several days and nights.~~

11           (3) A public or nonprofit BACKCOUNTRY search and rescue  
12 organization shall be exempt from all park fees when the organization is  
13 using a park, recreation area, or facility to conduct ~~training~~  
14 BACKCOUNTRY SEARCH AND RESCUE activities.

15           (4) The commission ~~shall~~ MAY promulgate rules as are reasonably  
16 necessary to implement this section.

17           **SECTION 7.** In Colorado Revised Statutes, 33-12-106, **amend**  
18 (3) as follows:

19           **33-12-106. Park entrance privileges - identified veterans -**  
20 **wounded warriors - backcountry search and rescue organizations**  
21 **conducting training activities - legislative declaration - rules.**

22           (3) Pursuant to section 33-10-115, a public or nonprofit BACKCOUNTRY  
23 search and rescue organization shall be allowed free entrance to any state  
24 park or recreation area on any day of the year such park or area is open,  
25 subject to availability.

26           **SECTION 8.** In Colorado Revised Statutes, 33-32-108, **amend**  
27 (2)(a) and (2)(b) introductory portion as follows:

1           **33-32-108. Enforcement.** (2) (a) Any actual expenses incurred  
2 by a governmental entity for BACKCOUNTRY search and rescue efforts  
3 stemming from any river running activity conducted for consideration by  
4 a river outfitter pursuant to ~~the provisions of this article~~ ARTICLE 32 shall  
5 be reimbursed by said river outfitter. Such expenses shall include but not  
6 be limited to hours worked, fuel, a reasonable fee for use of equipment,  
7 and equipment repair or replacement costs, if any.

8           (b) Pursuant to ~~paragraph (a) of this subsection (2)~~ SUBSECTION  
9 (2)(a) OF THIS SECTION, any expenses incurred by governmental entities  
10 stemming from BACKCOUNTRY search and rescue efforts that are  
11 reimbursed by a river outfitter shall be distributed as follows:

12           **SECTION 9. Appropriation.** (1) For the 2021-22 state fiscal  
13 year, \$216,070 is appropriated to the department of natural resources for  
14 use by the division of parks and wildlife. This appropriation is from the  
15 general fund. To implement this act, the department may use this  
16 appropriation as follows:

17           (a) \$75,625 for state park operations, which amount is based on  
18 an assumption that the department will require an additional 0.5 FTE; and

19           (b) \$140,445 for wildlife operations, which amount is based on an  
20 assumption that the department will require an additional 1.0 FTE.

21           **SECTION 10. Safety clause.** The general assembly hereby finds,  
22 determines, and declares that this act is necessary for the immediate  
23 preservation of the public peace, health, or safety.
