101 **CONCERNING THE APPOINTMENT OF KERRI L. HUNTER TO THE**
102 **POSITION OF STATE AUDITOR.**

1 WHEREAS, Section 49 of article V of the Colorado constitution
2 provides for the appointment by a majority of the members serving in
3 each house of the General Assembly of a state auditor to serve for a term
4 of five years; and

5 WHEREAS, Among the functions of the Legislative Audit
6 Committee is the examination of persons applying for the position of state
7 auditor as to qualifications and ability and, after consultation with the
8 Executive Committee, to place the name of a qualified candidate in
9 nomination before the General Assembly for the position of state auditor;

1 WHEREAS, The Legislative Audit Committee conducted a
2 national search to select a qualified candidate for the term commencing
3 July 1, 2021, and ending June 30, 2026; and

4 WHEREAS, On April 1, 2021, the Legislative Audit Committee
5 voted to submit the name of Kerri L. Hunter to the Seventy-third General
6 Assembly pursuant to section 2-3-101 (3)(a), Colorado Revised Statutes,
7 for the position of state auditor; and

8 WHEREAS, Kerri L. Hunter is a certified public accountant
9 licensed to practice in the state of Colorado as required by section 49 of
10 article V of the Colorado constitution and is widely recognized for her
11 expertise and leadership in the field of government auditing; now,
12 therefore,

13 *Be It Resolved by the House of Representatives of the Seventy-third*
14 *General Assembly of the State of Colorado, the Senate concurring herein:*

15 That Kerri L. Hunter be appointed by the General Assembly to the
16 position of state auditor for a term commencing July 1, 2021, and ending
17 June 30, 2026, and until a qualified successor is appointed.
