The bill transfers and appropriates a total of \$25.0 million to five programs in the Departments of Natural Resources and Local Affairs. It increases state expenditures on a one-time basis.

Appropriation Summary: The bill includes appropriations of \$25.0 million.

Fiscal Note Status: The fiscal note reflects the enacted bill.

Summary of Legislation

The bill transfers a total of \$25.0 million from the General Fund to five programs in the Departments of Natural Resources (DNR) and Local Affairs (DOLA). These funds are appropriated for FY 2020-21 and are available to be spent through FY 2023-24, except for the Colorado Avalanche Information Center funds, which are available through FY 2022-23. These transfers and appropriations are shown on Table 2.

State Transfers

A total of \$25.0 million is transferred from the General Fund: \$22.75 million to four cash funds in DNR and \$2.25 million to one cash fund in the DOLA, as shown in Table 2. The transfers take place within three days of the bill's effective date, which is assumed to fall in the current FY 2020-21.

State Expenditures

State expenditures will increase by a total of \$25.0 million and 17.0 FTE between FY 2020-21 and FY 2023-24 for the purposes listed in Table 2. Of this total, \$22.75 million is in the DNR and \$2.25 million is in DOLA.

Effective Date

The bill was signed into law by the Governor and took effect on June 21, 2021.

State Appropriations

The bill includes the following appropriations totaling \$22,750,000 to the Department of Natural Resources for FY 2020-21, and an allocation of 17.0 FTE:

- \$750,000 from the Colorado Avalanche Information Center Fund, and 3.0 FTE;
- \$3,500,000 from the Wildlife Cash Fund;
- \$1,000,000 from the Outdoor Equity Fund; and
- \$17,500,000 from the Parks and Outdoor Recreation Cash Fund, and 14.0 FTE; of this total, \$43,000 is reappropriated to the Department of Personnel.

In addition, the bill include an appropriation of \$2,250,000 from Search and Rescue Fund to the Department of Local Affairs for FY 2020-21, which may also be spent through FY 2023-24.
