A BILL FOR AN ACT

101 **CONCERNING PERMITTING COMMUNITY COLLEGES TO OFFER A**
102 **BACHELOR OF SCIENCE DEGREE IN NURSING TO CERTAIN**
103 **STUDENTS.**

Bill Summary

Under existing law, community colleges may offer a bachelor of science degree in nursing as a completion degree to students who have or are pursuing an associate degree in nursing. The bill permits community colleges to offer a bachelor of science degree in nursing to students who have or are pursuing a certificate in nursing.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 23-60-211, **amend**
3 (5) as follows:

4 **23-60-211. Degrees.** (5) Subject to the requirements of sections
5 23-1-113.7 and 23-1-107, a community college that is part of the state
6 system of community and technical colleges established and governed by
7 this part 2 may, with board approval, offer a bachelor of science degree
8 in nursing as a completion degree to students who have or are pursuing
9 an associate degree in nursing OR A PRACTICAL NURSING CERTIFICATE. In
10 considering whether to approve a request by a community college to offer
11 a bachelor of science in nursing as a completion degree, the board shall
12 consider student and workforce demand, cost effectiveness for the
13 students, and accreditation and licensing requirements. The board shall
14 provide such information to the Colorado commission on higher
15 education and solicit the commission's input in a joint meeting of the
16 board and the commission. A community college that is seeking board
17 approval shall provide the board with data regarding its current
18 partnerships with existing bachelor of science nursing degree programs
19 and its plans to continue such partnerships. At least ninety days prior to
20 requesting board approval to offer a bachelor of science degree in nursing
21 as a completion degree, the community college seeking such board
22 approval shall provide notice to the Colorado commission on higher
23 education and all state public and nonpublic institutions of higher
24 education.

25 **SECTION 2.** In Colorado Revised Statutes, 23-1-133, **amend**
26 (2)(a) introductory portion as follows:

1 **23-1-133. Commission directive - bachelor of science degree**
2 **in nursing program - Aims community college - approval.** (2) (a) In
3 determining whether to approve a bachelor of science degree in nursing
4 program as a completion degree to students who have or are pursuing an
5 associate degree in nursing OR A PRACTICAL NURSING CERTIFICATE for
6 Aims community college pursuant to section 23-71-102 (1)(b)(II)(B), the
7 commission shall consider the following criteria:

8 **SECTION 3.** In Colorado Revised Statutes, 23-71-102, **amend**
9 (1)(b)(II)(B) as follows:

10 **23-71-102. Definitions.** As used in this article 71, unless the
11 context otherwise requires:

12 (1) (b) Notwithstanding the provisions of subsection (1)(a) of this
13 section:

14 (II) Aims community college, in addition to its mission as a local
15 district college, may also offer, as its board of trustees determines
16 appropriate to address the needs of the communities within its service
17 area:

18 (B) Bachelor of science degree in nursing programs, as a
19 completion degree to students who have or are pursuing an associate
20 degree in nursing OR A PRACTICAL NURSING CERTIFICATE, that are
21 approved by the Colorado commission on higher education pursuant to
22 section 23-1-133 (2).

23 **SECTION 4.** **Act subject to petition - effective date.** This act
24 takes effect at 12:01 a.m. on the day following the expiration of the
25 ninety-day period after final adjournment of the general assembly; except
26 that, if a referendum petition is filed pursuant to section 1 (3) of article V
27 of the state constitution against this act or an item, section, or part of this

1 act within such period, then the act, item, section, or part will not take
2 effect unless approved by the people at the general election to be held in
3 November 2022 and, in such case, will take effect on the date of the
4 official declaration of the vote thereon by the governor.
