expanding existing, inclusive higher education programs for students with intellectual and developmental disabilities.

The bill requires the department to contract with an organization that has demonstrated success in assisting students with intellectual and developmental disabilities attend institutions of higher education to administer the grant program, perform annual evaluations of the grant recipients, and produce an annual report that is submitted to the education committees of the house of representatives and the senate.

1 *Be it enacted by the General Assembly of the State of Colorado:*

7 **23-79-101. Short title.** THE SHORT TITLE OF THIS ARTICLE 79 IS
8 THE "INCLUSIVE HIGHER EDUCATION ACT".

9 **23-79-102. Legislative declaration.** (1) THE GENERAL ASSEMBLY
10 FINDS THAT:

11 (a) AS OF THE 2020-21 SCHOOL YEAR, THE DEPARTMENT OF
12 EDUCATION REPORTED THAT AN ESTIMATED SIX THOUSAND NINE HUNDRED
13 TWO STUDENTS WITH INTELLECTUAL DISABILITIES RESIDE IN COLORADO;

14 (b) HISTORICALLY, SOCIETY'S LOW EXPECTATIONS AND LIMITED
15 OPPORTUNITIES HAVE PREVENTED PEOPLE WITH INTELLECTUAL
16 DISABILITIES FROM THE BENEFITS ASSOCIATED WITH HIGHER EDUCATION.
17 AS A RESULT, MANY PEOPLE WITH INTELLECTUAL DISABILITIES LIVE IN
18 POVERTY WITH FEW PROSPECTS OTHER THAN EXCEPTIONALLY
19 LOW-PAYING JOBS OR SITTING IDLY AT HOME.

20 (c) ALTHOUGH STUDENTS WITH INTELLECTUAL DISABILITIES HAVE
21 HISTORICALLY BEEN DENIED HIGHER EDUCATION OPPORTUNITIES, WHEN

1 OPPORTUNITIES ARISE, STUDENTS COMPLETING HIGHER EDUCATION
2 PROGRAMS REAP THE BENEFITS OF HIGHER EDUCATION, INCLUDING HIGH
3 EMPLOYMENT RATES, BETTER WAGES, INCREASED SOCIALIZATION,
4 COMMUNITY BELONGING, AND GREATER INDEPENDENCE;

5 (d) IN 2014, UNDER THE LEADERSHIP OF IN! PATHWAYS TO
6 INCLUSIVE HIGHER EDUCATION, EDUCATORS, ADVOCATES FOR PERSONS
7 WITH INTELLECTUAL DISABILITIES, STUDENTS, AND FAMILIES BEGAN
8 WORKING TO CREATE INCLUSIVE OPPORTUNITIES FOR STUDENTS WITH
9 INTELLECTUAL DISABILITIES, AS COLORADO WAS ONE OF ONLY FOUR
10 STATES THAT DID NOT HAVE AN INCLUSIVE HIGHER EDUCATION PATHWAY
11 FOR STUDENTS WITH INTELLECTUAL DISABILITIES;

12 (e) IN 2016, THE GENERAL ASSEMBLY ENACTED A FIVE-YEAR
13 INCLUSIVE HIGHER EDUCATION PILOT PROGRAM AT THE UNIVERSITY OF
14 NORTHERN COLORADO, THE UNIVERSITY OF COLORADO AT COLORADO
15 SPRINGS, AND ARAPAHOE COMMUNITY COLLEGE;

16 (f) AS OF 2022, APPROXIMATELY SEVENTY STUDENTS WITH
17 INTELLECTUAL DISABILITIES ARE ENROLLED IN A HIGHER EDUCATION
18 INSTITUTION, PARTICIPATING IN TRADITIONAL CLASSES AND COURSE
19 WORK, LIVING INCLUSIVELY ON CAMPUS, AND PREPARING FOR THEIR
20 CAREERS;

21 (g) INCLUSIVE HIGHER EDUCATION PATHWAYS ARE DESIGNED TO
22 FOCUS ON ACADEMIC GROWTH, SOCIAL DEVELOPMENT, INDEPENDENCE,
23 AND CAREER ADVANCEMENT;

24 (h) HIGHER EDUCATION OPPORTUNITIES FOR STUDENTS WITH
25 INTELLECTUAL DISABILITIES:

26 (I) CREATE CAREER PATHWAYS FOR STUDENTS WITH
27 INTELLECTUAL DISABILITIES;

1 (II) ENSURE STUDENTS WITH INTELLECTUAL DISABILITIES ENTER
2 THE WORKFORCE WITH IN-DEMAND SKILLS;

3 (III) INCREASE INCLUSION, SOCIAL INTERACTIONS, AND
4 MEANINGFUL COMMUNITY CONTRIBUTIONS FOR STUDENTS WITH
5 INTELLECTUAL DISABILITIES;

6 (IV) REDUCE RELIANCE ON FAMILY AND COMMUNITY RESOURCES
7 BY STUDENTS WITH INTELLECTUAL DISABILITIES; AND

8 (V) PROVIDE EMPLOYERS WITH ACCESS TO A HISTORICALLY
9 UNDERUTILIZED WORKFORCE;

10 (i) SINCE 2016, UNDER THE LEADERSHIP OF IN! PATHWAYS TO
11 INCLUSIVE HIGHER EDUCATION AND THE COLORADO INCLUSION
12 CONSORTIUM, MANY ADVANCEMENTS HAVE BEEN MADE IN COLORADO FOR
13 INCLUSIVE HIGHER EDUCATION FOR STUDENTS WITH INTELLECTUAL
14 DISABILITIES, INCLUDING THE ABILITY TO EARN CREDENTIALS AT
15 GRADUATION, ACCESS TO FEDERAL FINANCIAL AID, AND PARTNERSHIPS TO
16 SUPPORT VOCATIONAL GOALS; AND

17 (j) THE SUCCESS OF THE PILOT PROGRAM HAS CREATED
18 SIGNIFICANT DEMAND FOR MORE OPPORTUNITIES THROUGHOUT
19 COLORADO.

20 (2) THEREFORE, THE GENERAL ASSEMBLY DECLARES IT IS
21 BENEFICIAL TO CREATE HIGHER EDUCATION OPPORTUNITIES THAT SUPPORT
22 STUDENTS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES AND
23 TO DEVELOP INCLUSIVE HIGHER EDUCATION PROGRAMS IN COLORADO.

24 **23-79-103. Definitions.** AS USED IN THIS ARTICLE 79, UNLESS THE
25 CONTEXT OTHERWISE REQUIRES:

26 (1) "ADMINISTERING ENTITY" MEANS THE ENTITY SELECTED BY
27 THE DEPARTMENT TO ADMINISTER THE INCLUSIVE HIGHER EDUCATION

1 GRANT PROGRAM.

2 (2) "CASH FUND" MEANS THE INCLUSIVE HIGHER EDUCATION
3 OPPORTUNITIES CASH FUND CREATED IN SECTION 23-79-108.

4 (3) "COMMISSION" MEANS THE COLORADO COMMISSION ON
5 HIGHER EDUCATION ESTABLISHED IN SECTION 23-1-102.

6 (4) "DEPARTMENT" MEANS THE DEPARTMENT OF HIGHER
7 EDUCATION CREATED AND EXISTING PURSUANT TO SECTION 24-1-114.

8 (5) "GRANT PROGRAM" MEANS THE INCLUSIVE HIGHER EDUCATION
9 GRANT PROGRAM CREATED IN SECTION 23-79-104.

10 (6) "INCLUSIVE HIGHER EDUCATION" MEANS ACCESS TO HIGHER
11 EDUCATION, AS PROVIDED BY A STATE INSTITUTION OF HIGHER
12 EDUCATION, BY STUDENTS WITH INTELLECTUAL AND DEVELOPMENTAL
13 DISABILITIES THAT:

14 (a) ENABLES THE STUDENT TO HAVE ALL OF THE RIGHTS,
15 RESPONSIBILITIES, PRIVILEGES, BENEFITS, AND OUTCOMES THAT RESULT
16 FROM A HIGHER EDUCATION EXPERIENCE TO THE GREATEST EXTENT
17 POSSIBLE, INCLUDING ACADEMIC SUCCESS, CAREER DEVELOPMENT,
18 CAMPUS ENGAGEMENT, SELF-DETERMINATION, PARTICIPATION IN PAID
19 WORK EXPERIENCES, ON-CAMPUS OR OFF-CAMPUS LIVING, INCLUSIVE
20 SOCIAL ACTIVITIES, AND ACCESS TO AND INSTRUCTION IN TECHNOLOGY;
21 AND

22 (b) UPON SUCCESSFUL COMPLETION OF AN INCLUSIVE HIGHER
23 EDUCATION PROGRAM, RESULTS IN THE STUDENT RECEIVING A
24 MEANINGFUL CREDENTIAL FROM THE STATE INSTITUTION OF HIGHER
25 EDUCATION.

26 (7) "STATE INSTITUTION OF HIGHER EDUCATION" MEANS A STATE
27 INSTITUTION OF HIGHER EDUCATION AS DEFINED IN SECTION 23-18-102

1 (10).

2 (8) "STUDENT" MEANS A PERSON WITH AN INTELLECTUAL OR
3 DEVELOPMENTAL DISABILITY WHO IS ENROLLED IN AN INCLUSIVE HIGHER
4 EDUCATION PROGRAM IN A STATE INSTITUTION OF HIGHER EDUCATION.

5 **23-79-104. Inclusive higher education grant program - created**
6 **- duties - policies.** (1) THERE IS CREATED IN THE DEPARTMENT THE

7 INCLUSIVE HIGHER EDUCATION GRANT PROGRAM TO PROVIDE GRANTS TO
8 STATE INSTITUTIONS OF HIGHER EDUCATION FOR THE PURPOSE OF
9 ESTABLISHING, OR EXPANDING EXISTING, INCLUSIVE HIGHER EDUCATION
10 PROGRAMS FOR STUDENTS WITH INTELLECTUAL AND DEVELOPMENTAL
11 DISABILITIES.

12 (2) A STATE INSTITUTION OF HIGHER EDUCATION THAT RECEIVES
13 A GRANT THROUGH THE GRANT PROGRAM SHALL USE THE MONEY FOR THE
14 PURPOSE OF ESTABLISHING AN, OR EXPANDING AN EXISTING, INCLUSIVE
15 HIGHER EDUCATION PROGRAM. THE GRANT RECIPIENT MAY USE THE
16 GRANT AWARD TO:

17 (a) PERFORM AN INSTITUTIONAL ASSESSMENT TO DETERMINE
18 TRAINING, TECHNICAL ASSISTANCE, AND THE CAPACITY NEEDED TO
19 PROVIDE INCLUSIVE HIGHER EDUCATION OPPORTUNITIES FOR STUDENTS
20 WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES;

21 (b) IDENTIFY INSTITUTIONAL POLICIES AND PRACTICES THAT
22 FOSTER OR IMPEDE INCLUSIVE HIGHER EDUCATION OPPORTUNITIES;

23 (c) OFFER PROGRAMS AND SUPPORTS FOR THE STUDENTS THAT
24 ALLOW EACH STUDENT TO TAKE FOR CREDIT OR TO AUDIT A MINIMUM OF
25 TWO ON-CAMPUS UNDERGRADUATE COURSES EACH SEMESTER IN A
26 STUDENT'S CHOSEN AREA OF STUDY, AND TO TAKE A COURSE EACH
27 SEMESTER THAT IS DESIGNED TO MEET THE NEEDS OF EACH STUDENT AND

1 NECESSARY TO RECEIVE THE AWARD OF A CREDENTIAL IN THE STUDENT'S
2 CHOSEN AREA OF STUDY;

3 (d) INTEGRATE THE STUDENTS ACADEMICALLY AND SOCIALLY INTO
4 THE NORMATIVE OFFERINGS OF THE STATE INSTITUTION OF HIGHER
5 EDUCATION;

6 (e) PROVIDE PEER MENTORING SERVICES FOR THE STUDENTS;

7 (f) COORDINATE PROGRAMS AND SUPPORTS WITH AVAILABLE
8 VOCATIONAL REHABILITATION THROUGH THE DEPARTMENT OF LABOR AND
9 EMPLOYMENT;

10 (g) PROVIDE PROGRAMS AND SUPPORTS THAT PREPARE THE
11 STUDENTS FOR GAINFUL COMPETITIVE EMPLOYMENT;

12 (h) PROVIDE PROGRAMS AND SUPPORTS FOR THE STUDENTS TO
13 DEVELOP INDEPENDENT LIVING SKILLS, INCLUDING SELF-CARE,
14 SOCIALIZATION, CAREER READINESS, HEALTHY LIFESTYLE CHOICES, AND
15 FINANCIAL LITERACY;

16 (i) PROVIDE BENEFITS COUNSELING TO THE STUDENTS;

17 (j) DEVELOP ADMISSIONS STANDARDS THAT DO NOT REQUIRE
18 STUDENTS APPLYING TO PARTICIPATE IN AN INCLUSIVE HIGHER EDUCATION
19 PROGRAM TO TAKE A NATIONAL ASSESSMENT TEST AS AN ADMISSION
20 REQUIREMENT; AND

21 (k) PERFORM OUTREACH TO HIGH SCHOOLS TO ENSURE AWARENESS
22 OF AVAILABLE INCLUSIVE HIGHER EDUCATION OPPORTUNITIES.

23 (3) NO LATER THAN SEPTEMBER 30, 2022, THE DEPARTMENT
24 SHALL ISSUE A REQUEST FOR PROPOSALS FOR AN ORGANIZATION TO
25 ADMINISTER THE GRANT PROGRAM. THE DEPARTMENT SHALL SELECT AND
26 CONTRACT WITH AN ORGANIZATION THAT HAS DEMONSTRATED SUCCESS
27 IN ASSISTING STUDENTS WITH INTELLECTUAL AND DEVELOPMENTAL

1 DISABILITIES ATTEND STATE INSTITUTIONS OF HIGHER EDUCATION. THE
2 DEPARTMENT SHALL SELECT THE ADMINISTERING ENTITY AND ENTER INTO
3 A CONTRACT WITH THE ADMINISTERING ENTITY NO LATER THAN
4 DECEMBER 30, 2022, WHICH CONTRACT IS SUBJECT TO ANNUAL REVIEW
5 AND RENEWAL.

6 (4) THE DEPARTMENT AND ADMINISTERING ENTITY SHALL
7 IMPLEMENT THE GRANT PROGRAM IN ACCORDANCE WITH THIS ARTICLE 79.
8 GRANTS MUST BE AWARDED AS PROVIDED IN THIS ARTICLE 79 AND PAID
9 OUT OF THE CASH FUND.

10 (5) UPON RECEIVING NOTICE FROM THE ADMINISTERING ENTITY
11 THAT A STATE INSTITUTION OF HIGHER EDUCATION IS SELECTED TO
12 RECEIVE A GRANT, THE DEPARTMENT SHALL, AS SOON AS PRACTICABLE,
13 TRANSFER TO THE ADMINISTERING ENTITY THE AMOUNT OF THE GRANT
14 AWARD FROM THE CASH FUND.

15 (6) THE COMMISSION SHALL ADOPT POLICIES AS REQUIRED BY THIS
16 ARTICLE 79 OR AS MAY BE NECESSARY TO IMPLEMENT THE GRANT
17 PROGRAM. AT A MINIMUM, THE POLICIES MUST SPECIFY THE FORM OF THE
18 GRANT PROGRAM APPLICATION, THE TIME FRAMES FOR APPLYING FOR
19 GRANTS, AND THE TIME FRAMES FOR DISTRIBUTING GRANT MONEY.

20 **23-79-105. Administering entity - duties - funding.** (1) THE
21 ADMINISTERING ENTITY SHALL:

22 (a) ADMINISTER THE GRANT PROGRAM IN ACCORDANCE WITH THIS
23 ARTICLE 79, INCLUDING ESTABLISHING AND IMPLEMENTING THE PROCESS
24 BY WHICH A STATE INSTITUTION OF HIGHER EDUCATION MAY APPLY TO
25 RECEIVE A GRANT; AND

26 (b) PERFORM ANNUAL EVALUATIONS OF GRANT RECIPIENTS
27 REGARDING THE PERFORMANCE AND IMPLEMENTATION OF AN INCLUSIVE

1 HIGHER EDUCATION PROGRAM PURSUANT TO SECTION 23-79-107.

2 (2) OF THE MONEY ANNUALLY APPROPRIATED TO THE
3 DEPARTMENT PURSUANT TO SECTION 23-79-108, NOT MORE THAN TWENTY
4 PERCENT SHALL BE USED TO COMPENSATE THE ADMINISTERING ENTITY TO
5 OFFSET THE COSTS THAT THE ADMINISTERING ENTITY INCURS IN
6 ADMINISTERING THE GRANT PROGRAM. THE CONTRACT BETWEEN THE
7 DEPARTMENT AND THE ADMINISTERING ENTITY MUST NOT INCLUDE ANY
8 ADDITIONAL AMOUNT OF REMUNERATION TO THE ADMINISTERING ENTITY
9 FROM THE STATE. THE DEPARTMENT SHALL COMPENSATE THE
10 ADMINISTERING ENTITY WITH FUNDS OUT OF THE CASH FUND.

11 **23-79-106. Applications - criteria - awards.** (1) TO RECEIVE A
12 GRANT, A STATE INSTITUTION OF HIGHER EDUCATION MUST SUBMIT AN
13 APPLICATION TO THE ADMINISTERING ENTITY IN ACCORDANCE WITH
14 POLICIES ADOPTED BY THE COMMISSION.

15 (2) THE ADMINISTERING ENTITY SHALL REVIEW THE APPLICATIONS
16 RECEIVED PURSUANT TO THIS SECTION. IN AWARDING GRANTS, THE
17 ADMINISTERING ENTITY SHALL CONSIDER THE INTENDED EXPENSES AND
18 ASSOCIATED COSTS PROPOSED BY THE APPLICANT RELATIVE TO THE
19 MONEY ANNUALLY APPROPRIATED TO THE DEPARTMENT PURSUANT TO
20 SECTION 23-79-108, TO ACHIEVE THE GREATEST INTENDED IMPACT OF THE
21 GRANT PROGRAM ACROSS COLORADO, INCLUDING MAXIMIZING ACCESS
22 AND OPPORTUNITY FOR ALL STUDENTS REGARDLESS OF DEMOGRAPHIC OR
23 GEOGRAPHIC DIVERSITY.

24 **23-79-107. Evaluation and reporting requirements.** (1) ON OR
25 BEFORE JULY 1, 2024, AND ON OR BEFORE JULY 1 EACH YEAR THEREAFTER,
26 THE ADMINISTERING ENTITY SHALL PERFORM AN EVALUATION OF THE
27 PERFORMANCE OF THE INCLUSIVE HIGHER EDUCATION PROGRAM AT EACH

1 STATE INSTITUTION OF HIGHER EDUCATION THAT RECEIVED A GRANT. THE
2 EVALUATION MUST:

3 (a) REVIEW EACH INCLUSIVE HIGHER EDUCATION PROGRAM AND
4 COMPARE THE PROGRAMS TO RECOGNIZED ACCREDITATION STANDARDS
5 AND BEST PRACTICES;

6 (b) INCLUDE COMPREHENSIVE SURVEYS OF INCLUSIVE HIGHER
7 EDUCATION PROGRAM STAKEHOLDERS, INCLUDING STUDENTS, STUDENTS'
8 FAMILIES, PEER MENTORS, FACULTY, AND STAFF; AND

9 (c) INCLUDE ASSESSMENTS FOR STUDENTS TO DEMONSTRATE
10 GROWTH IN INDEPENDENT LIVING, INCLUDING SELF-CARE, SOCIALIZATION,
11 CAREER READINESS, HEALTHY LIFESTYLE CHOICES, AND FINANCIAL
12 LITERACY.

13 (2) ON OR BEFORE JULY 1, 2024, AND ON OR BEFORE JULY 1 EACH
14 YEAR THEREAFTER, THE ADMINISTERING ENTITY SHALL PERFORM A
15 COMPREHENSIVE SURVEY OF FORMER STUDENTS AND FORMER STUDENTS'
16 FAMILIES. THE SURVEY MUST SOLICIT INFORMATION CONCERNING THE
17 FORMER STUDENTS, INCLUDING THEIR HOUSING CIRCUMSTANCES,
18 CAREERS, AND SOCIAL ACTIVITIES OR ASSOCIATIONS. THE ADMINISTERING
19 ENTITY SHALL RETAIN THE SURVEYS AND EVALUATE SUCCESSES THAT ARE
20 A CONSEQUENCE OF INCLUSIVE HIGHER EDUCATION PROGRAMS AND
21 IDENTIFY OPPORTUNITIES TO IMPROVE OUTCOMES FOR CURRENT AND
22 FUTURE STUDENTS.

23 (3) ON OR BEFORE OCTOBER 1, 2024, AND ON OR BEFORE OCTOBER
24 1 EACH YEAR THEREAFTER WHEN GRANTS ARE AWARDED, THE
25 ADMINISTERING ENTITY SHALL SUBMIT A REPORT TO THE DEPARTMENT. AT
26 A MINIMUM, THE REPORT MUST INCLUDE:

27 (a) A SUMMARY OF THE FINDINGS FROM THE EVALUATION

1 PERFORMED PURSUANT TO SUBSECTIONS (1) AND (2) OF THIS SECTION;

2 (b) AN ANALYSIS OF THE FINDINGS FROM THE EVALUATIONS
3 PERFORMED PURSUANT TO SUBSECTIONS (1) AND (2) OF THIS SECTION,
4 INCLUDING COMPARISONS BETWEEN THE CURRENT YEAR'S AND PREVIOUS
5 YEARS' FINDINGS TO EVALUATE THE LONG-TERM IMPACTS OF INCLUSIVE
6 HIGHER EDUCATION FOR CURRENT STUDENTS PARTICIPATING IN AN
7 INCLUSIVE HIGHER EDUCATION PROGRAM AND FORMER STUDENTS WHO
8 PARTICIPATED IN A PROGRAM; AND

9 (c) A DESCRIPTION OF EXPENSES MADE WITH THE GRANT MONEY.

10 (4) ON OR BEFORE DECEMBER 31, 2024, AND ON OR BEFORE
11 DECEMBER 31 EACH YEAR THEREAFTER WHEN GRANTS ARE AWARDED,
12 THE DEPARTMENT SHALL SUBMIT THE ADMINISTERING ENTITY'S REPORT TO
13 THE EDUCATION COMMITTEES OF THE SENATE AND THE HOUSE OF
14 REPRESENTATIVES, OR ANY SUCCESSOR COMMITTEES, REGARDING THE
15 GRANT PROGRAM.

16 (5) NOTWITHSTANDING SECTION 24-1-136 (11)(a)(I), THE
17 REPORTING REQUIREMENTS SET FORTH IN THIS SECTION CONTINUE
18 INDEFINITELY.

19 **23-79-108. Inclusive higher education opportunities cash fund**
20 **- created - funding.** (1) THE INCLUSIVE HIGHER EDUCATION
21 OPPORTUNITIES CASH FUND IS CREATED IN THE STATE TREASURY. THE
22 CASH FUND CONSISTS OF MONEY THAT THE GENERAL ASSEMBLY
23 APPROPRIATES OR TRANSFERS TO THE CASH FUND.

24 (2) FOR THE 2022-23, 2023-24, 2024-25, 2025-26, AND 2026-27
25 STATE FISCAL YEARS, THE GENERAL ASSEMBLY SHALL APPROPRIATE FOUR
26 HUNDRED FIFTY THOUSAND DOLLARS IN EACH STATE FISCAL YEAR TO THE
27 CASH FUND FOR THE PURPOSES OF THIS ARTICLE 79.

1 (3) THE STATE TREASURER SHALL CREDIT ALL INTEREST AND
2 INCOME DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE
3 CASH FUND TO THE CASH FUND.

4 (4) THE STATE TREASURER SHALL CREDIT ANY UNEXPENDED AND
5 UNENCUMBERED MONEY REMAINING IN THE CASH FUND AT THE END OF A
6 STATE FISCAL YEAR TO THE GENERAL FUND.

7 (5) MONEY IN THE CASH FUND IS CONTINUOUSLY APPROPRIATED
8 TO THE DEPARTMENT FOR THE PURPOSES OF THIS ARTICLE 79.

9 **SECTION 2. Appropriation.** For the 2022-23 state fiscal year,
10 \$450,000 is appropriated to the inclusive higher education opportunities
11 cash fund created in section 23-79-108 (1), C.R.S. This appropriation is
12 from the general fund. The department of higher education is responsible
13 for the accounting related to this appropriation.

14 **SECTION 3. Act subject to petition - effective date.** This act
15 takes effect at 12:01 a.m. on the day following the expiration of the
16 ninety-day period after final adjournment of the general assembly; except
17 that, if a referendum petition is filed pursuant to section 1 (3) of article V
18 of the state constitution against this act or an item, section, or part of this
19 act within such period, then the act, item, section, or part will not take
20 effect unless approved by the people at the general election to be held in
21 November 2022 and, in such case, will take effect on the date of the
22 official declaration of the vote thereon by the governor.
