**A BILL FOR AN ACT**

101 **CONCERNING PERMITTING THE TRANSFER OF A MARIJUANA**  
102 **TRANSPORTER LICENSE WITH A CHANGE OF OWNERSHIP.**

**Bill Summary**

Under current law, a marijuana transporter license cannot be transferred with a change of ownership. The bill removes this prohibition.

1           **SECTION 1.** In Colorado Revised Statutes, 44-10-505, **amend**  
2 (1)(a) as follows:

3           **44-10-505. Medical marijuana transporter license - definition.**

4 (1) (a) A medical marijuana transporter license may be issued to a person  
5 to provide logistics, distribution, delivery, and storage of medical  
6 marijuana and medical marijuana products. Notwithstanding any other  
7 provisions of law, a medical marijuana transporter license is valid for two  
8 years. ~~but cannot be transferred with a change of ownership.~~ A licensed  
9 medical marijuana transporter is responsible for the medical marijuana  
10 and medical marijuana products once it takes control of the product.

11           **SECTION 2.** In Colorado Revised Statutes, 44-10-605, **amend**  
12 (1)(a) as follows:

13           **44-10-605. Retail marijuana transporter license - definition.**

14 (1) (a) A retail marijuana transporter license may be issued to a person  
15 to provide logistics, distribution, delivery, and storage of retail marijuana  
16 and retail marijuana products. Notwithstanding any other provisions of  
17 law, a retail marijuana transporter license is valid for two years. ~~but~~  
18 ~~cannot be transferred with a change of ownership.~~ A licensed retail  
19 marijuana transporter is responsible for the retail marijuana and retail  
20 marijuana products once it takes control of the product.

21           **SECTION 3. Act subject to petition - effective date.** This act  
22 takes effect at 12:01 a.m. on the day following the expiration of the  
23 ninety-day period after final adjournment of the general assembly; except  
24 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
25 of the state constitution against this act or an item, section, or part of this  
26 act within such period, then the act, item, section, or part will not take  
27 effect unless approved by the people at the general election to be held in

- 1 November 2022 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
