**Bill Summary**

**Committee on Legal Services.** Based on the findings and recommendations of the committee on legal services, the bill extends all state agency rules that were adopted or amended on or after November 1, 2020, and before November 1, 2021, with the exception of the state personnel board's and state personnel director's rule concerning paid

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Extension of rules scheduled for expiration May**  
3 **15, 2022 - exceptions.** (1) Except as indicated, the expiration of all rules  
4 of agencies in the following principal departments, which rules were  
5 adopted or amended on or after November 1, 2020, and before November  
6 1, 2021, and that are therefore scheduled for expiration May 15, 2022, is  
7 postponed:

- 8 (a) Department of agriculture;
- 9 (b) Department of corrections;
- 10 (c) Department of education;
- 11 (d) Department of health care policy and financing;
- 12 (e) Department of higher education;
- 13 (f) Department of human services;
- 14 (g) Department of labor and employment;
- 15 (h) Department of law;
- 16 (i) Department of local affairs;
- 17 (j) Department of military and veterans affairs;
- 18 (k) Department of natural resources;
- 19 (l) Department of personnel; except that the following rule of the  
20 state personnel board and the state personnel director concerning state  
21 personnel board rules and personnel director's administrative procedures  
22 (4 CCR 801-1) is not extended: Rule 5-16, which states in part "Paid  
23 family medical leave (PFML) provides permanent full-time employees up

1 to eighty (80) hours of paid leave ...";

2 (m) Department of public health and environment;

3 (n) Department of public safety;

4 (o) Department of regulatory agencies;

5 (p) Department of revenue;

6 (q) Department of state;

7 (r) Department of transportation; and

8 (s) Department of the treasury.

9 (2) The expiration of all rules of the public employees' retirement  
10 association, which rules were adopted or amended on or after November  
11 1, 2020, and before November 1, 2021, and which are therefore scheduled  
12 for expiration May 15, 2022, is postponed.

13 (3) The expiration of all rules of the board of equalization, which  
14 rules were adopted or amended on or after November 1, 2020, and before  
15 November 1, 2021, and which are therefore scheduled for expiration May  
16 15, 2022, is postponed.

17 (4) The recommendations of the committee on legal services as  
18 reflected in this act apply to the specified rules in the form in which the  
19 rules were considered and acted upon by the committee. Any amendments  
20 or other changes in the specified rules that became effective before  
21 November 1, 2021, that comply with the recommendations of the  
22 committee on legal services are not affected by this act. Any subsequent  
23 amendments or other changes in the specified rules that became effective  
24 on or after November 1, 2021, are not affected by this act.

25 **SECTION 2. Safety clause.** The general assembly hereby finds,  
26 determines, and declares that this act is necessary for the immediate  
27 preservation of the public peace, health, or safety.
