Committee on Legal Services. Based on the findings and recommendations of the committee on legal services, the bill extends all state agency rules that were adopted or amended on or after November 1, 2020, and before November 1, 2021, with the exception of the state personnel board's and state personnel director's rule concerning paid

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Extension of rules scheduled for expiration May**

3 **15, 2022.** (1) The expiration of all rules of agencies in the following

4 principal departments, which rules were adopted or amended on or after

5 November 1, 2020, and before November 1, 2021, and that are therefore

6 scheduled for expiration May 15, 2022, is postponed:

7 (a) Department of agriculture;

8 (b) Department of corrections;

9 (c) Department of education;

10 (d) Department of health care policy and financing;

11 (e) Department of higher education;

12 (f) Department of human services;

13 (g) Department of labor and employment;

14 (h) Department of law;

15 (i) Department of local affairs;

16 (j) Department of military and veterans affairs;

19 (l) Department of personnel;

20 (m) Department of public health and environment;

21 (n) Department of public safety;

22 (o) Department of regulatory agencies;

- 3 (s) Department of the treasury.

4 (2) The expiration of all rules of the public employees' retirement
5 association, which rules were adopted or amended on or after November
6 1, 2020, and before November 1, 2021, and which are therefore scheduled
7 for expiration May 15, 2022, is postponed.

8 (3) The expiration of all rules of the board of equalization, which
9 rules were adopted or amended on or after November 1, 2020, and before
10 November 1, 2021, and which are therefore scheduled for expiration May
11 15, 2022, is postponed.

12 (4) The recommendations of the committee on legal services as
13 reflected in this act apply to the specified rules in the form in which the
14 rules were considered and acted upon by the committee. Any amendments
15 or other changes in the specified rules that became effective before
16 November 1, 2021, that comply with the recommendations of the
17 committee on legal services are not affected by this act. Any subsequent
18 amendments or other changes in the specified rules that became effective
19 on or after November 1, 2021, are not affected by this act.

20 **SECTION 2. Safety clause.** The general assembly hereby finds,
21 determines, and declares that this act is necessary for the immediate
22 preservation of the public peace, health, or safety.
