A BILL FOR AN ACT

101 **CONCERNING FUNDING FOR SPECIAL EDUCATION SERVICES, AND, IN**

Bill Summary

Legislative Interim Committee on School Finance. Current law requires the department of education to distribute to each administrative unit \$1,250 for each child with a disability who receives special education services from the administrative unit. The bill increases the amount to \$1,750 and requires the amount to increase by the rate of inflation each budget year beginning with the 2024-25 budget year.

The bill increases the required annual appropriation by an additional \$40 million to fund children who have one or more disabilities and receive special education services from an administrative unit and requires the amount to increase by the rate of inflation each budget year beginning with the 2024-25 budget year.

The bill requires the special education fiscal advisory committee to submit a report to the education committees of the general assembly on or before January 1, 2023. The report must include the following information:

- An analysis of funding for special education services in other states compared to the funding model used in Colorado, with a focus on the proportionate share between federal, state, and local funding and how other states fund different categories of disabilities to target the needs of children with disabilities;
- An analysis of the actual costs to provide special education services to children with disabilities in Colorado;
- An analysis of the effectiveness of the current model for funding special education services, including whether the current funding model adequately supports special education services;
- An examination of the high-cost special education trust fund (fund) that includes how the fund is operated, who receives funding from the fund, and how the fund impacts those who receive funds;
- An analysis of the current disability categories for children with disabilities and whether the disability categories are sufficient for meeting the needs of children with disabilities; and
- Recommended changes, if any, to the special education services funding model.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 22-20-114, **amend**
3 (1) introductory portion, (1)(b), and (1)(c)(I); and **add** (1)(c)(III)(B.1),
4 (1)(c)(III)(D), and (1.3) as follows:

5 **22-20-114. Funding of programs - legislative declaration -**
6 **repeal.** (1) Subject to the provisions of subsection (3) of this section, for
7 the 2005-06 budget year and each budget year thereafter, the total amount

1 appropriated to the department for the payment of costs incurred by
2 administrative units for the provision of special education programs shall
3 MUST be distributed to each administrative unit that provides educational
4 services for children with disabilities as follows:

5 (b) (I) FOR THE BUDGET YEARS PRECEDING THE 2022-23 BUDGET
6 YEAR, an amount equal to one thousand two hundred fifty dollars for each
7 child with disabilities receiving special education services from the
8 administrative unit; and

9 (II) EXCEPT AS SPECIFIED IN SUBSECTION (1.3) OF THIS SECTION,
10 FOR THE 2022-23 BUDGET YEAR AND EACH BUDGET YEAR THEREAFTER, AN
11 AMOUNT EQUAL TO ONE THOUSAND SEVEN HUNDRED FIFTY DOLLARS FOR

5 THEREAFTER, IN ADDITION TO ANY AMOUNT THAT IS AVAILABLE PURSUANT
6 TO SUBSECTIONS (1)(c)(I), (1)(c)(III)(A), AND (1)(c)(III)(B) OF THIS
7 SECTION, THE GENERAL ASSEMBLY SHALL APPROPRIATE TWENTY-SIX
8 MILLION EIGHT HUNDRED TWENTY-FIVE THOUSAND DOLLARS, WHICH
9 AMOUNT MAY BE APPROPRIATED FROM THE STATE EDUCATION FUND OR

12 (D) IT IS THE INTENT OF THE GENERAL ASSEMBLY TO INCREASE
13 FUNDING FOR SPECIAL EDUCATION SERVICES AS NECESSARY FOR THE
14 2023-24 BUDGET YEAR AND BUDGET YEARS THEREAFTER TO FULLY FUND
15 SPECIAL EDUCATION SERVICES PURSUANT TO THIS SUBSECTION (1)(c).

16 (1.3) FOR THE 2024-25 BUDGET YEAR AND BUDGET YEARS
17 THEREAFTER, THE DOLLAR AMOUNTS SET FORTH IN SUBSECTIONS (1)(b)(II)
18 AND (1)(c)(III) OF THIS SECTION ARE ANNUALLY INCREASED BY THE RATE
19 OF INFLATION. THE AMOUNTS MUST BE ROUNDED TO THE NEAREST
20 DOLLAR. AS USED IN THIS SUBSECTION (1.3), "INFLATION" MEANS THE
21 ANNUAL PERCENTAGE CHANGE IN THE UNITED STATES DEPARTMENT OF
22 LABOR BUREAU OF LABOR STATISTICS CONSUMER PRICE INDEX FOR
23 DENVER-AURORA-LAKEWOOD FOR ALL ITEMS PAID BY ALL URBAN
24 CONSUMERS, OR ITS APPLICABLE SUCCESSOR INDEX.

25 **SECTION 2.** In Colorado Revised Statutes, 22-20-114.5, **add** (7)
26 as follows:

27 **22-20-114.5. Special education fiscal advisory committee -**

1 **special education high-cost grants - report - definitions - repeal.**

2 (7) ON OR BEFORE JANUARY 1, 2023, THE COMMITTEE SHALL SUBMIT TO
3 THE EDUCATION COMMITTEES OF THE HOUSE OF REPRESENTATIVES AND
4 THE SENATE, OR ANY SUCCESSOR COMMITTEES, A REPORT THAT INCLUDES
5 BUT NEED NOT BE LIMITED TO:

6 (a) AN ANALYSIS OF FUNDING FOR SPECIAL EDUCATION SERVICES
7 IN OTHER STATES COMPARED TO THE FUNDING MODEL USED IN COLORADO,
8 WITH A FOCUS ON THE PROPORTIONATE SHARES PROVIDED BY FEDERAL,
9 STATE, AND LOCAL FUNDING AND HOW OTHER STATES FUND DIFFERENT
10 CATEGORIES OF DISABILITIES TO TARGET THE NEEDS OF CHILDREN WITH
11 DISABILITIES;

12 (b) AN ANALYSIS OF THE ACTUAL COSTS TO PROVIDE SPECIAL
13 EDUCATION SERVICES TO CHILDREN WITH DISABILITIES IN COLORADO;

14 (c) AN ANALYSIS OF THE EFFECTIVENESS OF THE CURRENT
15 FUNDING MODEL FOR SPECIAL EDUCATION SERVICES AND WHETHER THE
16 CURRENT FUNDING MODEL ADEQUATELY SUPPORTS SPECIAL EDUCATION
17 SERVICES;

18 (d) AN EXAMINATION OF THE HIGH-COST SPECIAL EDUCATION
19 TRUST FUND CREATED IN SECTION 22-20-114.7, INCLUDING HOW THE
20 HIGH-COST SPECIAL EDUCATION TRUST FUND IS CURRENTLY OPERATING,
21 WHO IS RECEIVING FUNDING FROM THE HIGH-COST SPECIAL EDUCATION
22 TRUST FUND, AND HOW THE HIGH-COST SPECIAL EDUCATION TRUST FUND
23 IMPACTS THOSE WHO RECEIVE FUNDS;

24 (e) AN ANALYSIS OF THE CURRENT DISABILITY CATEGORIES FOR
25 CHILDREN WITH DISABILITIES DESCRIBED IN SECTION 22-20-103 (5)(a) AND
26 WHETHER THE DISABILITY CATEGORIES ARE SUFFICIENT FOR MEETING THE
27 NEEDS OF CHILDREN WITH DISABILITIES; AND

1 (f) RECOMMENDED CHANGES, IF ANY, TO THE SPECIAL EDUCATION
2 SERVICES FUNDING MODEL DESCRIBED IN SECTION 22-20-114.

3 **SECTION 3. Appropriation.** For the 2022-23 state fiscal year,
4 \$80,000,000 is appropriated to the department of education. This
5 appropriation is from the state education fund created in section 17 (4)(a)
6 of article IX of the state constitution. To implement this act, the
7 department may use this appropriation for special education programs for
8 children with disabilities.

9 **SECTION 4. Safety clause.** The general assembly hereby finds,
10 determines, and declares that this act is necessary for the immediate
11 preservation of the public peace, health, or safety.
