A BILL FOR AN ACT

101 **CONCERNING A TRANSFER FROM THE REVENUE LOSS RESTORATION**
102 **CASH FUND TO THE JUDICIAL DEPARTMENT INFORMATION**
103 **TECHNOLOGY CASH FUND.**

Bill Summary

Joint Budget Committee. The bill requires the state treasurer to transfer \$24,131,390 from the revenue loss restoration cash fund to the judicial department information technology cash fund on July 1, 2022. The money transferred to the judicial department information technology cash fund is subject to annual appropriation by the general assembly to

the judicial department for information technology infrastructure upgrades from the 2022-23 fiscal year through the 2024-25 fiscal year. The bill requires the money transferred to the judicial department information technology cash fund to be expended or encumbered by the judicial department prior to December 31, 2024.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly
3 finds and declares that:

4 (a) As a result of the COVID-19 public health emergency, the
5 judicial department has identified information technology infrastructure
6 upgrades that are necessary to allow the judicial department to continue
7 to serve the residents of this state during the current and future public
8 health emergencies;

9 (b) Upgrading judicial department information technology
10 infrastructure to address these needs is a critical government service for
11 the state to provide to the residents of this state; and

12 (c) Therefore, it is appropriate to use money in the revenue loss
13 restoration cash fund for this purpose.

14 **SECTION 2.** In Colorado Revised Statutes, 13-32-114, **add** (4)
15 as follows:

16 **13-32-114. Judicial department information technology cash**
17 **fund - creation - uses.** (4) IN ADDITION TO THE MONEY DEPOSITED IN THE
18 FUND PURSUANT TO SUBSECTION (1) OF THIS SECTION, THE FUND CONSISTS
19 OF MONEY TRANSFERRED TO THE FUND FROM THE REVENUE LOSS
20 RESTORATION CASH FUND PURSUANT TO SECTION 24-75-227 (3.5). SUCH
21 TRANSFERRED MONEY IS SUBJECT TO ANNUAL APPROPRIATION BY THE
22 GENERAL ASSEMBLY TO THE JUDICIAL DEPARTMENT FOR INFORMATION
23 TECHNOLOGY INFRASTRUCTURE UPGRADES FROM THE 2022-23 FISCAL

1 YEAR THROUGH THE 2024-25 FISCAL YEAR; EXCEPT THAT ALL SUCH
2 TRANSFERRED MONEY MUST BE EXPENDED OR ENCUMBERED BY THE
3 JUDICIAL DEPARTMENT PRIOR TO DECEMBER 31, 2024.

4 **SECTION 3.** In Colorado Revised Statutes, 24-75-227, **add** (3.5)
5 as follows:

6 **24-75-227. Revenue loss restoration cash fund - creation -**
7 **allowable uses - definitions - repeal.** (3.5) NOTWITHSTANDING THE
8 LIMITATION IN SUBSECTION (3)(c) OF THIS SECTION, ON JULY 1, 2022, THE
9 STATE TREASURER SHALL TRANSFER TWENTY-FOUR MILLION ONE
10 HUNDRED THIRTY-ONE THOUSAND THREE HUNDRED NINETY DOLLARS
11 FROM THE FUND TO THE JUDICIAL DEPARTMENT INFORMATION
12 TECHNOLOGY CASH FUND CREATED IN SECTION 13-32-114.

13 **SECTION 4. Safety clause.** The general assembly hereby finds,
14 determines, and declares that this act is necessary for the immediate
15 preservation of the public peace, health, or safety.
