**A BILL FOR AN ACT**

101     **CONCERNING INCREASING ACCESS TO POSTSECONDARY WORKFORCE**  
102             **READINESS WITH FINANCIAL AID INFORMATION, AND, IN**  
103             **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

The bill establishes a number of new programs concerning postsecondary career and education options for students, including:

- Establishing the postsecondary, workforce, career, and education grant program in the department of education (CDE) to provide grants to local education providers to

improve the training of school educators and administrators, to support students and families in developing career and education plans for after high school, and to increase the number of students for whom applications for free financial aid are completed;

- Creating regional postsecondary and workforce coordinators in the CDE to train educators concerning financial aspects of postsecondary options;
- Updating the financial literacy resource bank to include more information and training concerning postsecondary financial aid;
- Creating stipends for teachers who successfully complete financial aid training;
- Adding a requirement to individual career and postsecondary education plans to include information about available state and federal financial aid;
- Requiring the department of higher education (CDHE) to use technology to assist students and families in completing postsecondary state and federal financial aid applications; and
- Requiring the CDHE to make certain improvements to streamline the Colorado application for financial aid.

The bill appropriates money for each of the programs and specifies that the CDE and the CDHE may use the money appropriated in subsequent years without additional appropriation.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1. Legislative declaration.** (1) The general assembly  
3 finds and declares that:

4           (a) Research shows that education and training culminating in  
5 credentials, such as industry certificates, trade school certificates,  
6 apprenticeships, associate's degrees, and bachelor's degrees, among other  
7 business and industry-based experiences, are necessary to earn a living  
8 wage in Colorado. Completion of the federal or state financial aid  
9 applications are key components of understanding how additional  
10 education beyond high school can be financially supported. Completion  
11 of federal or state financial aid applications supports access to these

1 career pathway options, as they are vehicles to support paying for tuition,  
2 fees, equipment, and other expenses associated with additional training  
3 beyond high school.

4 (b) An understanding of how to access these career-aligned  
5 resources and supports is integral to navigating training and education  
6 resources for students and families. Financial literacy education and  
7 Colorado's individual career and academic plan can help families  
8 understand how to obtain federal or state financial aid to support students  
9 in pursuing additional education and career training.

10 (c) Research shows that students and families who do not  
11 complete financial aid forms do so for one or more of the following  
12 reasons:

13 (I) (A) Students and families are unaware of the true cost of  
14 attending postsecondary options and the resources available to pay for  
15 education and training that might be available by federal or state financial  
16 aid forms; or

17 (B) A false belief that grants or scholarships are unavailable based  
18 on family resources and income levels;

19 (II) Students and families often do not have the required tax  
20 information available due to individual or family circumstances or needed  
21 support to acquire that information or fill out complex forms, which leads  
22 to students not completing and submitting federal financial aid or state  
23 financial aid documents; and

24 (III) Students and families fear incurring debt for postsecondary  
25 education because of the potential difficulty in paying back those loans;

26 (d) In 2023, the free application for federal student aid will be  
27 simplified, reducing the number of questions from 100 to 30 and reducing

1 the financial information needed through the federal "FAFSA  
2 Simplification Act";

3 (e) More broadly, Colorado students have the opportunity to  
4 magnify the impact of state investments in higher education by accessing  
5 federal dollars to pursue postsecondary education and a credential of  
6 value to enhance income earning potential. It is estimated that more than  
7 \$30 million in federal resources could be leveraged each year by  
8 Colorado students completing federal and state financial aid applications.

9 (f) Completing federal and state financial aid applications requires  
10 support among students and their families, K-12 college and career  
11 readiness programs, and higher education institutions for academic and  
12 workforce training.

13 **SECTION 2.** In Colorado Revised Statutes, **add** 22-7-1015.5 as  
14 follows:

15 **22-7-1015.5. Postsecondary, workforce, career, and education**  
16 **grant program - created - application - criteria - awards -**  
17 **appropriation - repeal.** (1) THERE IS CREATED IN THE DEPARTMENT OF  
18 EDUCATION, REFERRED TO IN THIS SECTION AS THE "DEPARTMENT", THE  
19 POSTSECONDARY, WORKFORCE, CAREER, AND EDUCATION GRANT  
20 PROGRAM, REFERRED TO IN THIS SECTION AS THE "GRANT PROGRAM", TO  
21 AWARD GRANTS TO LOCAL EDUCATION PROVIDERS TO IMPROVE THE  
22 POSTSECONDARY OPTIONS AVAILABLE TO STUDENTS AND TO INCREASE THE  
23 NUMBER OF STUDENTS COMPLETING THE FREE APPLICATION FOR FEDERAL  
24 STUDENT AID, REFERRED TO IN THIS SECTION AS "FAFSA", AND THE  
25 COLORADO APPLICATION FOR STATE FINANCIAL AID, REFERRED TO IN THIS  
26 SECTION AS "CASFA". EACH GRANT HAS A TERM OF THREE YEARS  
27 BEGINNING IN THE 2022-23 STATE FISCAL YEAR. IN MAKING A GRANT

1 AWARD, THE DEPARTMENT SHALL SPECIFY THE AMOUNT OF EACH GRANT.

2 (2) THE DEPARTMENT SHALL DISTRIBUTE THE GRANT MONEY TO  
3 THE LOCAL EDUCATION PROVIDERS THAT RECEIVE A GRANT FOR THE  
4 FOLLOWING PURPOSES:

5 (a) DEVELOPING AND DISTRIBUTING INFORMATION TO STUDENTS,  
6 FAMILIES, AND SCHOOL LEADERS REGARDING THE FAFSA AND  
7 APPLICATIONS FOR STATE STUDENT AID, AND THE BENEFITS OF  
8 COMPLETING THE FAFSA AND APPLICATIONS FOR STATE STUDENT AID;

9 (b) DEVELOPING AND DISTRIBUTING INFORMATION TO STUDENTS  
10 AND FAMILIES REGARDING THE STEPS REQUIRED TO COMPLETE THE FAFSA  
11 AND APPLICATIONS FOR STATE STUDENT AID;

12 (c) TRAINING SCHOOL COUNSELORS AND OTHER EDUCATORS ON  
13 BEST PRACTICES TO SUPPORT STUDENTS AND FAMILIES WITH FILLING OUT  
14 THE FAFSA AND APPLICATIONS FOR STATE STUDENT AID, WITH AN  
15 EMPHASIS ON SUPPORTING COMMUNITIES THAT HAVE HISTORICALLY LOW  
16 COMPLETION RATES OF THE FAFSA AND APPLICATIONS FOR STATE  
17 STUDENT AID;

18 (d) ORGANIZING AND HOSTING OPPORTUNITIES FOR STUDENTS AND  
19 FAMILIES TO MEET WITH STAKEHOLDERS WHO ASSIST IN COMPLETING THE  
20 FAFSA OR APPLICATIONS FOR STATE STUDENT AID;

21 (e) INCORPORATING COMPLETION OF APPLICATIONS FOR FEDERAL  
22 STUDENT AID AND APPLICATIONS FOR STATE STUDENT AID INTO  
23 INDIVIDUAL CAREER AND ACADEMIC PLANS PURSUANT TO SECTIONS  
24 22-32-109 AND 22-30.5-525; ■■■

25 (f) COLLABORATING WITH THE DEPARTMENT OF HIGHER  
26 EDUCATION'S EFFORTS PURSUANT TO SECTION 23-3.3-1007 TO SUPPORT  
27 LOCAL EDUCATION PROVIDERS IN EXPLORING POSTSECONDARY OPTIONS

1 UNDER THE INDIVIDUAL CAREER AND ACADEMIC PLANS PURSUANT TO  
2 SECTIONS 22-32-109 AND 22-30.5-525; AND

3 (g) COLLABORATING OR PARTNERING WITH NONPROFIT  
4 ORGANIZATIONS TO SUPPORT LOCAL EDUCATION PROVIDERS AND  
5 STUDENTS WITH EDUCATION AND COMPLETION OF STUDENT APPLICATIONS  
6 FOR FEDERAL STUDENT AID AND APPLICATIONS FOR STATE STUDENT AID.

7 (3) A LOCAL EDUCATION PROVIDER SEEKING A GRANT MUST  
8 SUBMIT AN APPLICATION TO THE DEPARTMENT. THE DEPARTMENT SHALL  
9 REVIEW EACH GRANT APPLICATION RECEIVED AND DETERMINE WHETHER  
10 AND IN WHAT AMOUNT A GRANT SHOULD BE AWARDED TO THE LOCAL  
11 EDUCATION PROVIDER. IF THE DEPARTMENT DETERMINES AN APPLICATION  
12 IS MISSING ANY INFORMATION REQUIRED BY RULE TO BE INCLUDED WITH  
13 THE APPLICATION, THE DEPARTMENT MAY CONTACT THE LOCAL  
14 EDUCATION PROVIDER TO OBTAIN THE MISSING INFORMATION.

15 (4) AT A MINIMUM, EACH GRANT APPLICATION MUST SPECIFY:

16 (a) THE CURRENT PROGRAMS RELATED TO COLLEGE AND CAREER  
17 READINESS DEVELOPED PURSUANT TO SECTION 22-7-1015 AND INDIVIDUAL  
18 CAREER AND ACADEMIC PLANS PURSUANT TO SECTIONS 22-32-109 AND  
19 22-30.5-525 THAT THE LOCAL EDUCATION PROVIDER USES;

20 (b) WHETHER THE LOCAL EDUCATION PROVIDER HAS ENTERED  
21 INTO, OR HAS COMMITTED TO ESTABLISHING, ONE OR MORE PARTNERSHIPS  
22 WITH INSTITUTIONS OF HIGHER EDUCATION OR POSTSECONDARY SERVICE  
23 PROVIDERS IN COLORADO TO SUPPORT AND INCREASE THE CAPACITY AND  
24 EFFECTIVENESS OF CAREER COUNSELING AND POSTSECONDARY  
25 PREPARATION SERVICES PROVIDED TO STUDENTS ENROLLED IN OR  
26 RECEIVING EDUCATIONAL SERVICES FROM THE EDUCATION PROVIDER;

27 (c) THE LOCAL EDUCATION PROVIDER'S PLAN FOR USE OF THE

1 GRANT MONEY, INCLUDING THE EXTENT TO WHICH THE GRANT MONEY  
2 WILL BE USED TO INCREASE THE NUMBER OF STUDENTS WHO COMPLETE  
3 FEDERAL AND STATE FINANCIAL AID APPLICATIONS AT THE LOCAL  
4 EDUCATION PROVIDER'S HIGH SCHOOLS SERVED BY THE GRANT AND TO  
5 PROVIDE PROFESSIONAL DEVELOPMENT FOR SCHOOL COUNSELORS AND  
6 OTHER EDUCATORS ON WORK-BASED LEARNING, COMPLETION OF FEDERAL  
7 AND STATE FINANCIAL AID APPLICATIONS, AND INTEGRATION OF ALL  
8 POSTSECONDARY OPTIONS INTO THE INDIVIDUAL CAREER AND ACADEMIC  
9 PLANS FOR STUDENTS;

10 (d) THE LOCAL EDUCATION PROVIDER'S PLAN FOR INVOLVING  
11 EDUCATORS AND ADMINISTRATORS AT THE LOCAL EDUCATION PROVIDER'S  
12 SCHOOLS PROVIDING POSTSECONDARY PREPARATION SUPPORTS;

13 (e) THE EXTENT TO WHICH THE LOCAL EDUCATION PROVIDER HAS  
14 DEVELOPED OR PLANS TO DEVELOP PARTNERSHIPS TO SERVE THE  
15 POSTSECONDARY NEEDS OF ALL OF THE STUDENTS ENROLLED IN OR  
16 RECEIVING EDUCATIONAL SERVICES FROM THE LOCAL EDUCATION  
17 PROVIDER;

18 (f) THE LOCAL EDUCATION PROVIDER'S USE OF DISTRICT-LEVEL OR  
19 SCHOOL-LEVEL EXISTING AND POTENTIAL PROGRAMMING FOR  
20 POSTSECONDARY AND WORKFORCE READINESS, AS DEFINED IN SECTION  
21 22-7-1008;

22 (g) WHETHER THE LOCAL EDUCATION PROVIDER INTENDS TO  
23 PROVIDE MATCHING FUNDS TO AUGMENT ANY GRANT MONEY RECEIVED  
24 FROM THE PROGRAM AND THE ANTICIPATED AMOUNT AND SOURCE OF ANY  
25 MATCHING FUNDS; AND

26 (h) WHETHER THE LOCAL EDUCATION PROVIDER NEEDS TO UPDATE  
27 THE INDIVIDUAL CAREER AND ACADEMIC PLAN PROCESS TO

1 ACCOMMODATE REQUIREMENTS PURSUANT TO SECTION 22-2-136 (1),  
2 INCLUDING FINANCIAL AID FORM INFORMATION, OR FINANCIAL LITERACY  
3 CURRICULUM PURSUANT TO SECTION 22-2-127.

4 (5) IN REVIEWING APPLICATIONS, THE DEPARTMENT MAY CONSIDER  
5 THE FOLLOWING CRITERIA, IN ADDITION TO ANY OTHER CRITERIA ADOPTED  
6 BY RULE OF THE STATE BOARD:

7 (a) HIGH SCHOOLS WITH LOW POSTSECONDARY CREDENTIAL  
8 ATTAINMENT RATES;

9 (b) THE LOCAL EDUCATION PROVIDER'S HIGH SCHOOLS WITH LOW  
10 FEDERAL AND STATE FINANCIAL AID APPLICATION COMPLETION RATES;  
11 AND

12 (c) THE GEOGRAPHIC LOCATION OF THE LOCAL EDUCATION  
13 PROVIDER. THE DEPARTMENT MAY PRIORITIZE AWARDED GRANTS TO  
14 RURAL AREAS OF THE STATE AND PROVIDE TECHNICAL ASSISTANCE TO  
15 RURAL LOCAL EDUCATION PROVIDERS REQUESTING SUPPORT.

16 (6) (a) SUBJECT TO AVAILABLE APPROPRIATIONS, THE  
17 DEPARTMENT SHALL AWARD GRANTS TO LOCAL EDUCATION PROVIDERS  
18 PURSUANT TO THIS SECTION. EACH GRANT HAS A TERM OF THREE YEARS  
19 BEGINNING IN THE 2022-23 BUDGET YEAR. IN MAKING A GRANT AWARD,  
20 THE DEPARTMENT SHALL SPECIFY THE AMOUNT OF EACH GRANT.

21 (b) A LOCAL EDUCATION PROVIDER THAT RECEIVES A GRANT  
22 SHALL USE THE MONEY FOR THE FOLLOWING PURPOSES:

23 (I) DEVELOPING AND DISTRIBUTING TO STUDENTS, FAMILIES, AND  
24 EDUCATORS INFORMATION ABOUT AND STEPS TO COMPLETE THE FEDERAL  
25 AND STATE FINANCIAL AID APPLICATIONS;

26 (II) TRAINING SCHOOL COUNSELORS AND OTHER EDUCATORS ON  
27 BEST PRACTICES TO SUPPORT STUDENTS AND FAMILIES WITH FILLING OUT



1 FEDERAL AND STATE FINANCIAL AID APPLICATIONS WITH AN EMPHASIS ON  
2 SUPPORTING COMMUNITIES THAT HAVE HISTORICALLY LOW COMPLETION  
3 RATES OF FEDERAL AND STATE FINANCIAL AID APPLICATIONS;

4 (III) ORGANIZING AND HOSTING OPPORTUNITIES FOR STUDENTS  
5 AND FAMILIES TO MEET WITH STAKEHOLDERS WHO ASSIST IN COMPLETING  
6 THE FAFSA OR APPLICATIONS FOR STATE STUDENT AID; AND

7 (IV) UPDATING THE LOCAL EDUCATION PROVIDER'S INDIVIDUAL  
8 CAREER AND ACADEMIC PLAN PROCESS WITH FINANCIAL AID INFORMATION  
9 AND COMPLETION OF THE APPLICATION FORMS.

10 (7) THE DEPARTMENT MAY EXPEND NO MORE THAN TEN PERCENT  
11 OF THE MONEY ANNUALLY APPROPRIATED FOR THE PROGRAM TO OFFSET  
12 THE COSTS INCURRED IN IMPLEMENTING THE PROGRAM, INCLUDING THE  
13 PROVISION OF TECHNICAL ASSISTANCE TO RURAL LOCAL EDUCATION  
14 PROVIDERS, GRANT-RELATED PROFESSIONAL DEVELOPMENT, TRAINING,  
15 AND REPORTING ACTIVITIES.

16 (8) ON OR BEFORE SEPTEMBER 1, 2023, AND ON OR BEFORE  
17 SEPTEMBER 1 EACH YEAR THEREAFTER FOR THE LENGTH OF THE GRANT,  
18 EACH LOCAL EDUCATION PROVIDER RECEIVING GRANT MONEY PURSUANT  
19 TO THIS SECTION SHALL REPORT THE FOLLOWING INFORMATION TO THE  
20 DEPARTMENT:

21 (a) A COMPARISON OF THE DROPOUT RATES, AND THE COLLEGE  
22 MATRICULATION AND REMEDIATION RATES, IF APPLICABLE, AT THE HIGH  
23 SCHOOLS SERVED BY THE GRANT FOR THE YEARS PRIOR TO RECEIPT OF THE  
24 GRANT AND THE YEARS FOR WHICH THE LOCAL EDUCATION PROVIDER  
25 RECEIVES THE GRANT; AND

26 (b) A COMPARISON OF THE NUMBER OF STUDENTS WHO COMPLETED  
27 FEDERAL AND STATE FINANCIAL AID APPLICATIONS FOR THE YEAR PRIOR

1 TO WHICH THE LOCAL EDUCATION PROVIDER RECEIVED THE GRANT, IF  
2 AVAILABLE, AND THE NUMBER OF STUDENTS WHO COMPLETED FEDERAL  
3 AND STATE FINANCIAL AID APPLICATIONS FOR EACH OF THE THREE YEARS  
4 THE EDUCATION PROVIDER RECEIVES THE GRANT.

5 (9) NOTWITHSTANDING SECTION 24-1-136 (11)(a)(I), ON OR  
6 BEFORE OCTOBER 15, 2023, AND ON OR BEFORE OCTOBER 15 EACH YEAR  
7 THEREAFTER FOR THE LENGTH OF THE GRANT, THE DEPARTMENT SHALL  
8 SUBMIT TO THE EDUCATION COMMITTEES OF THE SENATE AND THE HOUSE  
9 OF REPRESENTATIVES, OR ANY SUCCESSOR COMMITTEES, A REPORT THAT,  
10 AT A MINIMUM, SUMMARIZES THE INFORMATION RECEIVED BY THE  
11 DEPARTMENT PURSUANT TO SUBSECTION (8) OF THIS SECTION AND THAT  
12 THE DEPARTMENT RECEIVES FROM THE DEPARTMENT OF HIGHER  
13 EDUCATION PURSUANT TO SECTION 23-1-113 (9). THE DEPARTMENT SHALL  
14 ALSO POST THE REPORT TO ITS WEBSITE.

15 (10) FOR THE 2022-23 STATE FISCAL YEAR, THE GENERAL  
16 ASSEMBLY SHALL APPROPRIATE TO THE DEPARTMENT ONE MILLION, ONE  
17 HUNDRED TWENTY-FIVE THOUSAND DOLLARS FROM THE GENERAL FUND  
18 FOR THE GRANT PROGRAM PURSUANT TO THIS SECTION. ANY UNEXPENDED  
19 MONEY REMAINING AT THE END OF THE 2022-23 STATE FISCAL YEAR FROM  
20 THIS APPROPRIATION:

21 (I) DOES NOT REVERT TO THE GENERAL FUND OR ANY OTHER FUND;

22 (II) MAY BE USED BY THE DEPARTMENT IN THE 2023-24 OR  
23 2024-25 STATE FISCAL YEAR WITHOUT FURTHER APPROPRIATION; AND

24 (III) MUST NOT BE USED FOR ANY OTHER PURPOSE OTHER THAN  
25 THE PURPOSES SET FORTH IN THIS SECTION.

26 (11) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1, 2027.

27 **SECTION 3.** In Colorado Revised Statutes, 22-7-1015, **amend**

1 (4)(c); and **add** (4)(e), (4)(f), and (4)(g) as follows:

2 **22-7-1015. Postsecondary and workforce readiness program**

3 **- technical assistance - appropriation.** (4) The department of education,  
4 the department of higher education, and the state institutions of higher  
5 education, upon request, shall provide support to local education  
6 providers in implementing postsecondary and workforce readiness.  
7 Beginning with the 2009-10 budget year, the department of education and  
8 the department of higher education may include in their annual budget  
9 requests an amount necessary to offset the costs incurred in complying  
10 with this section. Support may include, but need not be limited to:

11 (c) Providing professional development for educators; ~~and~~

12 (e) ESTABLISHING SUPPORT THROUGH REGIONAL POSTSECONDARY  
13 AND WORKFORCE READINESS COORDINATORS FOR TRAINING THAT ALIGNS  
14 WITH FINANCIAL AID, FINANCIAL LITERACY, AND SUPPORTS FOR STUDENT  
15 FEDERAL FINANCIAL AID APPLICATION AND STUDENT STATE FINANCIAL AID  
16 APPLICATION COMPLETION;

17 (f) (I) SUPPORTING THE NUMBER OF REGIONAL INDIVIDUAL CAREER  
18 AND ACADEMIC PLAN COORDINATORS IN THE STATE AND UPDATING THE  
19 RESOURCES AVAILABLE TO THE COORDINATORS TO SUPPORT FINANCIAL  
20 AID INFORMATION AND APPLICATIONS;

21 (II) REQUIRING THE REGIONAL INDIVIDUAL CAREER AND ACADEMIC  
22 PLAN COORDINATORS TO PROVIDE ADDITIONAL TRAINING AND OUTREACH  
23 TO SCHOOLS AND COORDINATE WITH THE OUTREACH TEAM IN THE  
24 DEPARTMENT OF HIGHER EDUCATION CREATED PURSUANT TO SECTION  
25 23-1-119 (6).

26 (g) FOR THE 2022-23 STATE FISCAL YEAR, THE GENERAL  
27 ASSEMBLY SHALL APPROPRIATE TO THE DEPARTMENT TWENTY-FIVE

1 THOUSAND DOLLARS FROM THE GENERAL FUND FOR THE PROGRAMS  
2 DESCRIBED IN SUBSECTION (4)(f) OF THIS SECTION. ANY UNEXPENDED  
3 MONEY REMAINING AT THE END OF THE 2022-23 STATE FISCAL YEAR FROM  
4 THIS APPROPRIATION:

5 (I) DOES NOT REVERT TO THE GENERAL FUND OR ANY OTHER FUND;

6 (II) MAY BE USED BY THE DEPARTMENT IN THE 2023-24 OR

6 education grant and readiness program, which amount is based on an  
7 assumption that the department will require an additional 0.9 FTE; and

8 (b) \$475,000 for financial aid training stipends and resource bank,  
9 which amount is based on an assumption that the department will require  
10 an additional 1.0 FTE.

11 (2) For the 2022-23 state fiscal year, \$1,000,000 is appropriated  
12 to the department of higher education. This appropriation is from the  
13 general fund. Any money appropriated in this subsection (2) not expended  
14 prior to July 1, 2023, is further appropriated to the department for the  
15 2023-24 and 2024-25 state fiscal years for the same purpose. To  
16 implement this act, the department may use this appropriation as follows:

17 (a) \$680,000 for a financial aid toolkit, which amount is based on  
18 an assumption that the department will require an additional 2.0 FTE; and

19 (b) \$320,000 for financial aid assessment tool improvements,  
20 which amount is based on an assumption that the department will require  
21 an additional 1.0 FTE.

22 (3) For the 2022-23 state fiscal year, \$250,000 is appropriated to  
23 the department of higher education. This appropriation is from the general  
24 fund and is based on an assumption that the department will require an  
25 additional 2.0 FTE. To implement this act, the department may use this  
26 appropriation for Colorado commission on higher education and higher  
27 education special purpose program administration.

1           **SECTION 10. Safety clause.** The general assembly hereby finds,  
2 determines, and declares that this act is necessary for the immediate  
3 preservation of the public peace, health, or safety.
