**A BILL FOR AN ACT**

101 **CONCERNING THE DESIGNATION AND PROMOTION OF DARK SKY**  
102 **LOCATIONS IN COLORADO.**

**Bill Summary**

The International Dark-Sky Association (IDA) encourages communities, parks, and protected areas to preserve and protect dark skies by various means, including an international dark sky places program that offers designations for 5 types of dark sky places. The bill requires the Colorado tourism office (office) to establish the Colorado designated dark sky designation technical assistance grant program (program) to:

- Provide technical assistance grants to applicants seeking direct support from the IDA for activities related to international dark sky designation; and
- Provide general education and outreach about dark skies and specifically promote responsible and sustainable tourism opportunities in designated dark sky places in the state.

The office may contract with the Colorado chapter of the IDA to help the office develop its program policies, evaluate grant applications, and make recommendations to the office regarding which applicants should receive grant awards and what the amount of each award should be. The office may also contract with the Colorado chapter of the IDA to provide general education and outreach and to promote tourism. To fund the program, the bill requires \$50,000 to be transferred from the general fund to the Colorado travel and tourism additional source fund, which current law continuously appropriates to the office.

On or before November 1, 2023, the office is required to submit a report detailing the expenditure of the money dedicated to the program to the house of representatives business affairs and labor committee and the senate business, labor, and technology committee, or their successor committees. The report must specify the grant-supported actions taken in furtherance of designating new dark sky places and indicate how many program grant recipients have had a community or other place designated as a designated dark sky place.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **add** 24-49.7-110 as  
3 follows:

4           **24-49.7-110. Colorado dark sky designation technical**  
5 **assistance grant program - funding - report - legislative declaration**  
6 **- definitions.** (1) THE GENERAL ASSEMBLY HEREBY FINDS AND DECLARES

7 THAT:

8           (a) THE AESTHETIC BEAUTY AND WONDER OF NATURAL DARK  
9 SKIES AT NIGHT ARE INHERENT TO THE CHARACTER AND ALLURE OF THE  
10 STATE;

11           (b) THE GROWING PROBLEM OF LIGHT POLLUTION, INCLUDING SKY

1 GLOW, GLARE, AND LIGHT TRESPASS, WHICH IS ALSO KNOWN AS SPILL  
2 LIGHT, IS ATTRIBUTED TO THE USE OF ARTIFICIAL LIGHT AT NIGHT AND HAS  
3 BEEN SCIENTIFICALLY LINKED TO NEGATIVE EFFECTS ON THE HEALTH AND  
4 WELL-BEING OF PEOPLE, PLANTS, AND ANIMALS, WHILE NATURAL DARK  
5 SKIES AT NIGHT HAVE BEEN SCIENTIFICALLY LINKED TO POSITIVE HEALTH  
6 EFFECTS;

7 (c) THE NIGHTTIME ENVIRONMENT IS BOTH A NATURAL AND  
8 CULTURAL RESOURCE;

9 (d) DARK SKY TOURISM COMBINES ELEMENTS OF ASTROTOURISM,  
10 CULTURAL HERITAGE TOURISM, NATURE AND WILDLIFE TOURISM, AND  
11 HEALTH AND WELLNESS TOURISM AND EMPHASIZES STEWARDSHIP OF THE  
12 NIGHTTIME ENVIRONMENT;

13 (e) THE INTERNATIONAL DARK-SKY ASSOCIATION, REFERRED TO  
14 IN THIS SECTION AS THE "IDA", ENDEAVORS TO PRESERVE DARK SKIES AT  
15 NIGHT AND TO INCREASE THE NUMBER OF PLACES THAT HAVE DARK SKIES  
16 AT NIGHT BY REDUCING ARTIFICIAL LIGHT POLLUTION THROUGH A VARIETY  
17 OF MEANS, INCLUDING AN INTERNATIONAL DARK SKY PLACES PROGRAM,  
18 HEREINAFTER REFERRED TO AS THE "IDSP PROGRAM". UNDER THE IDSP  
19 PROGRAM, A COMMUNITY OR OTHER PLACE THAT SATISFIES SPECIFIED  
20 CRITERIA CAN BE CERTIFIED BY THE IDA AS ONE OF THE FOLLOWING TYPES  
21 OF DESIGNATED DARK SKY PLACES:

- 22 (I) AN INTERNATIONAL DARK SKY COMMUNITY;
- 23 (II) AN INTERNATIONAL DARK SKY PARK;
- 24 (III) AN INTERNATIONAL DARK SKY RESERVE;
- 25 (IV) AN INTERNATIONAL DARK SKY SANCTUARY; OR
- 26 (V) AN URBAN NIGHT SKY PLACE;
- 27 (f) INCREASING NUMBERS OF COLORADANS AND COLORADO

1 COMMUNITIES ARE RECOGNIZING THE ECONOMIC, ECOLOGICAL, CULTURAL,  
2 AND SOCIETAL BENEFITS OF PRESERVING AND EXPANDING DARK SKY  
3 PLACES BY IMPLEMENTING IDA-APPROVED LIGHTING INITIATIVES AND  
4 APPLYING FOR DESIGNATED DARK SKY PLACE STATUS UNDER THE IDSP  
5 PROGRAM, BUT MANY COLORADANS AND COLORADO COMMUNITIES  
6 EITHER DO NOT YET KNOW ABOUT THE BENEFITS OF PRESERVING AND  
7 EXPANDING DARK SKY PLACES OR ABOUT THE IDSP PROGRAM OR REQUIRE  
8 TECHNICAL ASSISTANCE TO TAKE THE STEPS NECESSARY TO ACHIEVE  
9 DESIGNATED DARK SKY PLACE STATUS FOR A COMMUNITY OR OTHER  
10 PLACE;

11 (g) THROUGH DARK SKY EDUCATION, OUTREACH, PRACTICES, AND  
12 POLICIES, A CONNECTION TO THE NATURAL NIGHTTIME ENVIRONMENT CAN  
13 BE REESTABLISHED FOR PRESENT AND FUTURE GENERATIONS; AND

14 (h) IT THEREFORE SERVES PRIMARILY A PUBLIC PURPOSE AND IS  
15 NECESSARY, APPROPRIATE, AND IN THE BEST INTEREST OF ALL  
16 COLORADANS TO PROVIDE FUNDING TO THE OFFICE SO THAT THE OFFICE  
17 CAN:

18 (I) PROVIDE TECHNICAL ASSISTANCE GRANTS TO APPLICANTS  
19 SEEKING SUPPORT FOR AN APPLICATION TO THE IDA FOR A COMMUNITY OR  
20 PLACE TO BE CERTIFIED BY THE IDA AS A DESIGNATED DARK SKY PLACE;  
21 AND

22 (II) CONTRACT WITH THE IDA AND THE COLORADO CHAPTER OF  
23 THE IDA TO HELP THE OFFICE ADMINISTER THE GRANT PROGRAM,  
24 PROMOTE THE PRESERVATION AND EXPANSION OF DESIGNATED DARK SKY  
25 PLACES IN THE STATE IN ACCORDANCE WITH BEST STEWARDSHIP  
26 PRACTICES, AND PROMOTE TOURISM OPPORTUNITIES IN DESIGNATED DARK  
27 SKY PLACES IN THE STATE.

1 (2) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE  
2 REQUIRES:

3 (a) "ADDITIONAL SOURCE FUND" MEANS THE COLORADO TRAVEL  
4 AND TOURISM ADDITIONAL SOURCE FUND CREATED IN SECTION  
5 24-49.7-106 (2).

6 (b) "APPLICANT" MEANS A COMMUNITY, INDIVIDUAL, GROUP OF  
7 INDIVIDUALS, OR ENTITY THAT HAS APPLIED TO THE IDA TO HAVE A  
8 COMMUNITY OR OTHER PLACE CERTIFIED BY THE IDA AS A DESIGNATED  
9 DARK SKY PLACE AND THAT APPLIES FOR A GRANT.

10 (c) "COLORADO CHAPTER OF THE IDA" MEANS A COLORADO  
11 SINGLE MEMBER LIMITED LIABILITY COMPANY THAT HAS THE IDA AS ITS  
12 SOLE MEMBER RELATIONSHIP.

13 (d) "DESIGNATED DARK SKY PLACE" MEANS A PLACE IN COLORADO  
14 THAT IS CERTIFIED BY THE IDA THROUGH THE IDSP PROGRAM AS AN  
15 INTERNATIONAL DARK SKY COMMUNITY, INTERNATIONAL DARK SKY PARK,  
16 INTERNATIONAL DARK SKY RESERVE, INTERNATIONAL DARK SKY  
17 SANCTUARY, OR URBAN NIGHT SKY PLACE.

18 (e) "IDA TECHNICAL ASSISTANCE" MEANS ASSISTANCE PROVIDED  
19 BY THE IDA TO AN APPLICANT FOR THE PURPOSE OF HELPING THE  
20 APPLICANT SATISFY THE REQUIREMENTS FOR THE CERTIFICATION BY THE  
21 IDA OF A COMMUNITY OR PLACE AS A DESIGNATED DARK SKY PLACE.

22 (f) "PROGRAM" MEANS THE COLORADO DARK SKY DESIGNATION  
23 TECHNICAL ASSISTANCE GRANT PROGRAM ESTABLISHED BY THE OFFICE AS  
24 REQUIRED BY SUBSECTION (3) OF THIS SECTION.

25 (g) "TECHNICAL ASSISTANCE GRANT" OR "GRANT" MEANS AN  
26 AWARD MADE BY THE OFFICE TO AN APPLICANT TO PAY FOR IDA  
27 TECHNICAL ASSISTANCE IN ACCORDANCE WITH THE REQUIREMENTS OF

1 THIS SECTION AND THE POLICIES ESTABLISHED BY THE OFFICE PURSUANT  
2 TO SUBSECTION (3) OF THIS SECTION.

3 (3) (a) THE OFFICE SHALL ESTABLISH THE COLORADO DARK SKY  
4 DESIGNATION TECHNICAL ASSISTANCE GRANT PROGRAM IN ACCORDANCE  
5 WITH THE REQUIREMENTS OF THIS SECTION AND THE POLICIES THAT THE  
6 OFFICE ESTABLISHES PURSUANT TO THIS SUBSECTION (3). THE PROGRAM  
7 MAY PROVIDE TECHNICAL ASSISTANCE GRANTS FROM THE ADDITIONAL  
8 SOURCE FUND TO APPLICANTS. THE OFFICE SHALL ESTABLISH POLICIES FOR  
9 THE PROGRAM INCLUDING POLICIES THAT GOVERN THE GRANT  
10 APPLICATION PROCESS AND REQUIRE APPLICANTS TO DEMONSTRATE  
11 COMMUNITY AND STAKEHOLDER SUPPORT, AS DEFINED IN THE POLICIES,  
12 FOR THE DESIGNATED DARK SKY PLACE APPLICATION FOR THE COMMUNITY  
13 OR OTHER PLACE TO WHICH THE GRANT APPLICATION PERTAINS. THE  
14 OFFICE MAY CONTRACT WITH THE IDA AND THE COLORADO CHAPTER OF  
15 THE IDA TO HELP THE OFFICE DEVELOP ITS PROGRAM POLICIES, EVALUATE  
16 GRANT APPLICATIONS, AND MAKE RECOMMENDATIONS TO THE OFFICE  
17 REGARDING WHICH APPLICANTS SHOULD RECEIVE GRANT AWARDS AND  
18 WHAT THE AMOUNT OF EACH AWARD SHOULD BE.

19 (b) THE OFFICE, ON ITS OWN, IN CONSULTATION WITH THE IDA AND  
20 THE COLORADO CHAPTER OF THE IDA, OR BY CONTRACTING WITH THE  
21 IDA AND THE COLORADO CHAPTER OF THE IDA, SHALL PROVIDE GENERAL  
22 EDUCATION AND OUTREACH ABOUT DARK SKIES AND SPECIFICALLY  
23 PROMOTE RESPONSIBLE AND SUSTAINABLE TOURISM OPPORTUNITIES IN  
24 DESIGNATED DARK SKY PLACES IN THE STATE.

25 (4) ON JULY 1, 2022, THE STATE TREASURER SHALL TRANSFER  
26 THIRTY-FIVE THOUSAND DOLLARS FROM THE GENERAL FUND TO THE  
27 ADDITIONAL SOURCE FUND. NOTWITHSTANDING SECTION 24-49.7-106

1 (3)(b), THE OFFICE SHALL SPEND THIS MONEY, WHICH IS CONTINUOUSLY  
2 APPROPRIATED TO THE OFFICE, ONLY:

3 (a) TO MAKE TECHNICAL ASSISTANCE GRANTS;

4 (b) IF THE OFFICE CONTRACTS WITH THE IDA AND THE COLORADO  
5 CHAPTER OF THE IDA AS AUTHORIZED BY SUBSECTION (3) OF THIS  
6 SECTION, TO PAY THE IDA AND THE COLORADO CHAPTER OF THE IDA IN  
7 ACCORDANCE WITH THE TERMS OF THE CONTRACT TO:

8 (I) ASSIST IN ADMINISTERING THE GRANT PROGRAM;

9 (II) PROVIDE GENERAL EDUCATION ABOUT AND PROMOTE GENERAL  
10 AWARENESS OF THE BENEFITS OF PRESERVING AND EXPANDING DARK SKY  
11 PLACES AND THE IMPORTANCE OF USING BEST STEWARDSHIP PRACTICES  
12 WHEN MANAGING ACCESS TO DARK SKY PLACES; AND

13 (III) SPECIFICALLY PROMOTE RESPONSIBLE AND SUSTAINABLE  
14 TOURISM OPPORTUNITIES IN DESIGNATED DARK SKY PLACES IN THE STATE;  
15 AND

16 (c) TO COVER THE OFFICE'S DIRECT AND INDIRECT COSTS OF  
17 ADMINISTERING AND IMPLEMENTING THE PROGRAM.

18 (5) ON OR BEFORE NOVEMBER 1, 2023, THE OFFICE SHALL SUBMIT  
19 A REPORT DETAILING THE EXPENDITURE OF THE MONEY TRANSFERRED TO  
20 THE ADDITIONAL SOURCE FUND PURSUANT TO SUBSECTION (4) OF THIS  
21 SECTION TO THE HOUSE OF REPRESENTATIVES BUSINESS AFFAIRS AND  
22 LABOR COMMITTEE AND THE SENATE BUSINESS, LABOR, AND TECHNOLOGY  
23 COMMITTEE, OR THEIR SUCCESSOR COMMITTEES. THE REPORT SHALL  
24 SPECIFY THE GRANT-SUPPORTED ACTIONS TAKEN IN FURTHERANCE OF  
25 DESIGNATING NEW DARK SKY PLACES AND INDICATE HOW MANY GRANT  
26 RECIPIENTS HAVE OPENED AND MAINTAINED AN ACTIVE CASE FILE WITH  
27 THE IDA OR HAVE HAD A COMMUNITY OR OTHER PLACE CERTIFIED BY THE

1     **IDA** AS A DESIGNATED DARK SKY PLACE.

2             **SECTION 2. Safety clause.** The general assembly hereby finds,  
3 determines, and declares that this act is necessary for the immediate  
4 preservation of the public peace, health, or safety.
