l	WHEREAS, Our respected former colleague, Joe Nuñez, a past
2	member of the Colorado General Assembly, departed this life on
3	November 16, 2020; and
4	WHEREAS, Representative Nuñez was born April 5, 1937, in
5	Greeley, Colorado, to Manuela Nuñez and Concepción Lopez; and
6	WHEREAS, Representative Nuñez was a Vietnam veteran who
7	served our nation in the United States Air Force and retired at the rank of
8	Lieutenant Colonel from his last duty assignment at F. E. Warren Air
9	Force Base in Cheyenne, Wyoming; and
10	WHEREAS, Representative Nuñez received the Bronze Star, the
11	Meritorious Service Medal with one Oak Leaf Cluster, the Republic of
12	Vietnam Campaign Medal, and the Republic of Vietnam Gallantry Cross
13	with palm; and
14	WHEREAS, In 1998, Representative Nuñez ran for and was
15	elected to the Colorado House of Representatives for House District 64

1	and in 2000 he ran again and was reelected; and
2 3 4 5 6	WHEREAS, During his three years serving as a member of the House of Representatives, Representative Nuñez served on the Transportation and Energy, Appropriations, and Education Committees and as Vice-chair for the State, Veterans, and Military Affairs Committee; and
7 8 9 10	WHEREAS, Representative Nuñez also served as the representative for Secretary of the United States Department of Labor for the Rocky Mountain Region and as the Regional Director for the United States Department of Health and Human Services; and
11 12 13 14 15	WHEREAS, Representative Nuñez was preceded in death by his wife of 59 years, Lilly Yanas Nuñez, on November 10, 2020, and is survived by his four children John Michael Nuñez, Daniel Nuñez, Teresa Curtis, and Lili Nuñez Mueh, ten grandchildren, and three great-grandchildren; and
