A BILL FOR AN ACT

101	CONCERNING THE CREATION OF A NAVIGATOR PROGRAM TO PROMOTE
102	APPRENTICESHIPS TO HIGH SCHOOL STUDENTS, AND, IN
103	CONNECTION THEREWITH, MAKING AN APPROPRIATION.

Bill Summary

The bill directs the office of future of work (office) in the department of labor and employment to create an apprenticeship navigator pilot program (program) with 2 full-time apprenticeship navigators, with each apprenticeship navigator assigned to a different school district selected by the office. The purpose of the program is to

increase awareness of registered apprenticeship programs among graduating high school students in the selected school districts.

The bill also directs the office to promote apprenticeship programs to high school students by creating and maintaining a web-based job board of apprenticeships and incorporating apprenticeships in the state's career planning tools.

24	(3) THE NAVIGATORS SHALL:

2	JANUARY 1, 2027.

4	SECTION 2. In Colorado Revised Statutes, 22-2-136, amend (1)
5	as follows:
6	22-2-136. Additional duty - state board - individual career and
7	academic plans - standards - rules. (1) (a) On or before February 1,
8	2010, The state board shall promulgate rules pursuant to the "State
9	Administrative Procedure Act", article 4 of title 24, to establish standards
10	for individual career and academic plans for students enrolled in the
11	public schools in the state.
12	(b) An individual career and academic plan must be designed to
13	assist a student and the student's parent or legal guardian in exploring the
14	postsecondary career and educational opportunities available to the
15	student, INCLUDING APPRENTICESHIP PROGRAMS REGISTERED THROUGH
16	THE UNITED STATES DEPARTMENT OF LABOR'S OFFICE OF APPRENTICESHIP
17	OR A STATE APPRENTICESHIP AGENCY RECOGNIZED BY THAT OFFICE;
18	aligning course work and curriculum; applying to postsecondary
19	education institutions; securing financial aid; and ultimately entering the
20	workforce. As part of the process of establishing the individual career and
21	academic plan, the student and the student's parents must be made aware
22	of the importance of completing the free application for federal student
23	aid or the Colorado application for state financial aid, or successor forms
24	for accessing federal and state financial aid, and be provided help in
25	completing the forms, if requested.
26	SECTION 3. Appropriation. (1) For the 2023-24 state fiscal
27	year, \$342,638 is appropriated to the department of labor and employment

for use by the executive director's office. This appropriation is from the general fund. To implement this act, the department may use this appropriation for the office of future work, which amount is based on an assumption that the office will require an additional 1.9 FTE. Any money appropriated in this section not expended prior to July 1, 2024, is further appropriated to the department for the 2024-25 state fiscal year for the same purpose.

(2) For the 2023-24 state fiscal year, \$44,000 is appropriated to the department of education. This appropriation is from the general fund. To implement this act, the department may use this appropriation for preschool to postsecondary education alignment. Any money appropriated in this section not expended prior to July 1, 2024, is further appropriated to the department for the 2024-25 state fiscal year for the same purpose.

SECTION 4. Act subject to petition - effective date. This act takes effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly; except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part will not take effect unless approved by the people at the general election to be held in November 2024 and, in such case, will take effect on the date of the official declaration of the vote thereon by the governor.
