# **Bill Summary**

The bill requires the Colorado department of public health and environment (department) to distribute stop the bleed training materials and bleed control kits to K-12 schools that opt into receiving them. The bill also requires the department, in collaboration with the American college of surgeons' committee on trauma, to report the number of schools

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, add part 14 to article
3	3.5 of title 25 as follows:

5	STOP THE BLEED SCHOOL CONTROL KITS
6	25-3.5-1401. Stop the bleed school kits - report - definitions
7	- repeal. (1) The department shall distribute stop the bleed
8	CONTROL KITS TO EACH SCHOOL THAT CHOOSES TO ADMINISTER STOP THE
9	BLEED TRAINING.
10	(2) For each of the 2023-24, 2024-25, and 2025-26 state
11	FISCAL YEARS, THE GENERAL ASSEMBLY SHALL APPROPRIATE ONE
12	HUNDRED FIFTY THOUSAND DOLLARS TO THE DEPARTMENT FOR THE
13	PURPOSE OF PURCHASING AND DISTRIBUTING STOP THE BLEED CONTROL
14	KITS TO HIGH SCHOOLS, MIDDLE SCHOOLS, AND ELEMENTARY SCHOOLS.
15	Any unexpended money remaining at the end of the $2023-24$ and
16	2024-25 STATE FISCAL YEARS FROM THIS APPROPRIATION:
17	(a) Does not revert to the general fund or any other
18	FUND;
19	(b) May be used by the department in the 2024-25 and
20	2025-26 STATE FISCAL YEARS WITHOUT FURTHER APPROPRIATION; AND
21	(c) MUST NOT BE USED FOR ANY OTHER PURPOSE OTHER THAN THE
22	PURPOSE SET FORTH IN THIS SECTION.
23	(d) THE DEPARTMENT SHALL PROVIDE EACH SCHOOL WITH ITS
24	ALLOTMENT OF BLEED CONTROL KITS AFTER A SCHOOL HAS HELD A STOP

2	(3) THE DEPARTMENT SHALL DISTRIBUTE BLEED CONTROL KITS
3	ACCORDING TO THE FOLLOWING:
4	(a) SCHOOLS WITH A POPULATION OF OVER ONE THOUSAND
5	STUDENTS THAT OPT IN RECEIVE TEN BLEED CONTROL KITS;
6	(b) SCHOOLS WITH A POPULATION BETWEEN FIVE HUNDRED AND
7	ONE THOUSAND STUDENTS THAT OPT IN RECEIVE FIVE BLEED CONTROL
8	KITS; AND
9	(c) SCHOOLS WITH A POPULATION OF LESS THAN FIVE HUNDRED
10	STUDENTS THAT OPT IN RECEIVE THREE BLEED CONTROL KITS.
11	(4) On or before July 1, 2024, and on or before July 1 each
12	YEAR THEREAFTER THROUGH JULY 1, 2026, THE DEPARTMENT SHALL
13	COLLABORATE WITH THE AMERICAN COLLEGE OF SURGEONS' COMMITTEE
14	ON TRAUMA TO SUBMIT A REPORT TO THE HEALTH AND HUMAN SERVICES
15	COMMITTEE OF THE SENATE AND THE PUBLIC AND BEHAVIORAL HEALTH
16	AND HUMAN SERVICES COMMITTEE OF THE HOUSE OF REPRESENTATIVES,
17	OR ANY SUCCESSOR COMMITTEES, AND TO THE GOVERNOR ON THE
18	DISTRIBUTION OF STOP THE BLEED CONTROL KITS. AT A MINIMUM, THE
19	REPORT MUST INCLUDE:
20	(a) THE TOTAL NUMBER OF SCHOOLS THAT OPTED IN TO RECEIVE
21	STOP THE BLEED CONTROL KITS;
22	(b) THE TOTAL NUMBER OF PEOPLE IN SCHOOLS WHO HAVE BEEN
23	TRAINED IN STOP THE BLEED;
24	(c) THE TOTAL NUMBER OF STOP THE BLEED CONTROL KITS THAT
25	HAVE BEEN SENT TO SCHOOLS; AND
26	(d) The total cost of distributing the stop the bleed
27	CONTROL KITS.

1	(5) Any contract or agreement that the department
2	ENTERS INTO IN FURTHERANCE OF THIS SECTION IS EXEMPT FROM THE
3	REQUIREMENTS OF THE "PROCUREMENT CODE", ARTICLES 101 TO 112 OF

5	(6) As used in this section:
6	(a) "BLEED CONTROL" MEANS ACTIONS THAT CONTROL BLEEDING
7	FROM A PERSON WHO HAS SUFFERED A TRAUMATIC INJURY.
8	(b) "Bleed control kit" means a first aid response kit
9	DEVELOPED BY STOP THE BLEED THAT CONTAINS:
10	(I) One tourniquet endorsed by the United States
11	DEPARTMENT OF DEFENSE COMMITTEE ON TACTICAL COMBAT CASUALTY
12	CARE;
13	(II) ONE COMPRESSION BANDAGE;
14	(III) ONE BLEEDING CONTROL BANDAGE;
15	(IV) PROTECTIVE GLOVES;
16	(V) ONE MARKER; AND
17	(VI) ONE PAIR OF SCISSORS.
18	
19	(c) "SCHOOL" MEANS A PUBLIC SCHOOL, SCHOOL DISTRICT, BOARD
20	OF COOPERATIVE SERVICES, CHARTER SCHOOL, OR INSTITUTE CHARTER
21	SCHOOL.
22	(d) "STOP THE BLEED" MEANS THE AMERICAN COLLEGE OF
23	SURGEONS' STOP THE BLEED PROGRAM THAT IS ADMINISTERED BY THE
24	AMERICAN COLLEGE OF SURGEONS' COMMITTEE ON TRAUMA.
25	(7) This section is repealed, effective July 1, 2026.
26	<b>SECTION 2.</b> Appropriation. (1) For the 2023-24 state fiscal
27	year, \$155,541 is appropriated to the department of public health and

1	environment for use by the health facilities and emergency medical
2	services division. This appropriation is from the general fund and is based
3	on an assumption that the division will require an additional 0.1 FTE. To
4	implement this act, the division may use this appropriation for
5	administration and operations related to operations management. Any
6	money appropriated in this section not expended prior to July 1, 2024, is
7	further appropriated to the department for the 2024-25 and 2025-26 fiscal
8	years for the same purpose.
9	<b>SECTION 3.</b> Safety clause. The general assembly hereby finds,
10	determines, and declares that this act is necessary for the immediate
11	preservation of the public peace, health, or safety.
