**A BILL FOR AN ACT**

101      **CONCERNING TRANSPARENCY REQUIREMENTS FOR HOSPITALS, AND, IN**  
102            **CONNECTION THEREWITH, CREATING MORE TIMELY**  
103            **SUBMISSIONS OF DATA; PROVIDING INSIGHTS INTO TRANSFERS**  
104            **OF CASH AND PROFITS AND RESERVES, INCLUDING THOSE**  
105            **LEAVING COLORADO; REPORTING ON ALL INFORMATION**  
106            **RECEIVED; REPORTING INFORMATION BY EACH HOSPITAL IN**  
107            **ADDITION TO HEALTH SYSTEMS; DISCLOSING EXECUTIVE**  
108            **COMPENSATION, INCLUDING COMPENSATED INCENTIVES;**

Current law requires the department of health care policy and financing (state department) to annually prepare a written hospital expenditure report. The bill changes the name of the report to the hospital transparency report (transparency report).

The bill adds specified information that each hospital shall report to the state department for the transparency report.

No later than July 1, 2024, the bill requires each hospital to provide specified information to the state department for previous fiscal years.

The bill authorizes the state department to impose certain enforcement mechanisms against a hospital that does not provide all of the information required to be reported to the state department.

Beginning July 1, 2024, the bill requires any patient bill to include a clear, plain language description of the services the patient is being billed for and a statement that the patient has a right to receive a detailed explanation of the services charged and who to contact to receive such information.

2           **SECTION 1.** In Colorado Revised Statutes, 25.5-4-402.8, **amend**  
3 (2)(a), (2)(b) introductory portion, (2)(b)(II)(A), (2)(b)(III)(J),  
4 (2)(b)(III)(M), (2)(c) introductory portion, (2)(e), (3) introductory portion,  
5 (4)(a) introductory portion (4)(a)(I),, and (4)(b); **repeal** (2)(d); and **add**  
6 (2)(b)(II)(D), (2)(b)(II)(E), (2)(b)(II)(F), (2)(b)(III)(O), (2)(b)(III)(P),  
7 (2)(b)(III)(Q), (2)(b)(IV), (2)(b.5), (2)(g), and (4.5) as follows:

8           **25.5-4-402.8. Hospital transparency report - definitions.**

9 (2) (a) The state department shall annually prepare a written hospital  
10 ~~expenditure~~ TRANSPARENCY report detailing ~~uncompensated~~ hospital  
11 costs, INCLUDING UNCOMPENSATED CARE COSTS, and the different  
12 categories of expenditures, by major payer group, made by hospitals in

1 the state. The state department shall COORDINATE THE ANALYSIS, REVIEW,  
2 AND RELEASE OF THE HOSPITAL TRANSPARENCY REPORT AND THE REPORTS  
3 REQUIRED PURSUANT TO SECTION 25.5-1-703 (3) AND 25.5-4-402.4 (7)(e),  
4 INCLUDING THE OPPORTUNITY TO REVIEW AND consult ~~with~~ ON THE  
5 REPORTS MADE BY the Colorado healthcare affordability and sustainability  
6 enterprise board, created pursuant to section 25.5-4-402.4 (7) and referred  
7 to in this section as the "enterprise board". ~~in developing the hospital~~

2 (b) Except as provided in subsection (2)(c) of this section, each

4 pursuant to section 25-1.5-103 (1)(a)(II), shall make information available  
5 to the state department for purposes of preparing the annual hospital  
6 expenditure TRANSPARENCY report. The state board shall establish the  
7 format of the information provided by each hospital on an annual basis.  
8 ~~The first submission by each hospital must include the information~~  
9 ~~described in subsections (2)(b)(I) and (2)(b)(II) of this section for fiscal~~

4 PROJECTS AND CAPITAL INVESTMENTS GREATER THAN TWENTY-FIVE  
5 MILLION DOLLARS; EXCEPT THAT THE INFORMATION THE STATE  
6 DEPARTMENT RECEIVES FROM HOSPITALS REGARDING PLANNED ACTIVITIES  
7 IS CONFIDENTIAL, PROPRIETARY, CONTAINS TRADE SECRETS, AND IS NOT  
8 A PUBLIC RECORD PURSUANT TO PART 2 OF ARTICLE 72 OF TITLE 24.

9 (III) A report that contains the following information:

10 (J) Other operating revenue, operating margin, nonoperating gains  
11 and losses, GROSS REVENUE, NET PROFIT, and total margin;

12 (M) A roll forward of property, plant, and equipment accounts by  
13 asset type from the beginning to the end of the reporting period by asset  
14 category, including, but not limited to, purchases, other acquisitions,  
15 sales, disposals, and other changes; ~~and~~

16 (O) INFORMATION ON CURRENT AFFILIATIONS AND A REPORT OF  
17 PHYSICIAN PRACTICE ACQUISITIONS;

18 (P) SALARY AND TOTAL COMPENSATION DATA OF THE TOP FIVE  
19 HIGHEST PAID ADMINISTRATIVE POSITIONS OF EACH NONPROFIT HOSPITAL,  
20 INCLUDING THE TITLE, A BRIEF DESCRIPTION OF DUTIES, BASE  
21 COMPENSATION, INCENTIVE OR BONUS COMPENSATION, AND OTHER  
22 COMPENSATION. THE COMPENSATION REPORTED MUST INDICATE WHAT  
23 PERFORMANCE MEASURES WERE INCLUDED IN THE CHIEF EXECUTIVE  
24 OFFICER'S PERFORMANCE EVALUATION GENERATED BY THE HOSPITAL'S  
25 GOVERNING BOARD, INCLUDING, AT A MINIMUM, QUALITY OF CARE  
26 OUTCOMES PERFORMANCE; PATIENT SATISFACTION PERFORMANCE;  
27 COMMUNITY BENEFIT PERFORMANCE; CONSUMER AND EMPLOYER

1 AFFORDABILITY PERFORMANCE; MARKET SHARE PERFORMANCE; PROFITS  
2 OR MARGINS; REVENUE GROWTH; CHANGE IN DAYS CASH ON HAND OR  
3 CASH RESERVES; AND WORKFORCE. THE STATE DEPARTMENT MAY  
4 INCLUDE INFORMATION IT RECEIVES FROM PUBLIC HOSPITALS PURSUANT  
5 TO THIS SUBSECTION (2)(b)(III)(P) THAT IS NOT OTHERWISE PUBLICLY  
6 AVAILABLE IN THE HOSPITAL TRANSPARENCY REPORT; EXCEPT THAT  
7 INFORMATION THE STATE DEPARTMENT RECEIVES FROM A NONPROFIT  
8 HOSPITAL IS NOT A PUBLIC RECORD PURSUANT TO PART 2 OF ARTICLE 72 OF  
9 TITLE 24. THE STATE DEPARTMENT MAY ONLY REPORT INFORMATION  
10 RECEIVED PURSUANT TO THIS SUBSECTION (2)(b)(III)(P) IN AN  
11 AGGREGATED FORMAT THAT DOES NOT NAME INDIVIDUAL HOSPITALS OR  
12 ADMINISTRATORS.

13 (Q) IN A FORM AND MANNER SPECIFIED BY THE STATE  
14 DEPARTMENT, DETAILS OF SIGNIFICANT OTHER REVENUE THAT WOULD  
15 OTHERWISE BE REPORTED IN THE MEDICARE COST REPORT.

16 (IV) IN A FORM AND MANNER SPECIFIED BY THE STATE  
17 DEPARTMENT, A QUARTERLY FINANCIAL REPORT THAT INCLUDES AN  
18 INCOME STATEMENT, BALANCE SHEET, AND STATEMENT OF CASH FLOWS  
19 IF THE HOSPITAL IS OWNED OR AFFILIATED WITH A HOSPITAL SYSTEM THAT  
20 IS COMPRISED OF THREE OR MORE HOSPITALS OR THAT HAS MORE THAN  
21 ONE BILLION DOLLARS IN RESERVES, AND FOR ALL OTHER HOSPITALS, A  
22 QUARTERLY FINANCIAL REPORT THAT INCLUDES AN INCOME STATEMENT  
23 AND BALANCE SHEET. THE QUARTERLY FINANCIAL REPORT MUST BE  
24 REPORTED NO LATER THAN SIXTY DAYS AFTER THE END OF EACH QUARTER.

25 (b.5) NO LATER THAN JULY 1, 2024, EACH HOSPITAL SHALL  
26 PROVIDE THE FOLLOWING INFORMATION TO THE STATE DEPARTMENT:

27 (I) FOR EACH FISCAL YEAR 2014-15 THROUGH 2019-20, A LIST OF

1 THE HOSPITAL'S TRANSFERS OF CASH, INVESTMENTS, OR OTHER ASSETS TO  
2 RELATED PARTIES, INCLUDING BUT NOT LIMITED TO THE HOSPITAL'S  
3 PARENT ORGANIZATION AND THE REASON FOR THE TRANSFER. THE LIST  
4 MUST INDICATE IF THE CASH, INVESTMENTS, OR OTHER ASSETS WERE  
5 TRANSFERRED TO ENTITIES OUTSIDE OF COLORADO.

6 (II) FOR EACH FISCAL YEAR FROM 2014-15 THROUGH 2019-20,  
7 INFORMATION ON AFFILIATIONS AND A REPORT OF PHYSICIAN PRACTICE  
8 ACQUISITIONS; AND

9 (III) FOR EACH FISCAL YEAR FROM 2019-20 THROUGH 2022-23, IN  
10 A FORM AND MANNER SPECIFIED BY THE STATE DEPARTMENT, DETAILS OF  
11 SIGNIFICANT OTHER REVENUE THAT WOULD OTHERWISE BE REPORTED IN  
12 THE MEDICARE COST REPORT.

13 (c) The state department may exempt from ~~the~~ CERTAIN reporting  
14 requirements described in ~~subsection~~ SUBSECTIONS (2)(b) AND (2)(b.5) of  
15 this section certain types of hospitals, including but not limited to:

16 ~~(d) Prior to developing the first annual hospital expenditure report,~~  
17 ~~the state department shall consult with the enterprise board regarding the~~  
18 ~~development of the report. The state department shall strive for~~  
19 ~~consistency in reporting the components in each annual report with those~~  
20 ~~in the report of the enterprise board required pursuant to section~~

22 (e) Prior to issuing the hospital ~~expenditure~~ TRANSPARENCY  
23 report, the state department shall provide any hospital referenced in the  
24 hospital ~~expenditure~~ TRANSPARENCY report a copy of the report. Each  
25 hospital ~~shall~~ MUST have a minimum of fifteen days to review the hospital  
26 ~~expenditure~~ TRANSPARENCY report and any underlying data and submit  
27 corrections or clarifications to the state department.

1 (g) (I) IF A HOSPITAL DOES NOT PROVIDE ALL OF THE INFORMATION  
2 REQUIRED PURSUANT TO SUBSECTION (2)(b) OF THIS SECTION, THE STATE  
3 DEPARTMENT SHALL INFORM THE HOSPITAL OF ITS NONCOMPLIANCE  
4 WITHIN SIXTY DAYS AND IDENTIFY THE INFORMATION THAT NEEDS TO BE  
5 PROVIDED. IF A HOSPITAL DOES NOT COMPLY, THE STATE DEPARTMENT  
6 SHALL ISSUE A CORRECTIVE ACTION PLAN WITH A TIMELINE OF SIXTY DAYS  
7 REQUIRED FOR COMPLIANCE. IF A HOSPITAL CONTINUES TO NOT COMPLY,  
8 THE STATE DEPARTMENT MAY CREATE A MANDATORY  
9 PAY-FOR-REPORTING COMPLIANCE MEASURE WITHIN THE HOSPITAL  
10 TRANSFORMATION PROGRAM THAT IS TIED TO THE HEALTHCARE  
11 AFFORDABILITY AND SUSTAINABILITY FEE SUPPLEMENTAL PAYMENT AND  
12 IS BASED ON COMPLIANCE WITH SUBSECTION (2)(b) OF THIS SECTION.

13 (II) IF THE STATE DEPARTMENT DETERMINES A HOSPITAL'S  
14 NONCOMPLIANCE WITH THIS SECTION IS KNOWING OR WILLFUL OR THERE  
15 IS A REPEATED PATTERN OF NONCOMPLIANCE, THE STATE DEPARTMENT  
16 SHALL CONSIDER THE SIZE OF THE HOSPITAL AND THE SERIOUSNESS OF THE  
17 VIOLATION IN SETTING A FINE AMOUNT WHICH, FOR HOSPITALS OWNED OR  
18 AFFILIATED WITH A HOSPITAL SYSTEM COMPRISED OF THREE OR MORE  
19 HOSPITALS, MUST NOT EXCEED TWENTY THOUSAND DOLLARS PER  
20 VIOLATION PER WEEK UNTIL THE HOSPITAL TAKES CORRECTIVE AND, FOR  
21 ALL OTHER HOSPITALS, MUST NOT EXCEED FIVE THOUSAND DOLLARS PER  
22 WEEK UNTIL THE HOSPITAL TAKES CORRECTIVE ACTION.

23 (3) The hospital ~~expenditure~~ TRANSPARENCY report must include,  
24 but not be limited to:

25 (4) (a) On or before January 15, 2020, and on or before January  
26 15 each year thereafter, the state department shall submit the annual  
27 hospital ~~expenditure~~ TRANSPARENCY report to:



1 (I) The ~~public health care and human services committee of the~~  
2 ~~house of representatives HEALTH AND INSURANCE COMMITTEE AND THE~~  
3 ~~HOUSE OF REPRESENTATIVES PUBLIC AND BEHAVIORAL HEALTH AND~~  
4 ~~HUMAN SERVICES COMMITTEE, or any successor committee;~~

5 (b) The state department may request that the enterprise board  
6 combine the hospital ~~expenditure~~ TRANSPARENCY report described in this  
7 section with the report of the enterprise board specified in section  
8 25.5-4-402.4 (7)(e), so long as the specific requirements of this section  
9 are fulfilled, and so long as the enterprise board agrees to the request. The  
10 state department shall post the annual report on its website by January 15  
11 of each year.

12 (4.5) THE STATE DEPARTMENT SHALL REPORT ON THE ANNUAL  
13 HOSPITAL TRANSPARENCY REPORT DURING THE STATE DEPARTMENT'S  
14 "SMART ACT" HEARING.

15 **SECTION 2.** In Colorado Revised Statutes, **add** 25.5-4-427 as  
16 follows:

17 **25.5-4-427. Hospital and provider billing requirements -**  
18 **description of service provided - rules.** (1) BEGINNING JULY 1, 2024,  
19 ANY PATIENT BILL FOR SERVICES RENDERED MUST FOLLOW INDUSTRY  
20 STANDARD BILLING PRACTICES, INCLUDING, AT A MINIMUM, THE DATE OF  
21 SERVICE, THE PATIENT'S NAME, THE PROVIDER'S NAME, A DESCRIPTION OF  
22 THE SERVICES PROVIDED, AND THE CHARGES FOR EACH SERVICE.

23 **SECTION 3. Act subject to petition - effective date.** This act  
24 takes effect at 12:01 a.m. on the day following the expiration of the  
25 ninety-day period after final adjournment of the general assembly; except  
26 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
27 of the state constitution against this act or an item, section, or part of this

1 act within such period, then the act, item, section, or part will not take  
2 effect unless approved by the people at the general election to be held in  
3 November 2024 and, in such case, will take effect on the date of the  
4 official declaration of the vote thereon by the governor.
