A BILL FOR AN ACT

101 CONCERNING CREATING A TASK FORCE TO STUDY THE STATEWIDE
102 **K-12** EDUCATION ACCOUNTABILITY SYSTEM IN ORDER TO
103 ADDRESS RESOURCE INEQUITIES CONTRIBUTING TO STUDENT
104 PERFORMANCE.

Bill Summary

The bill creates the accountability, accreditation, student performance, and resource inequity task force (task force) to study academic opportunities, inequities, promising practices in schools, and

improvements to the accountability and accreditation system.

The bill requires the speaker and minority leader of the house of representatives, the president and minority leader of the senate, the governor, and the department of education (department) to appoint members to the task force no later than July 1, 2023. The task force consists of 25 members, including members who represent statewide education organizations, the department, the state board of education (state board), school district board of education members, superintendents, principals, and teachers.

The bill requires the department to enter into a contract with a facilitator to guide the work of the task force no later than August 15, 2023. The facilitator shall draft an interim report and final report.

The task force is required to submit an interim report by March 1, 2024, and a final report by November 15, 2024, reflecting its findings and recommendations to the education committees of the house of representatives and senate, the governor, the state board, the commissioner of education, and the department.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** part 21 to article
3 2 of title 2 as follows:

5 **ACCOUNTABILITY, ACCREDITATION,**
6 **STUDENT PERFORMANCE, AND RESOURCE INEQUITY**
7 **TASK FORCE**

8 **2-2-2101. Definitions.** AS USED IN THIS PART 21, UNLESS THE
9 CONTEXT OTHERWISE REQUIRES:

10 (1) "DEPARTMENT" MEANS THE DEPARTMENT OF EDUCATION
11 CREATED AND EXISTING PURSUANT TO SECTION 24-1-115.

12 (2) "RURAL SCHOOL DISTRICT" MEANS A SCHOOL DISTRICT IN
13 COLORADO THAT THE DEPARTMENT DETERMINES IS RURAL BASED ON THE
14 GEOGRAPHIC SIZE OF THE SCHOOL DISTRICT AND THE DISTANCE OF THE
15 SCHOOL DISTRICT FROM THE NEAREST LARGE, URBANIZED AREA, AND THE
16 TOTAL STUDENT ENROLLMENT OF THE SCHOOL DISTRICT IS SIX THOUSAND

1 FIVE HUNDRED OR FEWER STUDENTS.

2 (3) "STATE BOARD" MEANS THE STATE BOARD OF EDUCATION
3 CREATED AND EXISTING PURSUANT TO SECTION 1 OF ARTICLE IX OF THE
4 STATE CONSTITUTION.

5 (4) "STATEWIDE EDUCATION ACCOUNTABILITY AND
6 ACCREDITATION SYSTEM" MEANS THE SYSTEM FOR ACCREDITING SCHOOLS
7 AND SCHOOL DISTRICTS DESCRIBED IN ARTICLE 11 OF TITLE 22 AND AS
8 IMPLEMENTED BY RULES ADOPTED BY THE STATE BOARD.

9 (5) "TASK FORCE" MEANS THE ACCOUNTABILITY, ACCREDITATION,
10 STUDENT PERFORMANCE, AND RESOURCE INEQUITY TASK FORCE CREATED
11 IN SECTION 2-2-2102.

12 (6) "URBAN SCHOOL DISTRICT" MEANS A SCHOOL DISTRICT THAT
13 THE DEPARTMENT DOES NOT CONSIDER A RURAL OR SMALL RURAL SCHOOL
14 DISTRICT.

15 **2-2-2102. Accountability, accreditation, student performance,**
16 **and resource inequity task force - appointments - meetings.**

17 (1) THERE IS CREATED THE ACCOUNTABILITY, ACCREDITATION, STUDENT
18 PERFORMANCE, AND RESOURCE INEQUITY TASK FORCE TO STUDY
19 ACADEMIC OPPORTUNITIES, INEQUITIES, PROMISING PRACTICES IN
20 SCHOOLS, AND IMPROVEMENTS TO THE ACCOUNTABILITY AND
21 ACCREDITATION SYSTEM.

22 (2) THE TASK FORCE MEMBERS MUST BE APPOINTED ON OR BEFORE
23 JULY 1, 2023. FOLLOWING THE APPOINTMENT OF THE TASK FORCE
24 MEMBERS PURSUANT TO THIS SUBSECTION (2), THE SPEAKER OF THE HOUSE
25 OF REPRESENTATIVES SHALL APPOINT THE CHAIRPERSON, AND THE
26 PRESIDENT OF THE SENATE SHALL APPOINT THE VICE-CHAIRPERSON. THE
27 TASK FORCE CONSISTS OF TWENTY-FIVE MEMBERS, AND TASK FORCE

1 MEMBERS ARE APPOINTED AS FOLLOWS:

2 (a) THE SPEAKER OF THE HOUSE OF REPRESENTATIVES SHALL
3 APPOINT THE FOLLOWING MEMBERS:

4 (I) ONE SCHOOL DISTRICT SUPERINTENDENT WHO HAS EXPERTISE
5 WITH THE EDUCATION ACCOUNTABILITY SYSTEM;

6 (II) ONE SCHOOL DISTRICT SUPERINTENDENT WHO HAS EXPERIENCE
7 AS A SCHOOL DISTRICT SUPERINTENDENT IN COLORADO PUBLIC SCHOOLS
8 OR AS A CHARTER SCHOOL NETWORK LEADER, FORMED PURSUANT TO
9 SECTION 22-30.5-104.7;

10 (III) ONE REPRESENTATIVE OF A STATEWIDE PARENT
11 ORGANIZATION THAT FOCUSES ON EDUCATION POLICY;

12 (IV) ONE REPRESENTATIVE OF A STATEWIDE ORGANIZATION OF
13 TEACHERS; AND

14 (V) ONE REPRESENTATIVE OF A STATEWIDE ORGANIZATION
15 SPECIALIZING IN EQUITY AND INCLUSION;

16 (b) THE PRESIDENT OF THE SENATE SHALL APPOINT THE
17 FOLLOWING MEMBERS:

18 (I) ONE REPRESENTATIVE WHO SERVES AS A MEMBER OF THE STATE
19 BOARD;

20 (II) ONE REPRESENTATIVE OF A SCHOOL DISTRICT BOARD OF
21 EDUCATION;

22 (III) ONE REPRESENTATIVE OF A STATEWIDE ORGANIZATION THAT
23 FOCUSES ON EDUCATION POLICY;

24 (IV) ONE REPRESENTATIVE WHO IS AN ELEMENTARY SCHOOL
25 TEACHER WITH EXPERIENCE TEACHING IN COLORADO PUBLIC SCHOOLS;

26 AND

27 (V) ONE SCHOOL DISTRICT SUPERINTENDENT WHO HAS

1 EXPERIENCE AS A SCHOOL DISTRICT SUPERINTENDENT IN COLORADO
2 PUBLIC SCHOOLS WHO REPRESENTS AN URBAN SCHOOL DISTRICT;

3 (c) THE HOUSE OF REPRESENTATIVES MINORITY LEADER SHALL
4 APPOINT THE FOLLOWING MEMBERS:

5 (I) ONE REPRESENTATIVE OF A SCHOOL DISTRICT BOARD OF
6 EDUCATION FROM A RURAL SCHOOL DISTRICT;

7 (II) ONE TEACHER WHO TEACHES MIDDLE SCHOOL WITH
8 EXPERIENCE TEACHING IN COLORADO PUBLIC SCHOOLS;

9 (III) ONE SCHOOL DISTRICT SUPERINTENDENT WHO HAS
10 EXPERIENCE AS A SCHOOL DISTRICT SUPERINTENDENT IN COLORADO
11 PUBLIC SCHOOLS; AND

12 (IV) ONE SCHOOL DISTRICT EMPLOYEE WHO OVERSEES THE LOCAL
13 ADMINISTRATION OF THE STATEWIDE EDUCATION ACCOUNTABILITY AND
14 ACCREDITATION SYSTEM;

15 (d) THE SENATE MINORITY LEADER SHALL APPOINT THE
16 FOLLOWING MEMBERS:

17 (I) ONE REPRESENTATIVE OF THE GOVERNING BOARD OF THE STATE
18 CHARTER SCHOOL INSTITUTE CREATED PURSUANT TO PART 5 OF ARTICLE
19 30.5 OF TITLE 22;

20 (II) ONE TEACHER WHO TEACHES IN A RURAL SCHOOL DISTRICT;

21 (III) ONE SUPERINTENDENT WHO REPRESENTS A RURAL SCHOOL
22 DISTRICT WHO HAS EXPERIENCE AS A SCHOOL DISTRICT SUPERINTENDENT
23 IN COLORADO PUBLIC SCHOOLS; AND

24 (IV) ONE SCHOOL DISTRICT EMPLOYEE OF AN URBAN SCHOOL
25 DISTRICT WHO OVERSEES THE LOCAL ADMINISTRATION OF THE STATEWIDE
26 EDUCATION ACCOUNTABILITY AND ACCREDITATION SYSTEM;

27 (e) THE GOVERNOR SHALL APPOINT THE FOLLOWING MEMBERS:

1 (I) ONE REPRESENTATIVE FROM THE GOVERNOR'S OFFICE;

2 (II) ONE REPRESENTATIVE OF A STATEWIDE ORGANIZATION THAT
3 REPRESENTS CHARTER SCHOOLS;

4 (III) ONE REPRESENTATIVE OF A STATEWIDE ORGANIZATION THAT
5 FOCUSES ON EDUCATION AND WORKFORCE DEVELOPMENT;

6 (IV) ONE REPRESENTATIVE WHO IS AN EXPERT IN ENGLISH
7 LANGUAGE ACQUISITION AND BILINGUAL EDUCATION;

8 (V) ONE SCHOOL DISTRICT EMPLOYEE OF A RURAL SCHOOL
9 DISTRICT WHO OVERSEES THE LOCAL ADMINISTRATION OF THE STATEWIDE
10 EDUCATION ACCOUNTABILITY AND ACCREDITATION SYSTEM; AND

11 (VI) ONE REPRESENTATIVE OF A STATEWIDE ORGANIZATION THAT
12 REPRESENTS DIRECTORS OF SPECIAL EDUCATION.

13 (f) THE DEPARTMENT SHALL APPOINT ONE REPRESENTATIVE FROM
14 THE DEPARTMENT WHO FOCUSES ON THE STATEWIDE EDUCATION
15 ACCOUNTABILITY AND ACCREDITATION SYSTEM.

16 (3) (a) NO LATER THAN AUGUST 15, 2023, THE DEPARTMENT
17 SHALL ENTER INTO A CONTRACT WITH A FACILITATOR TO GUIDE THE WORK
18 OF THE TASK FORCE. THE DEPARTMENT DOES NOT HAVE TO COMPLY WITH
19 THE PROVISIONS OF THE "PROCUREMENT CODE", ARTICLES 101 TO 112 OF
20 TITLE 24, WHEN ENTERING INTO A CONTRACT WITH A FACILITATOR. THE
21 DEPARTMENT SHALL SELECT A NEUTRAL FACILITATOR WHO IS NOT
22 AFFILIATED WITH A STATEWIDE ORGANIZATION DESCRIBED IN SUBSECTION
23 (2) OF THIS SECTION. FOR THE DURATION OF THE TASK FORCE, THE
24 DEPARTMENT MAY ENTER INTO CONTRACTS AS NECESSARY FOR THE TASK
25 FORCE TO CONSIDER THE ISSUES DESCRIBED IN SECTION 2-2-2103.

26 (b) THE FACILITATOR SHALL DRAFT THE INTERIM REPORT
27 DESCRIBED IN SECTION 2-2-2103 (3) AND THE FINAL REPORT DESCRIBED IN

1 SECTION 2-2-2103 (4).

2 (4) (a) THE CHAIRPERSON AND VICE-CHAIRPERSON SHALL
3 CONVENE THE FIRST MEETING OF THE TASK FORCE NO LATER THAN
4 SEPTEMBER 1, 2023. THE TASK FORCE SHALL MEET AT LEAST FOUR TIMES
5 IN 2023 AND AT LEAST SIX TIMES IN 2024 TO COMPLETE THE DUTIES
6 SPECIFIED IN SECTION 2-2-2103. THE TASK FORCE SHALL ESTABLISH
7 PROCEDURES TO ALLOW MEMBERS OF THE TASK FORCE TO PARTICIPATE IN
8 THE MEETINGS REMOTELY.

9 (b) THE TASK FORCE MEMBERS SHALL SERVE WITHOUT
10 COMPENSATION BUT MUST RECEIVE REIMBURSEMENT FOR REASONABLE
11 TRAVEL EXPENSES TO ATTEND TASK FORCE MEETINGS.

12 (c) IF A VACANCY OCCURS ON THE TASK FORCE FOR ANY REASON,
13 THE ORIGINAL APPOINTING AUTHORITY SHALL APPOINT A PERSON WHO
14 MEETS THE REQUIREMENTS OF THE VACANT POSITION TO FILL THE
15 VACANCY AS SOON AS POSSIBLE AFTER THE VACANCY OCCURS.

16 (5) THE DEPARTMENT SHALL PROVIDE INFORMATION AND STAFF
17 SUPPORT TO THE TASK FORCE UPON THE REQUEST OF THE TASK FORCE
18 CHAIRPERSON TO THE EXTENT NECESSARY FOR THE TASK FORCE TO
19 COMPLETE THE DUTIES DESCRIBED IN SECTION 2-2-2103. THE
20 DEPARTMENT SHALL COLLECT AND PROVIDE TO THE TASK FORCE THE DATA
21 NECESSARY FOR THE TASK FORCE TO CONSIDER THE ISSUES IDENTIFIED IN
22 SECTION 2-2-2103.

23 **2-2-2103. Accountability, accreditation, student performance,**
24 **and resource inequity task force - duties - report.** (1) (a) IN
25 COMPLETING THE STUDY REQUIRED IN THIS PART 21, THE TASK FORCE, AT
26 A MINIMUM, SHALL CONSIDER:

27 (I) ACADEMIC OPPORTUNITIES OR INEQUITIES THAT MAY IMPACT

1 ACADEMIC ACHIEVEMENT GAPS;

2 (II) IMPROVEMENTS TO THE ACCOUNTABILITY AND
3 ACCREDITATION SYSTEM TO EXPAND AND INCENTIVIZE ACADEMIC
4 OPPORTUNITIES AND ADDRESS INEQUITIES;

5 (III) PROMISING PRACTICES IN SCHOOLS AND SCHOOL DISTRICTS;
6 AND

7 (IV) RECOMMENDATIONS FOR LEGISLATION OR RULES, AS
8 NECESSARY.

9 (b) TO SUPPORT THE CONSIDERATIONS OF THE TASK FORCE SET
10 FORTH IN SUBSECTION (1)(a) OF THIS SECTION, THE TASK FORCE MAY
11 REVIEW:

12 (I) THE RESULTS OF THE STATEWIDE EDUCATION ACCOUNTABILITY
13 SYSTEMS AUDIT REPORT DESCRIBED IN SECTION 2-3-127;

14 (II) THE LOCAL ACCOUNTABILITY SYSTEMS DESCRIBED IN PART 7
15 OF ARTICLE 11 OF TITLE 22;

16 (III) THE RESULTS OF THE LOCAL ACCOUNTABILITY SYSTEM GRANT
17 PROGRAM CREATED IN SECTION 22-11-703;

18 (IV) THE ANNUAL REPORT AND EVALUATION FROM THE HIGH
19 SCHOOL INNOVATIVE LEARNING PILOT PROGRAM CREATED IN ARTICLE 35.6
20 OF TITLE 22;

21 (V) THE RESULTS OF THE SCHOOL TRANSFORMATION GRANT
22 PROGRAM CREATED IN SECTION 22-13-103;

23 (VI) THE INTERIM AND FINAL REPORTS FROM THE SECONDARY,
24 POSTSECONDARY, AND WORK-BASED LEARNING INTEGRATION TASK FORCE
25 CREATED IN PART 2 OF ARTICLE 35.3 OF TITLE 22;

26 (VII) PROMISING PRACTICES FROM OTHER STATES AS IDENTIFIED
27 BY TASK FORCE MEMBERS; AND

1 (VIII) LEADING INDICATORS OR INSTRUCTIONAL PRACTICES THAT
2 COULD BE ADDED TO THE ACCOUNTABILITY MEASURES.

3 (2) THE TASK FORCE SHALL CONSULT WITH ADDITIONAL
4 STAKEHOLDERS AS NEEDED TO ADDRESS QUESTIONS NECESSARY TO
5 FINALIZE ITS FINDINGS AND RECOMMENDATIONS.

6 (3) ON OR BEFORE MARCH 1, 2024, THE TASK FORCE SHALL
7 SUBMIT AN INTERIM REPORT, INCLUDING ITS INITIAL FINDINGS AND
8 RECOMMENDATIONS ON ISSUES IDENTIFIED IN SUBSECTION (1) OF THIS
9 SECTION, TO THE EDUCATION COMMITTEES OF THE HOUSE OF
10 REPRESENTATIVES AND THE SENATE, OR THEIR SUCCESSOR COMMITTEES;
11 THE GOVERNOR; THE STATE BOARD; THE COMMISSIONER OF EDUCATION;
12 AND THE DEPARTMENT.

13 (4) ON OR BEFORE NOVEMBER 15, 2024, THE TASK FORCE SHALL
14 SUBMIT A FINAL REPORT, INCLUDING ITS FINDINGS AND
15 RECOMMENDATIONS ON ISSUES IDENTIFIED IN SUBSECTION (1) OF THIS
16 SECTION, TO THE EDUCATION COMMITTEES OF THE HOUSE OF
17 REPRESENTATIVES AND THE SENATE, OR THEIR SUCCESSOR COMMITTEES;
18 THE GOVERNOR; THE STATE BOARD; THE COMMISSIONER OF EDUCATION;
19 AND THE DEPARTMENT.

20 **2-2-2104. Repeal of part.** THIS PART 21 IS REPEALED, EFFECTIVE
21 DECEMBER 31, 2026.

22 **SECTION 2. Safety clause.** The general assembly hereby finds,
23 determines, and declares that this act is necessary for the immediate
24 preservation of the public peace, health, or safety.
