101 **CONCERNING A TRANSFER FROM THE SEVERANCE TAX OPERATIONAL**

Bill Summary

Joint Budget Committee. The bill requires the state treasurer, on June 30, 2023, to transfer \$12.6 million from the severance tax operational fund to the water plan implementation cash fund.

SECTION 1. In Colorado Revised Statutes, 39-29-109.3, add (9)
 as follows:

3 39-29-109.3. Severance tax operational fund - core reserve grant program reserve - definitions - repeal. (9) ON JUNE 30, 2023,
THE STATE TREASURER SHALL TRANSFER TWELVE MILLION SIX HUNDRED
THOUSAND DOLLARS FROM THE OPERATIONAL FUND TO THE WATER PLAN
IMPLEMENTATION CASH FUND CREATED IN SECTION 37-60-123.3.

8 SECTION 2. In Colorado Revised Statutes, 37-60-123.3, amend
9 (1)(a) as follows:

10 **37-60-123.3.** Water plan implementation cash fund - created 11 - water plan implementation account - created - legislative 12 declaration - reporting - repeal. (1) (a) There is hereby created in the 13 state treasury the water plan implementation cash fund, referred to in this 14 section as the "fund". The fund consists of sports betting revenues 15 transferred from the sports betting fund in accordance with section 16 44-30-1509, MONEY TRANSFERRED FROM THE SEVERANCE TAX 17 OPERATIONAL FUND PURSUANT TO SECTION 39-29-109.3(9), and any other 18 money that the general assembly may appropriate or transfer to the fund. 19 The state treasurer shall credit all interest and income derived from the 20 deposit and investment of money in the fund to the fund.

SECTION 3. Safety clause. The general assembly hereby finds,
 determines, and declares that this act is necessary for the immediate
 preservation of the public peace, health, or safety.
