HOUSE RESOLUTION 23-1006

101 **CONCERNING THE APPROVAL BY THE HOUSE OF REPRESENTATIVES OF**
102 **THE SPEAKER'S APPOINTMENT OF DANIEL WOLF TO THE**
103 **INDEPENDENT ETHICS COMMISSION.**

1 WHEREAS, Section 5 (2)(a)(II) of article XXIX of the Colorado
2 constitution provides that one member of the Independent Ethics
3 Commission created in section 5 (1) of that article, hereafter referred to
4 as the "Commission", shall be appointed by the House of Representatives,
5 and section 24-18.5-101 (2)(a), Colorado Revised Statutes, provides that
6 said appointment shall be made by the Speaker of the House of
7 Representatives with the approval of two-thirds of the members elected
8 to the House; and

9 WHEREAS, Pursuant to such authority, Speaker Julie McCluskie
10 appoints Daniel Wolf to the Independent Ethics Commission to succeed
11 Commissioner Amy Kao upon the conclusion of her term; and

12 WHEREAS, Mr. Wolf is a real estate, business, and commercial
13 law attorney with over thirty years of diverse and wide-ranging
14 experience, primarily practicing in Summit and Eagle Counties and
15 surrounding mountain communities; and

1 WHEREAS, Mr. Wolf lives in Silverthorne where he has raised
2 his family for the past twenty-five years; and

3 WHEREAS, Mr. Wolf is active in both his community and the
4 Colorado Bar Association; and

5 WHEREAS, Mr. Wolf is widely recognized as an authority on
6 complex legal issues and represents a wide variety of entities ranging
7 from small businesses to publicly traded businesses; contractors of all
8 sizes; workers in Leadville to wealthy foreign nationals in Vail;
9 condominium associations to nonprofits; doctors to veterinarians to
10 engineers, and other professionals; restaurants to retail stores to hotels;
11 and local special districts; and

12 WHEREAS, Mr. Wolf has helped and advised clients on all types
13 of legal issues in a wide range of settings, including before judges;
14 county, municipal, and other governmental boards; and commissions; and

15 WHEREAS, Mr. Wolf provides independent and unvarnished
16 counsel to clients, including many boards, on all manner of issues,
17 including ethical issues and compliance with applicable laws; and

18 WHEREAS, Mr. Wolf is a founder, trustee, and a former
19 long-time chairman of The Peak School in Frisco, Colorado; and

20 WHEREAS, Mr. Wolf has served on the boards of directors for the
21 Vail Valley Chapter of the Salvation Army and Team Breckenridge Sport
22 Club; and

23 WHEREAS, Mr. Wolf was appointed to, and currently serves on,
24 the Fifth Judicial District Judicial Performance Commission and has
25 served two terms on the Fifth Judicial District Nominating Commission;
26 and

27 WHEREAS, On the basis of his extraordinary service as an
28 experienced attorney, his resolution of diverse and complex legal issues,
29 and his impressive community outreach and knowledge, Daniel Wolf has
30 demonstrated the qualifications that will allow him to serve as a respected
31 member of the Colorado Independent Ethics Commission in an exemplary
32 manner and to provide leadership on matters of ethics in a way that will
33 reflect well upon the House of Representatives, the Colorado General

1 Assembly, and the State of Colorado; now, therefore,

2 *Be It Resolved by the House of Representatives of the*
3 *Seventy-fourth General Assembly of the State of Colorado:*

4 That the House of Representatives hereby approves Speaker Julie
5 McCluskie's appointment of Daniel Wolf to the Independent Ethics
6 Commission for a four-year term commencing July 1, 2023, and ending
7 June 30, 2027.

8 *Be It Further Resolved,* That a copy of this House Resolution be
9 sent to the Chair of the Independent Ethics Commission, the Executive
10 Director of the Independent Ethics Commission, and Mr. Wolf.
