2 designated May 15 as Peace Officers' Memorial Day and the week in
3 which it falls as National Police Week; and

4 WHEREAS, The members of the law enforcement agencies within
5 the state of Colorado play an essential role in safeguarding the rights and
6 freedoms of the citizens of the state of Colorado; and

7 WHEREAS, It is important that all citizens of Colorado know and
8 understand the duties, responsibilities, and challenges of their peace
9 officers; and

2 Colorado recognize their duty to serve the people of this state by
3 safeguarding life and property; protecting citizens against violence,
4 disorder, and deception; and protecting the weak against oppression or

22 have rendered a dedicated service to their community and, in doing so,
23 have established for themselves an enviable and enduring reputation for
24 preserving the rights and security of all citizens; now, therefore,

25 *Be It Resolved by the Senate of the Seventy-third General*
26 *Assembly of the State of Colorado, the House of Representatives*
27 *concurring herein:*

28 (1) That we, the members of the General Assembly, hereby
29 proclaim the week commencing May 12, 2023, as Police Week in
30 Colorado, in recognition of peace officers' efforts in safeguarding the
31 citizens of Colorado, and call upon all citizens of the state and upon all
32 patriotic, civic, and educational organizations to observe Police Week;
33 and

1 (2) That we hereby proclaim the day of May 15, 2023, as Peace
2 Officers' Memorial Day in recognition of those officers who, through
3 their courageous deeds, have made the supreme sacrifice or who have
4 been disabled in the line of duty, and call upon the citizens of Colorado
5 to recognize and participate in the observance of this worthy occasion.
