**A BILL FOR AN ACT**

101 **CONCERNING NON-LEGAL NAME CHANGES FOR STUDENTS IN SCHOOLS.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. **Colorado Youth Advisory Council Review Committee. Section 1** of the bill:

- Requires public schools and institute charter schools (school) to use a student's preferred name, if a preferred name is requested by the student; and
- Deems a school's refusal to use a student's preferred name a form of discrimination.

**Section 2** of the bill:

- Creates the non-legal name changes in schools task force (task force) in the department of education (department) consisting of 9 members appointed by the department to examine existing school policies and provide recommendations to schools on how to best implement student non-legal name change policies;
- Requires the department to appoint members to the task force by June 30, 2024;
- Requires the task force to submit a report to the department detailing the recommended policy guidelines by January 1, 2025;
- Requires the department to publish the report on its website and submit the report to the superintendent of each school district and chief administrator of each institute charter school by February 1, 2025;
- Requires a school to implement the task force's policy recommendations by July 1, 2025; and
- Repeals the task force, effective July 1, 2026.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. In Colorado Revised Statutes, add 22-1-144 as**  
 3 **follows:**

4 **22-1-144. Use of a student's chosen name - definitions. (1) AS**  
 5 **USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE REQUIRES:**

6 **(a) "CHOSEN NAME" MEANS ANY NAME THAT A STUDENT**  
 7 **REQUESTS TO BE KNOWN AS THAT DIFFERS FROM THE STUDENT'S LEGAL**  
 8 **NAME, TO REFLECT THE STUDENT'S GENDER IDENTITY.**

9 **(b) "GENDER IDENTITY" MEANS AN INDIVIDUAL'S INNATE SENSE OF**  
 10 **THE INDIVIDUAL'S OWN GENDER, WHICH MAY OR MAY NOT CORRESPOND**  
 11 **WITH THE INDIVIDUAL'S SEX ASSIGNED AT BIRTH.**

12 **(c) "LOCAL EDUCATION PROVIDER" MEANS A SCHOOL DISTRICT, A**  
 13 **CHARTER SCHOOL AUTHORIZED BY A SCHOOL DISTRICT PURSUANT TO PART**  
 14 **1 OF ARTICLE 30.5 OF THIS TITLE 22, A CHARTER SCHOOL AUTHORIZED BY**  
 15 **THE STATE CHARTER SCHOOL INSTITUTE PURSUANT TO PART 5 OF ARTICLE**

1 30.5 OF THIS TITLE 22, OR A BOARD OF COOPERATIVE SERVICES CREATED  
2 AND OPERATING PURSUANT TO ARTICLE 5 OF THIS TITLE 22 THAT  
3 OPERATES ONE OR MORE PUBLIC SCHOOLS.

4 (d) "PUBLIC SCHOOL" MEANS AN ELEMENTARY SCHOOL, MIDDLE  
5 SCHOOL, JUNIOR HIGH SCHOOL, HIGH SCHOOL, OR DISTRICT CHARTER  
6 SCHOOL OF A SCHOOL DISTRICT THAT ENROLLS STUDENTS IN ANY OF  
7 GRADES KINDERGARTEN THROUGH TWELVE OR AN INSTITUTE CHARTER  
8 SCHOOL THAT ENROLLS STUDENTS IN ANY OF GRADES KINDERGARTEN  
9 THROUGH TWELVE.

10 (2) A PUBLIC SCHOOL SHALL ADDRESS A STUDENT BY THE  
11 STUDENT'S CHOSEN NAME AND USE THE STUDENT'S CHOSEN NAME IN  
12 SCHOOL AND DURING EXTRACURRICULAR ACTIVITIES.

13 (3) KNOWINGLY OR INTENTIONALLY USING A NAME OTHER THAN  
14 A STUDENT'S CHOSEN NAME IS DISCRIMINATORY.

15 (4) A STUDENT WHO IS SUBJECT TO DISCRIMINATION PURSUANT TO  
16 SUBSECTION (3) OF THIS SECTION MAY FILE A REPORT WITH THE PUBLIC  
17 SCHOOL IN ACCORDANCE WITH THE REQUIREMENTS OF SECTION 22-1-143  
18 (2).

19 (5) A LOCAL EDUCATION PROVIDER SHALL IMPLEMENT A WRITTEN  
20 POLICY OUTLINING HOW THE LOCAL EDUCATION PROVIDER WILL HONOR A  
21 STUDENT'S REQUEST TO USE A CHOSEN NAME AND MAY INCLUDE A  
22 PROCESS FOR INCLUDING A STUDENT'S CHOSEN NAME ON SCHOOL  
23 RECORDS.

24 **SECTION 2.** In Colorado Revised Statutes, 22-1-143, **add**  
25 **(1)(d)(IV)** as follows:

26 **22-1-143. Harassment or discrimination - policy required -**  
27 **training and notification - definitions.** (1) As used in this section,

1 unless the context otherwise requires:

2 (d) (IV) HARASSMENT OR DISCRIMINATION INCLUDES THE  
3 KNOWING OR INTENTIONAL USE OF A NAME OTHER THAN A STUDENT'S  
4 CHOSEN NAME, AS DEFINED IN SECTION 22-1-144 (1).

5 **SECTION 3.** In Colorado Revised Statutes, 22-2-117, **amend**  
6 **(1)(b)(IX) and (1)(b)(X); and add (1)(b)(XI) as follows:**

7 **22-2-117. Additional power - state board - waiver of**  
8 **requirements - rules.** (1) (b) The state board shall not waive any of the  
9 requirements specified in any of the following statutory provisions:

10 (IX) Any provisions of section 22-1-128 relating to  
11 comprehensive human sexuality education content requirements; or

12 (X) Any provision of section 22-30.5-104 (3), 22-30.5-507 (3),  
13 22-32-109 (1)(II), 22-32-110 (1)(k), 22-38-104 (1)(d), or 22-63-206 (1)  
14 relating to discrimination based on hair texture, hair type, or a protective  
15 hairstyle that is commonly or historically associated with race; OR

16 (XI) ANY PROVISION OF SECTION 22-1-144 RELATING TO THE USE  
17 OF A STUDENT'S CHOSEN NAME, AS DEFINED IN SECTION 22-1-144 (1), IN A  
18 PUBLIC SCHOOL.

19 **SECTION 4.** In Colorado Revised Statutes, 22-30.5-104, **amend**  
20 **(6)(c)(VIII); and add (6)(c)(X) as follows:**

21 **22-30.5-104. Charter school - requirements - authority - rules**  
22 **- definitions.** (6) (c) A school district, on behalf of a charter school, may  
23 apply to the state board for a waiver of a state statute or state rule that is  
24 not an automatic waiver. Notwithstanding any provision of this  
25 subsection (6) to the contrary, the state board may not waive any statute  
26 or rule relating to:

27 (VIII) Section 22-33-106.1 concerning suspension and expulsion

1 of students in preschool through second grade; or

2 (X) ANY PROVISION OF SECTION 22-1-144 RELATING TO THE USE  
3 OF A STUDENT'S CHOSEN NAME, AS DEFINED IN SECTION 22-1-144 (1), IN A  
4 PUBLIC SCHOOL.

5 **SECTION 5.** In Colorado Revised Statutes, 22-30.5-507, amend  
6 (7)(b)(VIII); and add (7)(b)(X) as follows:

7 **22-30.5-507. Institute charter school - requirements -**  
8 **authority - rules - definitions.** (7) (b) An institute charter school may  
9 apply to the state board, through the institute, for a waiver of state statutes  
10 and state rules that are not automatic waivers. The state board may waive  
11 state statutory requirements or rules promulgated by the state board;  
12 except that the state board may not waive any statute or rule relating to:

13 (VIII) Section 22-33-106.1 concerning suspension and expulsion  
14 of students in preschool through second grade; or

15 (X) ANY PROVISION OF SECTION 22-1-144 RELATING TO THE USE  
16 OF A STUDENT'S CHOSEN NAME, AS DEFINED IN SECTION 22-1-144 (1), IN A  
17 PUBLIC SCHOOL.

18 **SECTION 6. Safety clause.** The general assembly finds,  
19 determines, and declares that this act is necessary for the immediate  
20 preservation of the public peace, health, or safety or for appropriations for  
21 the support and maintenance of the departments of the state and state  
22 institutions.
