A BILL FOR AN ACT

101 **CONCERNING AUTHORIZATION TO HOLD SPECIAL EVENTS WHERE**
102 **SUBSTANCES THAT MINORS ARE PROHIBITED FROM PURCHASING**
103 **ARE SERVED.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Under current law, a special event permit allows the service of alcohol beverages during special events. The bill authorizes a special event permit to be issued to a chamber of commerce and chamber of commerce members to participate in a special event. Certain types of business are excluded from participating in the special event. The holder

of a retail establishment permit may serve complimentary alcohol beverages during the event but must make snacks and sandwiches available during the event.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 44-5-102, **amend**
3 (1)(b) and (1)(c); and **add** (1)(d) as follows:

4 **44-5-102. Qualifications for permit.** (1) A special event permit
5 issued under this article 5 may be issued to:

6 (b) A political candidate who has filed the necessary reports and
7 statements with the secretary of state pursuant to article 45 of title 1; ~~or~~

8 (c) ~~Any~~ A municipality, county, or special district; OR

9 (d) (I) A CHAMBER OF COMMERCE.

10 (II) MEMBERS OF A CHAMBER OF COMMERCE MAY PARTICIPATE IN
11 A SPECIAL EVENT FOR WHICH A PERMIT HAS BEEN GRANTED TO THE
12 CHAMBER OF COMMERCE, AND THE PREMISES OF THE MEMBERS AND THE
13 LOCATIONS SPECIFIED IN THE SPECIAL EVENT PERMIT NEED NOT BE
14 CONTIGUOUS; EXCEPT THAT A MEMBER OF A CHAMBER OF COMMERCE
15 SHALL NOT PARTICIPATE IN THE SPECIAL EVENT IF THE MEMBER:

16 (A) SELLS FIREARMS, MOTOR VEHICLES, MARIJUANA, GASOLINE,
17 OR DIESEL FUEL;

18 (B) EDUCATES STUDENTS FROM KINDERGARTEN THROUGH
19 TWELFTH GRADE OR PROVIDES CHILD CARE;

20 (C) IS A CONVENIENCE STORE; OR

21 (D) HOLDS A LIQUOR LICENSE OR PERMIT UNDER ARTICLE 3 OR 4
22 OF THIS TITLE 44, BUT THE HOLDER OF A PERMIT UNDER SECTION 44-3-424
23 MAY PARTICIPATE IN THE SPECIAL EVENT IF THE HOLDER IS NOT
24 EXERCISING THE PRIVILEGES OF THE PERMIT ISSUED UNDER SECTION

1 44-3-424 DURING THE SPECIAL EVENT.

2 **SECTION 2.** In Colorado Revised Statutes, 44-3-202, **add**
3 (2)(a)(I)(U) as follows:

4 **44-3-202. Duties of state licensing authority.** (2) (a) (I) Rules
5 adopted pursuant to subsection (1)(b) of this section may cover, without
6 limitation, the following subjects:

7 (U) SPECIAL EVENT PERMITS ISSUED UNDER ARTICLE 5 OF THIS
8 TITLE 44.

9 **SECTION 3.** In Colorado Revised Statutes, 44-5-103, **amend**
10 (1)(a) as follows:

11 **44-5-103. Grounds for issuance of special permits.** (1) (a) A
12 special event permit may be issued under this section notwithstanding the
13 fact that the special event is to be held on premises licensed under the
14 provisions of section 44-3-403, 44-3-404, 44-3-413 (3), 44-3-418,
15 44-3-419, or 44-3-424. The holder of a special event permit issued
16 pursuant to this subsection (1) is responsible for any violation of ~~article~~
17 ~~3~~ THIS ARTICLE 5 OR ARTICLES 3 OR 4 of this title 44.

18 **SECTION 4.** In Colorado Revised Statutes, 44-5-105, **amend** (5)
19 as follows:

20 **44-5-105. Restrictions related to permits.** (5) A SPECIAL EVENT
21 PERMIT HOLDER SHALL MAKE AVAILABLE sandwiches or other food snacks
22 ~~shall be available~~ during all hours of service of malt, spirituous, or vinous
23 liquors, but prepared meals need not be served. FOR A SPECIAL EVENT
24 HELD BY A CHAMBER OF COMMERCE, PURSUANT TO A PERMIT ISSUED
25 UNDER SECTION 44-5-102 (1)(d), THE CHAMBER OF COMMERCE AND EACH
26 PARTICIPATING MEMBER SHALL MAKE AVAILABLE SNACKS AND
27 SANDWICHES DURING ALL HOURS WHEN ALCOHOL BEVERAGES ARE

1 SERVED.

2 **SECTION 5.** In Colorado Revised Statutes, **add 44-7-105.5** as
3 follows:

4 **44-7-105.5. Tobacco festivals - rules.** (1) THE EXECUTIVE
5 DIRECTOR SHALL PROMULGATE RULES THAT CREATE AN OFF-SITE EVENT
6 PERMIT IN ORDER TO AUTHORIZE A STATE LICENSE HOLDER TO HOST AN
7 AGE-RESTRICTED TOBACCO FESTIVAL HOSTED BY THE STATE LICENSE
8 HOLDER.

9 (2) THE RULES REQUIRED PURSUANT TO SUBSECTION (1) OF THIS
10 SECTION MUST:

11 (a) AUTHORIZE OFF-SITE TOBACCO FESTIVALS FOR PERMIT
12 HOLDERS;

13 (b) ESTABLISH PROCEDURES TO AUTHORIZE A STATE LICENSE
14 HOLDER TO APPLY FOR AND BE ISSUED AN OFF-SITE EVENT PERMIT FOR A
15 TOBACCO FESTIVAL;

16 (c) REQUIRE A STATE LICENSE HOLDER TO NOTIFY THE DIVISION OF
17 THE TIME AND PLACE OF THE TOBACCO FESTIVAL AND ANY OTHER
18 INFORMATION REQUIRED BY RULE AT LEAST THIRTY DAYS BEFORE THE
19 FESTIVAL;

20 (d) REQUIRE THE STATE LICENSE HOLDER TO HAVE ANY LOCAL
21 PERMIT REQUIRED BY THE LOCAL AUTHORITY;

22 (e) REQUIRE THE TOBACCO FESTIVAL TO COMPLY WITH PART 2 OF
23 ARTICLE 14 OF TITLE 25; AND

24 (f) PROHIBIT AN INDIVIDUAL WHO IS UNDER TWENTY-ONE YEARS
25 OF AGE FROM TAKING PART IN THE TOBACCO FESTIVAL.

26 (3) THE EXECUTIVE DIRECTOR MAY ESTABLISH BY RULE AN
27 APPLICATION FEE FOR THE PERMIT. THE APPLICATION FEE MUST BE SET AT

1 AN AMOUNT THAT OFFSETS THE DIRECT AND INDIRECT COST OF
2 IMPLEMENTING THIS SECTION, INCLUDING ISSUING THE PERMIT AND
3 ENFORCEMENT RESULTING FROM THE PERMIT.

4 (4) THIS SECTION TAKES EFFECT JANUARY 1, 2025.

5 **SECTION 6. Act subject to petition - effective date -**
6 **applicability.** (1) This act takes effect at 12:01 a.m. on the day following
7 the expiration of the ninety-day period after final adjournment of the
8 general assembly; except that, if a referendum petition is filed pursuant
9 to section 1 (3) of article V of the state constitution against this act or an
10 item, section, or part of this act within such period, then the act, item,
11 section, or part will not take effect unless approved by the people at the
12 general election to be held in November 2024 and, in such case, will take
13 effect on the date of the official declaration of the vote thereon by the
14 governor.

15 (2) This act applies to events held on or after the applicable
16 effective date of this act.
