# A BILL FOR AN ACT

## **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Under current law, a special event permit allows the service of alcohol beverages during special events. The bill authorizes a special event permit to be issued to a chamber of commerce and chamber of commerce members to participate in a special event. Certain types of business are excluded from participating in the special event. The holder

of a retail establishment permit may serve complimentary alcohol beverages during the event but must make snacks and sandwiches available during the event.

Be it enacted by the General Assembly of the State of Colorado:
