CONCERNING THE CONTINUATION OF THE SENIOR DENTAL ADVISORY COMMITTEE.

Be it enacted by the General Assembly of the State of Colorado:

**SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal** (15)(a)(IV); and **add** (20)(a)(VI) as follows:

- **2-3-1203.** Sunset review of advisory committees legislative declaration definition repeal. (15) (a) The following statutory authorizations for the designated advisory committees are scheduled for repeal on September 1, 2024:
- (IV) The senior dental advisory committee created in section 25.5-3-406, C.R.S.;
- (20) (a) The following statutory authorizations for the designated advisory committees will repeal on September 1, 2029:

- (VI) THE SENIOR DENTAL ADVISORY COMMITTEE CREATED IN SECTION 25.5-3-406.
- **SECTION 2.** In Colorado Revised Statutes, 25.5-3-406, **amend** (3)(a) as follows:
- **25.5-3-406.** Senior dental advisory committee creation duties repeal. (3) (a) This section is repealed, effective September 1, 2024 SEPTEMBER 1, 2029.
- **SECTION 3.** Act subject to petition effective date. This act takes effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly; except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part will not take effect unless approved by the people at the general election to be held in

November 2024 and, in such case, declaration of the vote thereon by	will take effect on the date of the official the governor.
