Bill Summary

The bill requires the general assembly to appropriate money from the state education fund to fund stipends under the student educator stipend program, subject to available appropriations. SENATE 3rd Reading Unamended

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 23-3.9-302, add (5) 3 as follows: 4 23-3.9-302. Student educator stipend program - created -5 guidelines - appropriation - legislative declaration - definition -6 repeal. (5) (a) THE GENERAL ASSEMBLY SHALL APPROPRIATE TO THE 7 DEPARTMENT OF EDUCATION MONEY FROM THE STATE EDUCATION FUND 8 TO FUND STIPENDS FOR ELIGIBLE STUDENTS. THE DEPARTMENT OF 9 EDUCATION SHALL TRANSFER SPENDING AUTHORITY FROM THE 10 APPROPRIATION MADE PURSUANT TO THIS SUBSECTION (5)(a) TO THE 11 DEPARTMENT OF HIGHER EDUCATION FOR THE SAME PURPOSE. 12 (b) THE GENERAL ASSEMBLY FINDS AND DECLARES THAT, FOR 13 PURPOSES OF SECTION 17 OF ARTICLE IX OF THE STATE CONSTITUTION, 14 AWARDING STIPEND MONEY TO AN ELIGIBLE STUDENT TO REDUCE THE 15 FINANCIAL BARRIERS TO ENTERING THE EDUCATOR WORKFORCE WHILE 16 THE STUDENT IS A STUDENT EDUCATOR IS A CRITICAL ELEMENT OF 17 ACCOUNTABLE EDUCATION REFORM, ACCOUNTABLE PROGRAMS TO MEET 18 STATE ACADEMIC STANDARDS, AND CLASS SIZE REDUCTION, AND 19 THEREFORE THE DEPARTMENT AND ELIGIBLE STUDENT MAY RECEIVE 20 FUNDING FROM THE STATE EDUCATION FUND CREATED IN SECTION 17 (4) OF ARTICLE IX OF THE STATE CONSTITUTION. 21 22 **SECTION 2.** Appropriation. (1) For the 2024-25 state fiscal 23 year, \$4,197,000 is appropriated to the department of education for use 24 by educator talent. This appropriation is from the state education fund 25 created in section 17 (4) of article IX of the state constitution. To 26 implement this act, the department may use this appropriation for transfer

3	(2) For the 2024-25 state fiscal year, \$4,197,000 is appropriated to
4	the department of higher education for use by Colorado commission on
5	higher education financial aid. This appropriation is from reappropriated
6	funds received from the department of education under subsection (1) of
7	this section, and is based on an assumption that the department will
8	require an additional 1.0 FTE. To implement this act, the department may
9	use this appropriation for the student educator stipend program.
10	SECTION 3. Safety clause. The general assembly finds,
11	determines, and declares that this act is necessary for the immediate
12	preservation of the public peace, health, or safety or for appropriations for
13	the support and maintenance of the departments of the state and state
14	institutions.
