A BILL FOR AN ACT

101 CONCERNING REASONABLE MODIFICATIONS TO RENTAL PREMISES FOR

102 AN INDIVIDUAL WITH A DISABILITY.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Under current law, it is unlawful for a person to discriminate against a renter in the rental of a dwelling because the renter has a disability. Discrimination includes a refusal to permit reasonable modifications of existing premises occupied or to be occupied by an individual with a disability if the modifications are necessary to afford the individual with full enjoyment of the premises.

Reading Unamended March 18, 2024

The bill removes the provision that allows a landlord to condition permission for a modification on the renter agreeing to restore the interior of the premises.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 24-34-502.2, amend 3 (2)(a) as follows: 4 24-34-502.2. Unfair or discriminatory housing practices 5 against individuals with disabilities prohibited. (2) For purposes of 6 this section, "discrimination" includes both segregate and separate and 7 includes, but is not limited to: 8 (a) A refusal to permit at the expense of an individual with a 9 disability, reasonable modifications of existing premises occupied or to 10 be occupied by the AN individual WITH A DISABILITY if the modifications 11 are necessary to afford the individual with full enjoyment of the premises; 12 except that, in the case of a rental, the landlord may, where it is 13 reasonable to do so, condition permission for a modification on the renter 14 agreeing to restore the interior of the premises to the condition that 15 existed before the modification, reasonable wear and tear excepted; 16 **SECTION 2.** Act subject to petition - effective date. This act 17 takes effect at 12:01 a.m. on the day following the expiration of the 18 ninety-day period after final adjournment of the general assembly; except 19 that, if a referendum petition is filed pursuant to section 1 (3) of article V 20 of the state constitution against this act or an item, section, or part of this 21 act within such period, then the act, item, section, or part will not take 22 effect unless approved by the people at the general election to be held in
