A BILL FOR AN ACT

101 **CONCERNING ALIGNING THE COLORADO STATUTES WITH THE**
102 **NATIONAL ASSOCIATION OF INSURANCE COMMISSIONERS'**
103 **FINANCIAL MODEL LAWS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill updates Colorado state laws concerning insurance company holding systems to align with the National Association of Insurance Commissioners' model act. The changes include updating:

- The registration requirements for the ultimate controlling person of each insurer by adding new filing requirements

- to be included with the division of insurance's (division) existing registration requirements;
- The standards for insurance holding company transactions subject to registration with the division;
 - Language concerning the confidential treatment of documents to include proprietary and trade secret documents and materials; and
 - The regulatory tools that the division may use for the regulation of insurance holding companies.
- The bill also makes technical amendments.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 10-3-801, **add** (4.3),
3 (7.5), and (8.5) as follows:

4 **10-3-801. Definitions.** As used in this part 8, unless the context
5 otherwise requires:

7 (4.3) "GROUP CAPITAL CALCULATION INSTRUCTIONS" MEANS THE
8 GROUP CAPITAL CALCULATION INSTRUCTIONS ADOPTED AND AMENDED BY
9 THE NATIONAL ASSOCIATION OF INSURANCE COMMISSIONERS.

10 [REDACTED]
11 (7.5) "NAIC LIQUIDITY STRESS TEST FRAMEWORK" OR
12 "FRAMEWORK" MEANS THE NAIC PUBLICATION THAT INCLUDES A HISTORY
13 OF THE NAIC'S DEVELOPMENT OF REGULATORY LIQUIDITY STRESS
14 TESTING, THE SCOPE CRITERIA APPLICABLE FOR A SPECIFIC DATA YEAR,
15 AND THE LIQUIDITY STRESS TEST INSTRUCTIONS AND REPORTING
16 TEMPLATES FOR A SPECIFIC DATA YEAR, AS ADOPTED BY THE NAIC, AND
17 AS AMENDED FROM TIME TO TIME BY THE NAIC, IN ACCORDANCE WITH
18 THE PROCEDURES ADOPTED BY THE NAIC.

19 (8.5) "SCOPE CRITERIA" MEANS THE DESIGNATED EXPOSURE BASES,
20 ALONG WITH MINIMUM MAGNITUDES OF EXPOSURE BASES FOR THE

1 SPECIFIED DATA YEAR, USED TO ESTABLISH A PRELIMINARY LIST OF
2 INSURERS CONSIDERED SCOPED INTO THE NAIC LIQUIDITY STRESS TEST
3 FRAMEWORK FOR THAT DATA YEAR.

4 **SECTION 2.** In Colorado Revised Statutes, 10-3-804, **amend**
5 (12) as follows:

6 **10-3-804. Registration of insurers.** (12) (a) The ultimate
7 controlling person of every insurer subject to registration shall also file
8 an annual enterprise risk report. The report must, to the best of the
9 ultimate controlling person's knowledge and belief, identify the material
10 risks within the insurance holding company system that could pose
11 enterprise risk to the insurer. The controlling person shall file the report
12 with the lead state commissioner of the insurance holding company
13 system as determined by the procedures within the financial analysis
14 handbook adopted by the NAIC.

15 (b) EXCEPT AS PROVIDED IN SUBSECTIONS (12)(b)(I) TO
16 (12)(b)(IV) AND (12)(c) TO (12)(e) OF THIS SECTION, THE ULTIMATE
17 CONTROLLING PERSON OF EACH INSURER SUBJECT TO REGISTRATION SHALL
18 CONCURRENTLY FILE WITH THE REGISTRATION AN ANNUAL GROUP CAPITAL
19 CALCULATION AS DIRECTED BY THE LEAD STATE COMMISSIONER. THE
20 REPORT MUST BE COMPLETED IN ACCORDANCE WITH THE NAIC GROUP
21 CAPITAL CALCULATION INSTRUCTIONS, WHICH MAY PERMIT THE LEAD
22 STATE COMMISSIONER TO ALLOW A CONTROLLING PERSON THAT IS NOT
23 THE ULTIMATE CONTROLLING PERSON TO FILE THE GROUP CAPITAL
24 CALCULATION. THE REPORT MUST BE FILED WITH THE LEAD STATE
25 COMMISSIONER OF THE INSURANCE HOLDING COMPANY SYSTEM AS
26 DIRECTED BY THE LEAD STATE COMMISSIONER IN ACCORDANCE WITH THE
27 PROCEDURES WITHIN THE FINANCIAL ANALYSIS HANDBOOK ADOPTED BY

1 THE NAIC. THE FOLLOWING INSURANCE HOLDING COMPANY SYSTEMS ARE
2 EXEMPT FROM FILING THE GROUP CAPITAL CALCULATION:

3 (I) AN INSURANCE HOLDING COMPANY SYSTEM THAT HAS ONLY
4 ONE INSURER WITHIN ITS HOLDING COMPANY STRUCTURE, THAT ONLY
5 WRITES BUSINESS, AND IS ONLY LICENSED IN ITS DOMESTIC STATE AND
6 ASSUMES NO BUSINESS FROM ANY OTHER INSURER;

7 (II) AN INSURANCE HOLDING COMPANY SYSTEM THAT IS REQUIRED
8 TO PERFORM A GROUP CAPITAL CALCULATION SPECIFIED BY THE UNITED
9 STATES FEDERAL RESERVE BOARD. THE LEAD STATE COMMISSIONER SHALL
10 REQUEST THE CALCULATION FROM THE FEDERAL RESERVE BOARD UNDER
11 THE TERMS OF INFORMATION SHARING AGREEMENTS IN EFFECT. IF THE
12 FEDERAL RESERVE BOARD CANNOT SHARE THE CALCULATION WITH THE
13 LEAD STATE COMMISSIONER, THE INSURANCE HOLDING COMPANY SYSTEM
14 IS NOT EXEMPT FROM THE GROUP CAPITAL CALCULATION FILING.

15 (III) AN INSURANCE HOLDING COMPANY SYSTEM WHOSE
16 NON-UNITED STATES GROUP-WIDE SUPERVISOR IS LOCATED WITHIN A
17 RECIPROCAL JURISDICTION AS DESCRIBED IN SECTION 10-3-702 THAT
18 RECOGNIZES THE UNITED STATES' STATE REGULATORY APPROACH TO
19 GROUP SUPERVISION AND GROUP CAPITAL;

20 (IV) AN INSURANCE HOLDING COMPANY SYSTEM:

21 (A) THAT PROVIDES INFORMATION TO THE LEAD STATE
22 COMMISSIONER THAT MEETS THE REQUIREMENTS FOR ACCREDITATION
23 UNDER THE NAIC FINANCIAL STANDARDS AND ACCREDITATION PROGRAM,
24 EITHER DIRECTLY OR INDIRECTLY THROUGH THE GROUP-WIDE SUPERVISOR,
25 WHO HAS DETERMINED SUCH INFORMATION IS SATISFACTORY TO ALLOW
26 THE LEAD STATE COMMISSIONER TO COMPLY WITH THE NAIC GROUP
27 SUPERVISION APPROACH, AS DETAILED IN THE NAIC FINANCIAL ANALYSIS

1 HANDBOOK; AND

2 (B) WHOSE NON-UNITED STATES GROUP-WIDE SUPERVISOR THAT
3 IS NOT IN A RECIPROCAL JURISDICTION RECOGNIZES AND ACCEPTS, AS
4 SPECIFIED BY THE LEAD STATE COMMISSIONER IN REGULATION, THE GROUP
5 CAPITAL CALCULATION AS THE WORLD-WIDE GROUP CAPITAL ASSESSMENT
6 FOR UNITED STATES INSURANCE GROUPS THAT OPERATE IN THAT
7 JURISDICTION.

8 (c) NOTWITHSTANDING SUBSECTIONS (12)(b)(III) AND
9 (12)(b)(IV) OF THIS SECTION AND THIS SUBSECTION (12)(c), THE LEAD
10 STATE COMMISSIONER SHALL REQUIRE THE GROUP CAPITAL CALCULATION
11 FOR UNITED STATES OPERATIONS OF ANY NON-UNITED-STATES-BASED
12 INSURANCE HOLDING COMPANY SYSTEM WHERE, AFTER ANY NECESSARY
13 CONSULTATION WITH OTHER SUPERVISORS OR OFFICIALS, IT IS DEEMED
14 APPROPRIATE BY THE LEAD STATE COMMISSIONER FOR PRUDENTIAL
15 OVERSIGHT AND SOLVENCY MONITORING PURPOSES OR FOR ENSURING THE
16 COMPETITIVENESS OF THE INSURANCE MARKETPLACE.

17 (d) NOTWITHSTANDING THE EXEMPTIONS FROM FILING THE GROUP
18 CAPITAL CALCULATION STATED IN SUBSECTIONS (12)(b)(I) TO (12)(b)(IV)
19 OF THIS SECTION, THE LEAD STATE COMMISSIONER MAY EXEMPT THE
20 ULTIMATE CONTROLLING PERSON FROM FILING THE ANNUAL GROUP
21 CAPITAL CALCULATION OR TO ACCEPT A LIMITED GROUP CAPITAL FILING
22 OR REPORT IN ACCORDANCE WITH CRITERIA AS SPECIFIED BY THE
23 REGULATIONS PROMULGATED BY THE LEAD STATE COMMISSIONER.

24 (e) IF THE LEAD STATE COMMISSIONER DETERMINES THAT AN
25 INSURANCE HOLDING COMPANY SYSTEM NO LONGER MEETS ONE OR MORE
26 OF THE REQUIREMENTS FOR AN EXEMPTION FROM FILING THE GROUP
27 CAPITAL CALCULATION UNDER THIS SECTION, THE INSURANCE HOLDING

1 COMPANY SYSTEM MUST FILE THE GROUP CAPITAL CALCULATION AT THE
2 NEXT ANNUAL FILING DATE UNLESS GIVEN AN EXTENSION BY THE LEAD
3 STATE COMMISSIONER BASED ON REASONABLE GROUNDS SHOWN.

4 (f) (I) THE ULTIMATE CONTROLLING PERSON OF AN INSURER
5 SUBJECT TO REGISTRATION AND ALSO SCOPED INTO THE NAIC LIQUIDITY
6 STRESS TEST FRAMEWORK SHALL FILE THE RESULTS OF A SPECIFIC YEAR'S
7 LIQUIDITY STRESS TEST. THE FILING MUST BE MADE TO THE LEAD STATE
8 COMMISSIONER OF THE INSURANCE HOLDING COMPANY SYSTEM AS
9 DETERMINED BY THE PROCEDURES WITHIN THE FINANCIAL ANALYSIS
10 HANDBOOK ADOPTED BY THE NAIC.

11 (II) (A) THE NAIC LIQUIDITY STRESS TEST FRAMEWORK INCLUDES
12 SCOPE CRITERIA APPLICABLE TO A SPECIFIC DATA YEAR. AT LEAST
13 ANNUALLY, THE FINANCIAL STABILITY TASK FORCE OR ITS SUCCESSOR
14 SHALL REVIEW THE SCOPE CRITERIA. ANY CHANGE TO THE NAIC
15 LIQUIDITY STRESS TEST FRAMEWORK OR TO THE DATA YEAR FOR WHICH
16 THE SCOPE CRITERIA ARE TO BE MEASURED TAKES EFFECT ON JANUARY 1
17 OF THE YEAR FOLLOWING THE CALENDAR YEAR WHEN SUCH CHANGES ARE
18 ADOPTED. INSURERS MEETING AT LEAST ONE THRESHOLD OF THE SCOPE
19 CRITERIA ARE CONSIDERED SCOPED INTO THE NAIC LIQUIDITY STRESS
20 TEST FRAMEWORK FOR THE SPECIFIED DATA YEAR UNLESS THE LEAD STATE
21 COMMISSIONER, IN CONSULTATION WITH THE NAIC FINANCIAL STABILITY
22 TASK FORCE OR ITS SUCCESSOR, DETERMINES THE INSURER SHOULD NOT
23 BE SCOPED INTO THE NAIC LIQUIDITY STRESS TEST FRAMEWORK FOR THAT
24 DATA YEAR. SIMILARLY, INSURERS THAT DO NOT TRIGGER AT LEAST ONE
25 THRESHOLD OF THE SCOPE CRITERIA ARE CONSIDERED SCOPED OUT OF THE
26 NAIC LIQUIDITY STRESS TEST FRAMEWORK FOR THE SPECIFIED DATA
27 YEAR, UNLESS THE LEAD STATE COMMISSIONER, IN CONSULTATION WITH

1 THE NAIC FINANCIAL STABILITY TASK FORCE OR ITS SUCCESSOR,
2 DETERMINES THE INSURER SHOULD BE SCOPED INTO THE FRAMEWORK FOR
3 THAT DATA YEAR.

4 (B) AS PART OF THE DETERMINATION FOR AN INSURER, THE LEAD
5 STATE INSURANCE COMMISSIONER, IN CONSULTATION WITH THE FINANCIAL
6 STABILITY TASK FORCE OR ITS SUCCESSOR, SHALL ASSESS A REGULATOR'S
7 DESIRE TO AVOID HAVING INSURERS SCOPED IN AND OUT OF THE NAIC
8 LIQUIDITY STRESS TEST FRAMEWORK ON A FREQUENT BASIS.

9 (III) THE PERFORMANCE OF, AND FILING OF THE RESULTS FROM, A
10 SPECIFIC YEAR'S LIQUIDITY STRESS TEST MUST COMPLY WITH THE NAIC
11 LIQUIDITY STRESS TEST FRAMEWORK'S INSTRUCTIONS AND REPORTING
12 TEMPLATES FOR THAT YEAR AND ANY LEAD STATE INSURANCE
13 COMMISSIONER DETERMINATIONS, IN CONJUNCTION WITH THE NAIC
14 FINANCIAL STABILITY TASK FORCE OR ITS SUCCESSOR, PROVIDED WITHIN
15 THE FRAMEWORK.

16 **SECTION 3.** In Colorado Revised Statutes, 10-3-805, **amend**
17 (1)(a)(V); and **add** (1)(a)(VII), (1)(a)(VIII), (1)(a)(IX), (1)(h), and (4) as
18 follows:

19 **10-3-805. Standards and management of an insurer within an**
20 **insurance holding company system - rules. (1) Transactions within**
21 **an insurance holding company system. (a)** Transactions within an
22 insurance holding company system to which an insurer subject to
23 registration is a party are subject to the following standards:

24 (V) The books, accounts, and records of each party to all such
25 transactions shall be so maintained as to clearly and accurately disclose
26 the nature and details of the transactions, including such accounting
27 information as is necessary to support the reasonableness of the charges

1 or fees to the respective parties; and

2 (VII) (A) IF AN INSURER SUBJECT TO THIS ARTICLE 3 IS DEEMED BY
3 THE COMMISSIONER TO BE IN A HAZARDOUS FINANCIAL CONDITION, AS
4 DEFINED BY RULE OF THE COMMISSIONER, OR A CONDITION THAT WOULD
5 BE GROUNDS FOR SUPERVISION, CONSERVATION, OR A DELINQUENCY
6 PROCEEDING, THEN THE COMMISSIONER MAY REQUIRE THE INSURER TO
7 SECURE AND MAINTAIN EITHER A DEPOSIT, HELD BY THE COMMISSIONER,
8 OR A BOND, AS DETERMINED BY THE INSURER AT THE INSURER'S
9 DISCRETION, FOR THE PROTECTION OF THE INSURER FOR THE DURATION OF
10 THE CONTRACT OR AGREEMENT, OR THE EXISTENCE OF THE CONDITION FOR
11 WHICH THE COMMISSIONER REQUIRED THE DEPOSIT OR THE BOND.

12 (B) IN DETERMINING WHETHER A DEPOSIT OR A BOND IS REQUIRED,
13 THE COMMISSIONER SHALL CONSIDER WHETHER CONCERNS EXIST WITH
14 RESPECT TO THE AFFILIATED PERSON'S ABILITY TO FULFILL A CONTRACT OR
15 AGREEMENT IF THE INSURER WERE TO BE PUT INTO LIQUIDATION. ONCE
16 THE INSURER IS DEEMED TO BE IN A HAZARDOUS FINANCIAL CONDITION OR
17 A CONDITION THAT WOULD BE GROUNDS FOR SUPERVISION,
18 CONSERVATION, OR A DELINQUENCY PROCEEDING, AND A DEPOSIT OR
19 BOND IS NECESSARY, THE COMMISSIONER MAY DETERMINE THE AMOUNT
20 OF THE DEPOSIT OR BOND, NOT TO EXCEED THE VALUE OF A CONTRACT OR
21 AGREEMENT IN ANY ONE YEAR, AND WHETHER SUCH DEPOSIT OR BOND
22 SHOULD BE REQUIRED FOR A SINGLE CONTRACT, MULTIPLE CONTRACTS, OR
23 A CONTRACT ONLY WITH A SPECIFIC PERSON.

24 (VIII) THE RECORDS AND DATA OF THE INSURER HELD BY AN
25 AFFILIATE ARE AND REMAIN THE PROPERTY OF THE INSURER AND ARE
26 SUBJECT TO CONTROL OF THE INSURER. THE AFFILIATE SHALL ENSURE
27 THAT THE RECORDS AND DATA ARE IDENTIFIABLE AND ARE SEGREGATED

1 OR READILY CAPABLE OF SEGREGATION, AT NO ADDITIONAL COST TO THE
2 INSURER, FROM ALL OTHER PERSONS' RECORDS AND DATA. THIS INCLUDES
3 ALL RECORDS AND DATA THAT ARE OTHERWISE THE PROPERTY OF THE
4 INSURER, IN WHATEVER FORM MAINTAINED, INCLUDING CLAIMS AND
5 CLAIM FILES, POLICYHOLDER LISTS, APPLICATION FILES, LITIGATION FILES,
6 PREMIUM RECORDS, RATE BOOKS, UNDERWRITING MANUALS, PERSONNEL
7 RECORDS, FINANCIAL RECORDS, OR SIMILAR RECORDS WITHIN THE
8 POSSESSION, CUSTODY, OR CONTROL OF THE AFFILIATE. AT THE REQUEST
9 OF THE INSURER, THE AFFILIATE SHALL PERMIT THE RECEIVER TO OBTAIN
10 A COMPLETE SET OF ALL RECORDS OF ANY TYPE THAT PERTAIN TO THE
11 INSURER'S BUSINESS, OBTAIN ACCESS TO THE OPERATING SYSTEMS ON
12 WHICH THE DATA IS MAINTAINED, OBTAIN THE SOFTWARE THAT RUNS THE
13 OPERATING SYSTEMS EITHER THROUGH ASSUMPTION OF LICENSING
14 AGREEMENTS OR OTHERWISE, AND RESTRICT THE USE OF THE DATA BY THE
15 AFFILIATE IF THE RECEIVER OR THE AFFILIATE IS NOT OPERATING THE
16 INSURER'S BUSINESS. THE AFFILIATE SHALL PROVIDE A WAIVER OF ANY
17 LANDLORD LIEN OR OTHER ENCUMBRANCE TO GIVE THE INSURER ACCESS
18 TO ALL RECORDS AND DATA IN THE EVENT OF THE AFFILIATE'S DEFAULT
19 UNDER A LEASE OR OTHER AGREEMENT.

20 (IX) A PREMIUM OR OTHER MONEY BELONGING TO THE INSURER
21 THAT IS COLLECTED BY OR HELD BY AN AFFILIATE IS THE EXCLUSIVE
22 PROPERTY OF THE INSURER AND IS SUBJECT TO THE CONTROL OF THE
23 INSURER. ANY RIGHT OF OFFSET IN THE EVENT AN INSURER IS PLACED INTO
24 RECEIVERSHIP IS SUBJECT TO PART 5 OF THIS ARTICLE 3.

25 (h) (I) AN AFFILIATE THAT IS PARTY TO AN AGREEMENT OR
26 CONTRACT WITH A DOMESTIC INSURER THAT IS SUBJECT TO SUBSECTION
27 (1)(b)(IV) OF THIS SECTION IS SUBJECT TO THE JURISDICTION OF ANY

1 SUPERVISION, SEIZURE, CONSERVATORSHIP, OR RECEIVERSHIP
2 PROCEEDINGS AGAINST THE INSURER AND TO THE AUTHORITY OF ANY
3 SUPERVISOR, CONSERVATOR, REHABILITATOR, OR LIQUIDATOR FOR THE
4 INSURER APPOINTED PURSUANT TO SUPERVISION AND RECEIVERSHIP ACTS
5 FOR THE PURPOSE OF INTERPRETING, ENFORCING, AND OVERSEEING THE
6 AFFILIATE'S OBLIGATIONS UNDER THE AGREEMENT OR CONTRACT TO
7 PERFORM SERVICES FOR THE INSURER THAT:

8 (A) ARE AN INTEGRAL PART OF THE INSURER'S OPERATIONS,
9 INCLUDING MANAGEMENT, ADMINISTRATION, ACCOUNTING, DATA
10 PROCESSING, MARKETING, UNDERWRITING, CLAIMS HANDLING,
11 INVESTMENT, OR ANY OTHER SIMILAR FUNCTIONS; OR

12 (B) ARE ESSENTIAL TO THE INSURER'S ABILITY TO FULFILL ITS
13 OBLIGATIONS UNDER ITS INSURANCE POLICIES.

14 (II) THE COMMISSIONER MAY REQUIRE THAT AN AGREEMENT OR
15 CONTRACT PURSUANT TO SUBSECTION (1)(b)(IV) OF THIS SECTION FOR THE
16 PROVISION OF SERVICES DESCRIBED IN SUBSECTION (1)(h)(I) OF THIS
17 SECTION SPECIFY THAT THE AFFILIATE CONSENTS TO THE JURISDICTION AS
18 SET FORTH IN THIS SUBSECTION (1)(h).

19 (4) THE COMMISSIONER MAY PROMULGATE RULES TO IMPLEMENT
20 THIS SECTION.

21 **SECTION 4.** In Colorado Revised Statutes, 10-3-808, **amend** (1),
22 (3)(a), (3)(c), (3)(d), and (6); and **add** (7) as follows:

23 **10-3-808. Confidential treatment.** (1) (a) Documents, materials,
24 or other information in the possession or control of the division that are
25 obtained by or disclosed to the commissioner or any other person in the
26 course of an examination or investigation made pursuant to section
27 10-3-806 and all information reported pursuant to section 10-3-803 (2)(l)

1 and (2)(m), 10-3-804, or 10-3-805 ARE PROPRIETARY AND CONTAIN
2 TRADE SECRETS AND are confidential by law and privileged; are not
3 subject to the "Colorado Open Records Act", part 2 of article 72 of title
4 24; ~~C.R.S.~~, are not subject to subpoena; and are not subject to discovery
5 or admissible in evidence in any private civil action. However, the
6 commissioner is authorized to use the documents, materials, or other
7 information in the furtherance of any regulatory or legal action brought
8 as a part of the commissioner's official duties. The commissioner shall not
9 otherwise make the documents, materials, or other information public
10 without the prior written consent of the insurer to which they pertain
11 unless the commissioner, after giving the insurer and its affiliates who
12 would be affected notice and opportunity to be heard, determines that the
13 interest of policyholders, shareholders, or the public will be served by the
14 publication, in which event the commissioner may publish all or any part
15 OF THE DOCUMENTS, MATERIALS, OR OTHER INFORMATION in such manner
16 as the commissioner deems appropriate.

24 WITH RESPECT TO CREDIT FOR REINSURANCE.

25 (b) A RULE ADOPTED PURSUANT TO SUBSECTION (2)(a)(I) OR
26 (2)(a)(II) OF THIS SECTION MUST APPLY TO ANY TREATY CONTAINING:

27 (I) POLICIES ISSUED ON OR AFTER JANUARY 1, 2015; OR

18 MOST RECENT NAIC ACCOUNTING PRACTICES AND PROCEDURES MANUAL,
19 AS AMENDED BY THE NAIC, EXCLUDING THE IMPACT OF ANY PERMITTED
20 OR PRESCRIBED PRACTICES; AND

21 (II) IS LICENSED:

22 (A) IN AT LEAST TWENTY-SIX STATES; OR

23 (B) IN AT LEAST TEN STATES AND LICENSED OR ACCREDITED IN A
24 TOTAL OF AT LEAST THIRTY-FIVE STATES.

25 (e) THE AUTHORITY TO ADOPT RULES PURSUANT TO THIS
26 SUBSECTION (2) DOES NOT LIMIT THE COMMISSIONER'S GENERAL
27 AUTHORITY TO ADOPT RULES PURSUANT TO SUBSECTION (1) OF THIS

1 SECTION.

2 (f) AS USED IN THIS SUBSECTION (2), "NAIC" MEANS THE
3 NATIONAL ASSOCIATION OF INSURANCE COMMISSIONERS.

4 **SECTION 6. Act subject to petition - effective date.** This act
5 takes effect January 1, 2025; except that, if a referendum petition is filed
6 pursuant to section 1 (3) of article V of the state constitution against this
7 act or an item, section, or part of this act within the ninety-day period
8 after final adjournment of the general assembly, then the act, item,
9 section, or part will not take effect unless approved by the people at the
10 general election to be held in November 2024 and, in such case, will take
11 effect January 1, 2025, or on the date of the official declaration of the
12 vote thereon by the governor, whichever is later.
