# **Bill Summary**

Joint Budget Committee. The bill clarifies that the department of early childhood (department) may use the remaining money annually appropriated from the preschool programs cash fund (fund) to provide additional preschool services for children who are in low-income families or who meet at least one qualifying factor and to provide services for the furtherance of the universal preschool program.

HOUSE 2nd Reading Unamended March 28, 2024 The bill prohibits the general assembly from appropriating the full balance of the fund prior to the start of a state fiscal year. The unappropriated balance in the fund is the reserve. The department may submit a request for a supplemental appropriation from the reserve to the joint budget committee.

Preschool programs cash fund - created - use -5 repeal. (3) (b) The department shall use money remaining in MAY USE 6 THE REMAINING MONEY ANNUALLY APPROPRIATED FROM the preschool 7 programs cash fund after the uses described in subsection (3)(a) of this 8 section to provide additional preschool services for children who are in 9 low-income families or who meet at least one qualifying factor. 10 (4) In furtherance of the purposes set forth in subsection (3) of 11 this section and to meet an expansion of preschool populations, in 12 addition to the use described in subsection (3)(b) of this section, the 13 department may use money remaining in the REMAINING MONEY 14 ANNUALLY APPROPRIATED FROM THE PRESCHOOL PROGRAMS CASH fund 15 after meeting the uses described in subsection (3)(a) of this section to 16 ensure the availability of quality, voluntary preschool services provided 17 through a mixed delivery system by means the department deems 18 appropriate, including: 19 (5.5) THE GENERAL ASSEMBLY SHALL NOT APPROPRIATE THE FULL 20 BALANCE OF THE PRESCHOOL PROGRAMS CASH FUND PRIOR TO THE START 21 OF A STATE FISCAL YEAR. THE UNAPPROPRIATED BALANCE IN THE 22 PRESCHOOL PROGRAMS CASH FUND AT THE START OF THE FISCAL YEAR IS 23 THE RESERVE. THE DEPARTMENT MAY SUBMIT A REQUEST FOR A
