	WHEREAS, Colorado has a proud and distinguished history of
	dedicated military service by men and women whose courage, heroism,
	and sacrifice preserve the liberties and democratic way of life set forth in
	our state and federal constitutions; and
	WHEREAS, Colorado is home to a significant number of military
	installations, including Fort Carson, the United States Air Force
	Academy, Buckley Space Force Base, Peterson Space Force Base,
	Schriever Space Force Base, and Cheyenne Mountain Space Force
	Station, that contribute not only to the national security of our nation but
	to the economic health of our state; and

1 2 3 4 5	WHEREAS, Colorado benefits greatly from the presence and military service of the more than 47,000 men and women in our state who serve in the United States Army, Navy, Air Force, Space Force, Marine Corps, and Coast Guard; the branch Reserves; the Colorado National Guard; and the Civil Air Patrol; and
6 7 8 9	WHEREAS, The service members of the Colorado National Guard have served in defense of our nation and as the first military responders in support of civil authorities during domestic emergencies and are celebrating their 164th anniversary this year; and

Colorado is home not only to active duty service personnel and veterans but also to the countless family members of these service members who display the same dedication, courage, and sacrifice; and
17 18 19 20	WHEREAS, We should never forget the sacrifices made for us by the service members from Colorado declared missing in action or prisoners of war while defending the principles of liberty and justice in conflicts in Korea, Laos, and Vietnam; and
