# Be It Resolved by the Senate of the Seventy-fourth General

**SENATE JOINT RESOLUTION 24-001** 

- Be It Resolved by the Senate of the Seventy-fourth General Assembly of the State of Colorado, the House of Representatives concurring herein:
- That in the Joint Rules of the Senate and House of Representatives, Joint Rule No. 23, **amend** (a)(1) as follows:

### 6 **23. DEADLINE SCHEDULE**

7 (a) (1) **Deadline schedule.** For the purposes of organizing the legislative session, the schedule for the enactment of legislation shall be as follows:
