Summary of Legislation

The bill creates the Bilingual Licensing Unit within the Department of Early Childhood (CDEC) to provide resources in plain language and prevalent languages to help individuals comply with child care licensing compliance requirements. CDEC is also required to provide services in different languages to individuals opening or operating an early childhood program licensed by the CDEC. The CDEC must report on language barriers in obtaining child care licenses to committees of the General Assembly by March 30, 2026.

Beginning in FY 2024-25, the bill requires that the General Assembly annually appropriate \$235,000 from the General Fund for the Bilingual Licensing Unit. The bill also requires that \$45,000 be appropriated for updates to the CDEC's mobile licensing application in FY 2024-25 only.

State Expenditures

The bill increases state expenditures in the CDEC by about \$360,000 in FY 2024-25 and \$318,000 in FY 2025-26, paid by the General Fund. These costs are for additional staff and to make updates to existing IT systems to establish the new unit and foster bilingual access to child care licensing. Expenditures are shown in Table 2 and detailed below.

Staff. Beginning in FY 2024-24, the CDEC will require 3.0 FTE for the Bilingual Licensing Unit to provide education and resources for the child care licensing process in prevalent languages, and support bilingual individuals through the licensing process. This includes reviewing documents submitted by bilingual providers and performing inspections of their facilities. Staff costs are prorated for an August 1, 2024 start date.

Mobile licensing application update. In FY 2024-25 only, the CDEC requires \$45,000 to update the mobile licensing application in prevalent languages, including modifications that allow the ability to produce licensing inspections and investigation reports and provide essential information in prevalent languages. The estimated costs assume 600 hours of work at a rate of \$75 per hour.

Translation and other expenses. CDEC will have costs of around \$10,000 per year for translation, interpretation, and other language services.

Centrally appropriated costs. Pursuant to a Joint Budget Committee policy, certain costs associated with this bill are addressed through the annual budget process and centrally appropriated in the Long Bill or supplemental appropriations bills, rather than in this bill. These costs, which include employee insurance, supplemental employee retirement payments, and indirect cost assessments, are shown in Table 2.

Effective Date

This bill was signed into law by the Governor and took effect on June 6, 2024.

State Appropriations

For FY 2024-25, the bill requires and includes an appropriation of \$280,928 to the Department of Early Childhood, and 2.7 FTE.
