### Fiscal Impact of Bill as Amended to Date

The reengrossed bill contains amendments adopted on second reading in the House (04/16/24) and the Senate Health and Human Services Committee Report (05/01/24) includes amendments to the bill. Legislative Council Staff and JBC Staff agree that the amendments eliminate the required cash funds appropriation to the Department of Regulatory Agencies of \$7,699 and the associated 0.1 FTE for FY 2024-25.

#### **Current Appropriations Clause in Bill**

The bill includes an appropriations clause that appropriates \$328,946 General Fund to the Department of Public Health and Environment for FY 2024-25, based on the assumption that the Department will require an additional 0.8 FTE. This provision also appropriates a total of \$118,771 to the Department of Regulatory Agencies for FY 2024-25, including \$111,072 General Fund and

\$7,699 cash funds from the Division of Professions and Occupations Cash Fund. Of this amount, \$32,005 is further appropriated to the Department of Law and \$16,400 is further appropriated to the Office of Information Technology within the Governor's Office. This provision is based on the assumption that the Department of Regulatory Agencies will require an additional 1.1 FTE and the Department of Law will require an additional 0.1 FTE.

The clause does not reflect the updated fiscal impact of the bill as a result of the amendments adopted on second reading in the House (04/16/24) and in the Senate Health and Human Services Committee Report (05/01/24). These amendments reduce the appropriation for the Department of Regulatory Agencies by \$7,699 cash funds and 0.1 FTE, resulting in a total appropriation of \$111,072 General Fund and 1.0 FTE for the Department of Regulatory Agencies for FY 2024-25. The appropriations to the Department of Public Health and Environment, Department of Law, and Governor's Office remain unchanged.

#### **Description of Amendments in This Packet**

**J.003** Staff has prepared amendment **J.003** (attached) that reduces the appropriation for the Department of Regulatory Agencies to \$111,072 General Fund for FY 2024-25. This provision also states that the appropriation is based on the assumption that the Department will require an additional 1.0 FTE.

#### **Points to Consider**

#### General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).

This bill requires a total General Fund appropriation of \$440,018 for FY 2024-25, reducing the \$63.1

million set aside by the same amount.

## TABOR/ Excess State Revenues Impact

The amendments adopted on second reading in the House (04/16/24) and in the Senate Health and Human Services Committee Report (05/01/24) remove the required cash fund appropriation for this bill. As a result, the bill no longer affects state cash fund revenue and does not have a TABOR impact.
