Current Appropriations Clause in Bill

The bill includes an appropriation clause that provides the following appropriations for FY 2024-25: \$800,005 General Fund and \$202,992 cash funds from the Statewide Longitudinal Data System Cash Fund to the Department of Education, based on an assumption that the Department will require an additional 1.2 FTE; and \$4,432,419 cash funds from the Statewide Longitudinal Data System Cash Fund to the Governor's Office of Information Technology, based on an assumption that the Office

will require an additional 6.9 FTE. The appropriation clause fails to specify the authorized use for the cash funds appropriation to the Department of Education.

Description of Amendments in This Packet

J.003 Staff has prepared amendment **J.003** (attached) to make a technical correction to the cash funds appropriation to the Department of Education to specify that this amount is for information technology services.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).

This bill requires, for FY 2024-25, a General Fund appropriation of \$805,000 and a General Fund transfer of \$5,000,000. The \$5.8 million General Fund total reduces the \$63.1 million set aside by the same amount.
