The House State, Civic, Military, and Veterans Affairs Committee Report (03/25/24) and the House Appropriations Committee Report (04/12/24), both of which were adopted on second reading in the House (04/15/24), include amendments to the bill. However, Legislative Council Staff and JBC Staff agree that the amendments do not change the fiscal impact of the bill.

#### **Current Appropriations Clause in Bill**

The bill includes an appropriation clause that appropriates a total of \$29,741 General Fund to the Legislative Department for FY 2024-25. This provision also states that the appropriation is based on the assumption that the Department will require an additional 0.3 FTE.

# **Points to Consider**

#### General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).

This bill requires a General Fund appropriation of \$29,741 for FY 2024-25, reducing the \$63.1 million set aside by the same amount.
