Current Appropriations Clause in Bill

The bill neither requires nor contains an appropriation clause for FY 2024-25.

Description of Amendments in This Packet

L.007 Bill Sponsor amendment L.007 (attached) makes modifications to the bill, including: Keeps the ozone season transit grant program in the Colorado Energy Office rather than moving it to CDOT; creates the youth fair free transit grant program in the CEO rather than creating it in CDOT; specifies that an eligible transit agency, through a transit association, and RTD may apply for either the ozone season transit grant program or the youth fair free transit grant program, but not both; renames the ozone season transit grant program fund the zero fare transit fund, and specifies that the CEO may use money in the fund for the purposes of the

ozone season transit grant program and the youth fair free transit grant program; extends the ozone season transit grant program, scheduled to repeal on July 1, 2024, indefinitely; directs the state treasurer to transfer, on July 1, 2024, \$10 million from the multimodal transportation options fund to the zero fare transit fund.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$93.5 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$14.0 million).

This bill requires an ongoing annual General Fund transfer of \$14.0 million, reducing the \$93.5 million set aside in FY 2024-25 by the same amount.
