Current Appropriations Clause in Bill

The bill includes an appropriation clause that provides \$325,000 General Fund for FY 2024-25, including \$250,000 to the Department of Higher Education and \$75,000 to the Department of Health Care Policy and Financing. This provision also states that the appropriation is based on the assumption that the Department of Health Care Policy and Financing will receive an additional \$75,000 in federal funds.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).

This bill requires a General Fund appropriation of \$325,000 for FY 2024-25, reducing the \$63.1 million set aside by the same amount.
