### **SB24-047**

### **Description of Amendments in This Packet**

**J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating a total of \$2,812,863 General Fund for FY 2024-25, including \$2,282,863 to the Department of Public Health and Environment, \$455,000 to the Department of Higher Education, and \$75,000 to the Department of Health Care Policy and Financing. This provision also states that the appropriation is based on the assumption that the Department of Health Care Policy and Financing will receive an additional \$75,000 in federal funds and the Department of Public Health and Environment will require an additional 2.2 FTE.

### L.009 and J.002

Bill Sponsor amendment **L.009** (attached) strikes the Finance Committee Report (02/27/24), removes the substance use disorder prevention gap grant program from the bill, and removes the perinatal data linkage project from the bill. Staff has prepared amendment **J.002** (attached) to add a provision appropriating a total of \$325,000 General Fund for FY 2024-25, including \$250,000 to the Department of Higher Education and \$75,000 to the Department of Health Care Policy and Financing. This provision also states that the appropriation is based on the assumption that the Department of Health Care Policy and Financing will receive an additional \$75,000 in federal funds.

### If the Committee adopts <u>L.009</u>, then it should adopt <u>J.002</u> and should NOT adopt <u>J.001</u>.

### **Points to Consider**

### General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$93.5 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$14.0 million).

### **SB24-047**

## **JBC Staff Analysis**

This bill, as amended by the Health and Human Services (02/08/24) and Finance (02/27/24) Committee Reports, requires a General Fund appropriation of \$2,812,863 for FY 2024-25, reducing the \$93.5 million set aside by the same amount.

If **L.009** is adopted, this bill will require a General Fund appropriation of \$325,000 for FY 2024-25, reducing the \$93.5 million set aside by the same amount.
