Current Appropriations Clause in Bill

The bill requires but does not contain an appropriation clause.

Description of Amendments in This Packet

J.001 Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$597,200 General Fund to the Judicial Department for FY 2024-25.

L.006, L.007, and J.002

Bill Sponsor amendment **L.006** (attached) removes the requirement that the Judicial Department publish district court opinions in eviction cases appealed from county court. Bill Sponsor amendment **L.007** (attached) requires eviction cases to be filed by plaintiffs on the Judicial Department standard form of eviction. The result of these two amendments reduces the fiscal impact outlined in the Fiscal Note and requires one senior software engineer, requiring an appropriation of \$136,122 General Fund and 0.9 FTE for FY 2024-25 and \$169,232 General Fund and 1.0 FTE in future years. Amendment **J.002** (attached) appropriates \$136,122 General Fund to the Judicial Department for FY 2024-25 and is based on the assumption that the Department will require an additional 0.9 FTE.

If the Committee adopts L.006 and L.007, then J.002 should be adopted and not J.001.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package. The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).

This bill requires a General Fund appropriation of \$597,200 for FY 2024-25, reducing the \$63.1 million set aside by the same amount. <u>If amendments **L.006**</u>, **L.007**, and **J.002** are adopted, the bill requires a General Fund appropriation of \$136,122 for FY 2024-25, reducing the \$63.1 million set aside by the same amount.
