Description of Amendments in This Packet

J.001 Staff has prepared amendment **J.001** (attached) to add a provision appropriating a total of \$84,425 General Fund to the Department of Public Health and Environment for FY 2024-25. This provision also states that the appropriation is based on the assumption that the Department will require an additional 0.6 FTE.

JBC Staff Analysis

L.002 Bill Sponsor amendment **L.002** (attached) changes the language in the bill around required screening in a school or schools of a district from "kindergarten OR third grade" to "kindergarten AND third grade". Legislative Council Staff and JBC staff agree the amendment has no fiscal impact on the bill.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$93.5 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$14.0 million).

This bill requires a General Fund appropriation of \$84,425 for FY 2024-25, reducing the \$93.5 million set aside by the same amount.
