## **Current Appropriations Clause in Bill**

The bill includes an appropriation clause that provides \$34,128 General Fund to the Department of Health Care Policy and Financing for FY 2024-25. This provision also states that the appropriation is based on the assumption that the Department will require an additional 0.3 FTE.

### **Points to Consider**

#### General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).

This bill requires a General Fund appropriation of \$34,128 for FY 2024-25, reducing the \$63.1 million set aside by the same amount.

# Future Fiscal Impact

The projected cost to implement the bill increases from \$34,128 General Fund in FY 2024-25 to \$2.2 million total funds, including \$1.1 million General Fund, in FY 2025-26 and \$3.9 million total funds, including \$1.2 million General Fund, in FY 2026-27 and on-going.
