Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Effective July 1, 2025, the bill defines "premium cigar" and reduces the statutory rate of excise taxation of this particular tobacco product from the current rates for all non-cigarette tobacco products other than moist snuff of 36% of the manufacturer's list price (MLP) from July 1, 2024, through June 30, 2027, and 42% of the MLP on and after July 1,

2027, to 20% of the MLP, effectively rolling back the increases in the statutory taxation rate for such tobacco products since 2005. The bill does not affect taxation of premium cigars under the state constitution, which imposes an additional 20% tax.

1 Be it enacted by the General Assembly of the State of Colorado: 2 SECTION 1. In Colorado Revised Statutes, 39-28.5-101, add 3 (9.5) as follows: 4 **39-28.5-101.** Definitions. As used in this article 28.5, unless the 5 context otherwise requires: 6 (9.5) "PREMIUM CIGAR" MEANS A CIGAR THAT IS ROLLED BY HAND, 7 HAS A WRAPPER MADE OF WHOLE TOBACCO LEAVES, AND DOES NOT HAVE 8 A FILTER OR A MOUTHPIECE. 9 SECTION 2. In Colorado Revised Statutes, 39-28.5-102, amend 10 (1) introductory portion; and **add** (6) as follows: 11 **39-28.5-102.** Tax levied. (1) Except as set forth in subsection (3) 12 SUBSECTIONS (3) AND (6) of this section, there is levied a tax upon the 13 sale, use, consumption, handling, or distribution of all tobacco products 14 in this state, excluding modified risk tobacco products, at the rate of: 15 (6) THE TAX IMPOSED UPON THE SALE, USE, CONSUMPTION, 16 HANDLING, OR DISTRIBUTION OF PREMIUM CIGARS PURSUANT TO 17 SUBSECTION (1) OF THIS SECTION IS TWENTY PERCENT OF THE 18 MANUFACTURER'S LIST PRICE OF THE PREMIUM CIGARS. 19 **SECTION 3. Effective date - applicability.** This act takes effect 20 July 1, 2025, and applies to the sale, use, consumption, handling, or 21 distribution of premium cigars on or after said date. 22 SECTION 4. Safety clause. The general assembly finds, 23 determines, and declares that this act is necessary for the immediate
