The bill adds to this definition an individual who has passed a competency evaluation administered by the department of public health and environment before July 1, 2017.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 25-27-102, **amend**  
3 (10.5) as follows:

4           **25-27-102. Definitions.** As used in this article 27, unless the  
5 context otherwise requires:

6           (10.5) "Qualified medication administration personnel" means an  
7 individual who HAS PASSED A COMPETENCY EVALUATION ADMINISTERED  
8 BY THE DEPARTMENT BEFORE JULY 1, 2017, OR has passed a competency  
9 evaluation administered by an approved training entity on or after July 1,  
10 2017, and whose name appears on the department's list of individuals who  
11 have passed the requisite competency evaluation.

12           **SECTION 2. Safety clause.** The general assembly finds,  
13 determines, and declares that this act is necessary for the immediate  
14 preservation of the public peace, health, or safety or for appropriations for  
15 the support and maintenance of the departments of the state and state  
16 institutions.
