**A BILL FOR AN ACT**

101 **CONCERNING AMENDMENTS TO THE DANGEROUS DOG STATUTE.**

**Bill Summary**

In the case of a veterinary health-care worker, dog groomer, humane agency personnel, professional dog handler, or trainer acting in the performance of that person's professional duties, the bill removes the term "or serious bodily injury" to the list provisions that the statute does not apply to, leaving just "bodily injury".

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 18-9-204.5, **amend**  
3 (6) introductory portion, and (6)(b) as follows:

4 **18-9-204.5. Unlawful ownership of dangerous dog - legislative**  
5 **declaration - definitions.** (6) ~~The provisions of this section shall~~ THIS  
6 SECTION DOES not apply to the following:

7 (b) ~~To any~~ A dog that inflicts bodily ~~or serious bodily~~ injury to  
8 ~~any~~ A veterinary health-care worker, dog groomer, humane agency  
9 personnel, professional dog handler, or trainer, each acting in the  
10 performance of ~~his or her~~ THE PERSON'S respective duties, unless the  
11 DOG'S owner is subject to a court order issued pursuant to ~~paragraph (e.5)~~  
12 ~~of subsection (3)~~ SUBSECTION (3)(e.5) of this section and the owner has  
13 failed to comply with ~~the provisions of subparagraph (V) of paragraph~~  
14 ~~(e.5) of subsection (3)~~ SUBSECTION (3)(e.5)(V) of this section; or

15 **SECTION 2. Act subject to petition - effective date.** This act  
16 takes effect at 12:01 a.m. on the day following the expiration of the  
17 ninety-day period after final adjournment of the general assembly; except  
18 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
19 of the state constitution against this act or an item, section, or part of this  
20 act within such period, then the act, item, section, or part will not take  
21 effect unless approved by the people at the general election to be held in  
22 November 2026 and, in such case, will take effect on the date of the  
23 official declaration of the vote thereon by the governor.
