A BILL FOR AN ACT

101 CONCERNING THE DISTRIBUTION OF STATE MONEY TO LOCAL GOVERNMENTS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

The bill modifies the distribution of money from certain funds so that the money in those funds is distributed to local governments and:

- The first 50% of the money is distributed equally among the 64 counties and 2 federally recognized tribal governments in the state; and
- The second 50% of the money is distributed among the 64

counties and 2 federally recognized tribal governments in the state in proportion to the population of those counties and tribal governments.

The bill applies this modified distribution beginning on July 1, 2025, to the following funds:

- The marijuana tax cash fund;
- The public school capital construction assistance fund;
- The peace officer training and support fund; and
- The affordable housing financing fund.
- 1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, add 24-75-117 as 3 follows: 4 **24-75-117. Distribution of state funds.** (1) NOTWITHSTANDING 5 ANY LAW TO THE CONTRARY, BEGINNING JULY 1, 2025, MONEY FROM THE 6 FOLLOWING FUNDS SHALL BE ANNUALLY DISTRIBUTED IN ACCORDANCE 7 WITH THE DISTRIBUTION FORMULA: 8 (a) THE MARIJUANA TAX CASH FUND CREATED IN SECTION 9 39-28.8-501: 10 (b) THE PUBLIC SCHOOL CAPITAL CONSTRUCTION ASSISTANCE 11 FUND CREATED IN SECTION 22-43.7-104: 12 (c) THE PEACE OFFICER TRAINING AND SUPPORT FUND CREATED IN 13 SECTION 24-33.5-537; AND 14 (d) THE AFFORDABLE HOUSING FINANCING FUND CREATED IN 15 SECTION 29-32-103. 16 (2) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE 17 REQUIRES, "DISTRIBUTION FORMULA" MEANS A FORMULA THAT ENSURES 18 THAT THE MONEY IN A FUND IS DISTRIBUTED ONLY TO LOCAL
