101 **CONCERNING THE ADDITION OF VOICE COURT REPORTERS TO THE LIST**
102 **OF PROFESSIONALS WHO MAY ADMINISTER AN OATH OR**
103 **AFFIRMATION.**

Bill Summary

Current law does not allow a voice court reporter to administer an oath or affirmation. The bill adds voice reporters to the list of professionals who may administer an oath or affirmation.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 24-12-103 as
3 follows:

4 **24-12-103. Who may administer oaths or affirmations.** (1) All
5 courts in this state and each judge, justice, magistrate, referee, clerk, and
6 deputy clerk; ~~thereof~~; court reporters who hold the registered professional
7 reporter, CERTIFIED VERBATIM REPORTER, OR CERTIFIED VERBATIM
8 REPORTER - STENOGRAPHIC certification or higher; members and referees of
9 the division of labor standards and statistics; members of the public
10 utilities commission; and notaries public have power to administer oaths
11 or affirmations to witnesses and others concerning ~~any~~ A matter, thing,
12 process, or proceeding pending, commenced, or to be commenced before
13 them. ~~respectively~~.

14 (2) The courts, judges, magistrates, referees, clerks, and deputy
15 clerks within their respective districts or counties; court reporters who
16 hold the registered professional reporter, CERTIFIED VERBATIM REPORTER,
17 OR CERTIFIED VERBATIM REPORTER - STENOGRAPHIC certification or higher;
18 a person designated by the governing body, or ~~any~~ AN officer ~~thereof~~ OF
19 THE BODY; and notaries public within ~~any~~ A county of this state have the
20 power to administer all oaths or affirmations of office and other oaths or
21 affirmations required to be taken by ~~any~~ A person upon ~~any~~ A lawful
22 occasion and to take affidavits and depositions concerning ~~any~~ A matter
23 or thing, process, or proceeding pending, commenced, or to be
24 commenced in ~~any~~ A court or on ~~any~~ AN occasion an affidavit or a
25 deposition is authorized or by law required to be taken.

26 **SECTION 2. Safety clause.** The general assembly finds,
27 determines, and declares that this act is necessary for the immediate

1 preservation of the public peace, health, or safety or for appropriations for
2 the support and maintenance of the departments of the state and state
3 institutions.
