101 **CONCERNING THE CONTINUATION OF THE TOWING TASK FORCE, AND,**
102 **IN CONNECTION THEREWITH, IMPLEMENTING THE**
103 **RECOMMENDATIONS CONTAINED IN THE 2024 SUNSET REPORT**

Bill Summary

law, the towing task force is scheduled to repeal on September 1, 2025. The bill repeals this scheduled repeal, thereby continuing the towing task force indefinitely.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal**
3 (16)(a)(VI) as follows:

4 **2-3-1203. Sunset review of advisory committees - legislative**
5 **declaration - definition - repeal.** (16) (a) The following statutory
6 authorizations for the designated advisory committees will repeal on
7 September 1, 2025:

8 ~~(VI) The towing task force created in section 40-10.1-403;~~

9 **SECTION 2.** In Colorado Revised Statutes, 40-10.1-403, **repeal**
10 (6) as follows:

11 **40-10.1-403. Towing task force - creation - conflict of interest**
12 **- rules - report.** (6) ~~This section is repealed, effective September 1,~~
13 ~~2025. Before the repeal, the task force is scheduled for review in~~
14 ~~accordance with section 2-3-1203.~~

15 **SECTION 3. Act subject to petition - effective date.** This act
16 takes effect at 12:01 a.m. on the day following the expiration of the
17 ninety-day period after final adjournment of the general assembly; except
18 that, if a referendum petition is filed pursuant to section 1 (3) of article V
19 of the state constitution against this act or an item, section, or part of this
20 act within such period, then the act, item, section, or part will not take
21 effect unless approved by the people at the general election to be held in
22 November 2026 and, in such case, will take effect on the date of the
23 official declaration of the vote thereon by the governor.
