1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal**  
3 (16)(a)(VI); and **add (26)** as follows:

4           **2-3-1203. Sunset review of advisory committees - legislative**  
5 **declaration - definition - repeal.** (16) (a) The following statutory  
6 authorizations for the designated advisory committees will repeal on  
7 September 1, 2025:

8           (VI) ~~The towing task force created in section 40-10.1-403;~~  
9           (26) (a) THE FOLLOWING STATUTORY AUTHORIZATIONS FOR THE  
10 DESIGNATED ADVISORY COMMITTEES WILL REPEAL ON SEPTEMBER 1,  
11 2035:

12           (I) THE TOWING TASK FORCE CREATED IN SECTION 40-10.1-403;  
13           (b) THIS SUBSECTION (26) IS REPEALED, EFFECTIVE SEPTEMBER 1,  
14 2037.

15           **SECTION 2.** In Colorado Revised Statutes, 40-10.1-403, **amend**  
16 (6) as follows:

17           **40-10.1-403. Towing task force - creation - conflict of interest**  
18 **- rules - report - repeal.** (6) This section is repealed, effective  
19 September 1, 2025 2035. Before the repeal, the task force is scheduled for  
20 review in accordance with section 2-3-1203.

21           **SECTION 3. Act subject to petition - effective date.** This act  
22 takes effect at 12:01 a.m. on the day following the expiration of the  
23 ninety-day period after final adjournment of the general assembly; except  
24 that, if a referendum petition is filed pursuant to section 1 (3) of article V

1 of the state constitution against this act or an item, section, or part of this  
2 act within such period, then the act, item, section, or part will not take  
3 effect unless approved by the people at the general election to be held in  
4 November 2026 and, in such case, will take effect on the date of the  
5 official declaration of the vote thereon by the governor.
