1 *Be It Resolved by the Senate of the Seventy-fifth General Assembly*
2 *of the State of Colorado, the House of Representatives concurring herein:*

1 (3) That the President of the Senate and the Chair of the House
2 Services Committee, with the authorization of the Speaker of the House
3 of Representatives, are hereby separately authorized to retain and hire
4 replacements for employees referred to in subsection (1) of this resolution
5 for such period of time in the interim between the First Regular Session
6 of the Seventy-fifth General Assembly and the Second Regular Session
7 of the Seventy-fifth General Assembly as they deem necessary for their
8 respective houses.

9 (4) That the President of the Senate and the Chair of the House
10 Services Committee, with the authorization of the Speaker of the House
11 of Representatives, are hereby separately authorized to hire such
12 session-only employees for the next regular session as they deem
13 necessary for their respective houses and who may start their employment
14 on the date authorized.
